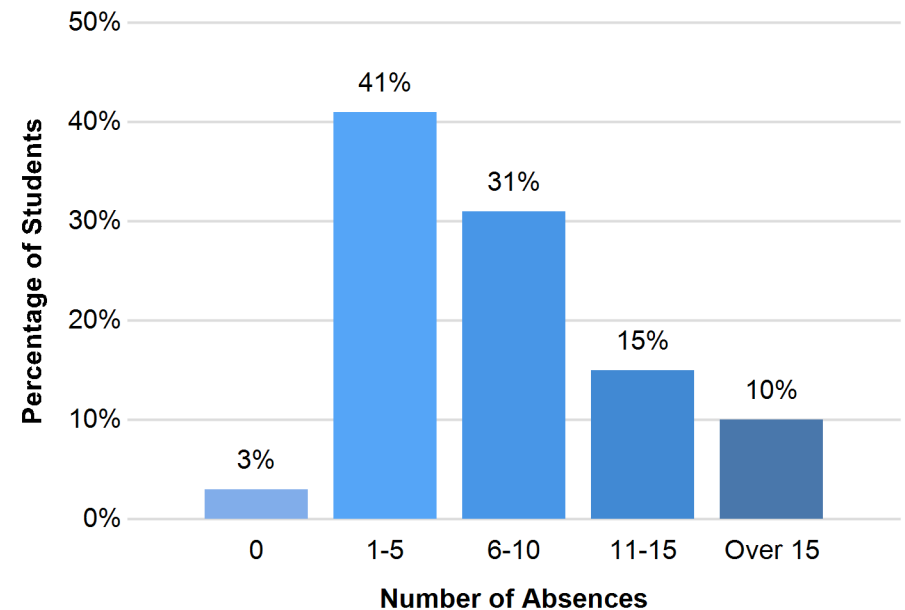

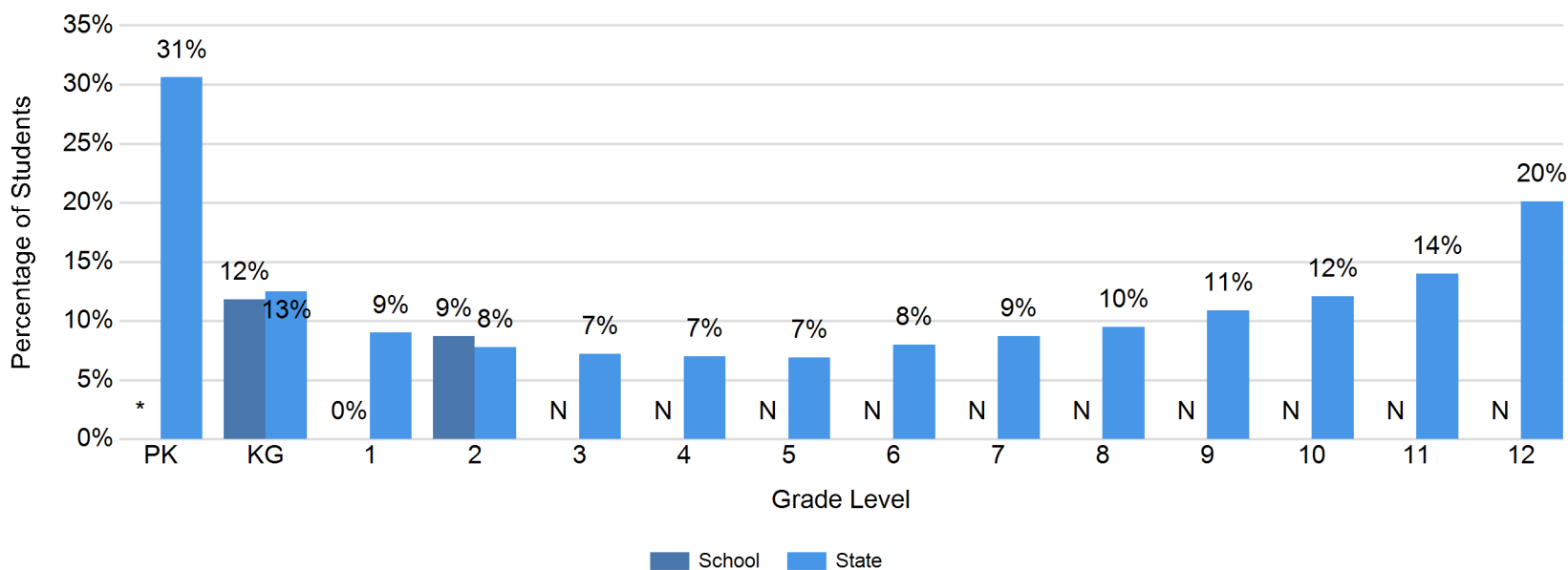

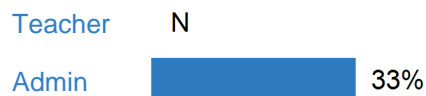
Bachelor's Degree

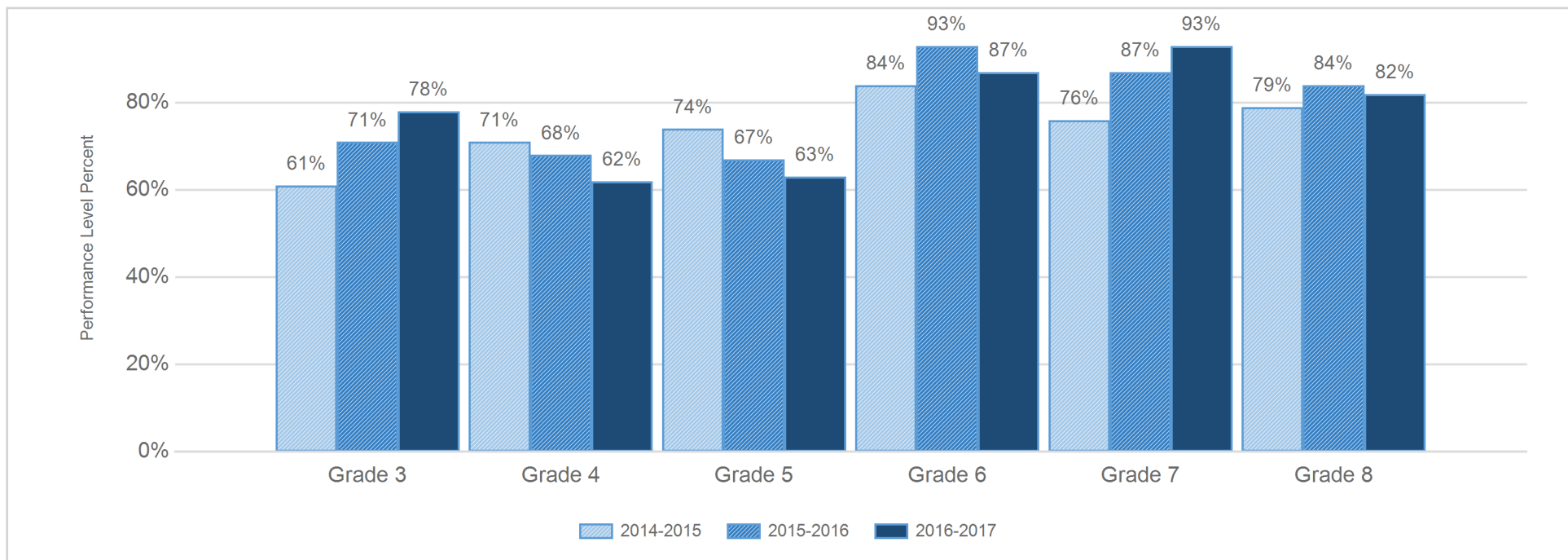

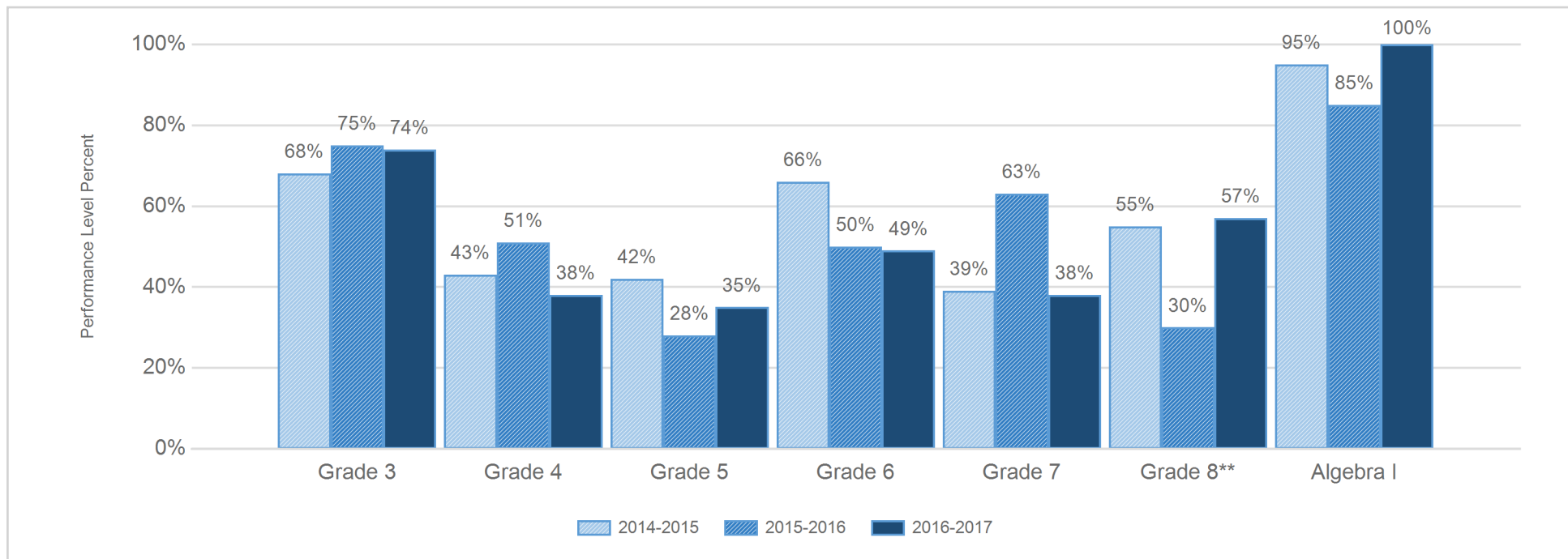

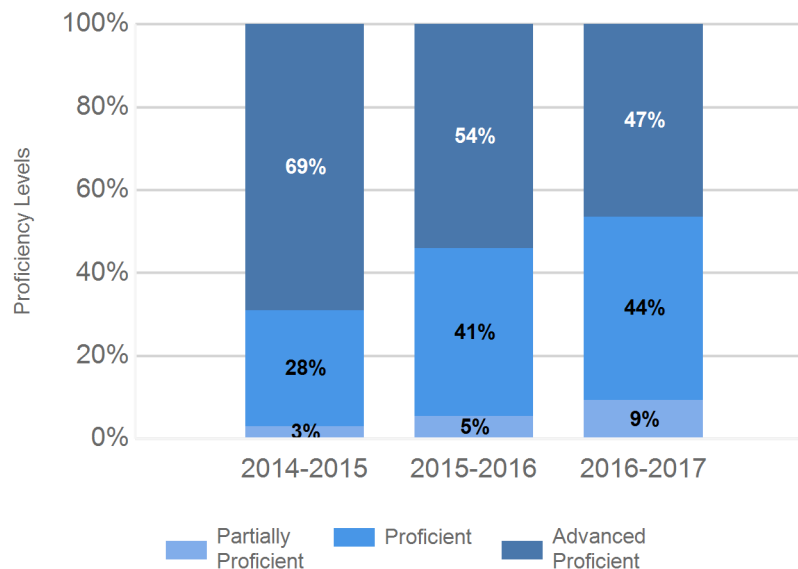

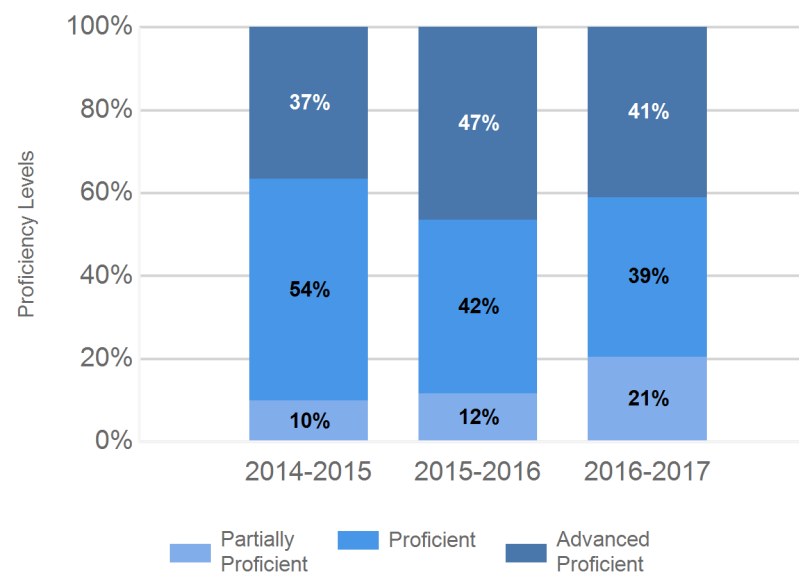

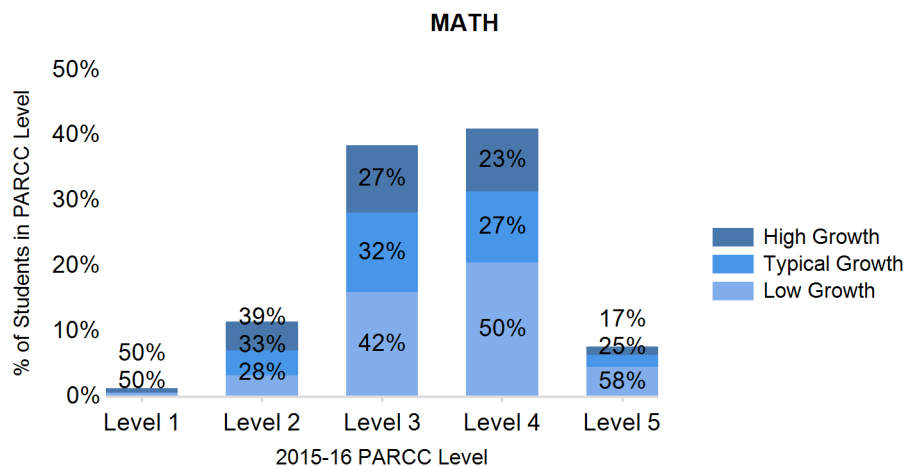

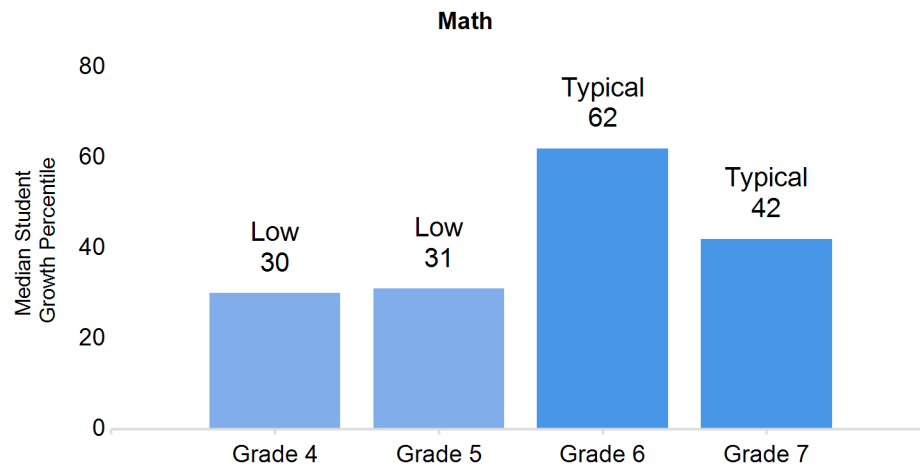
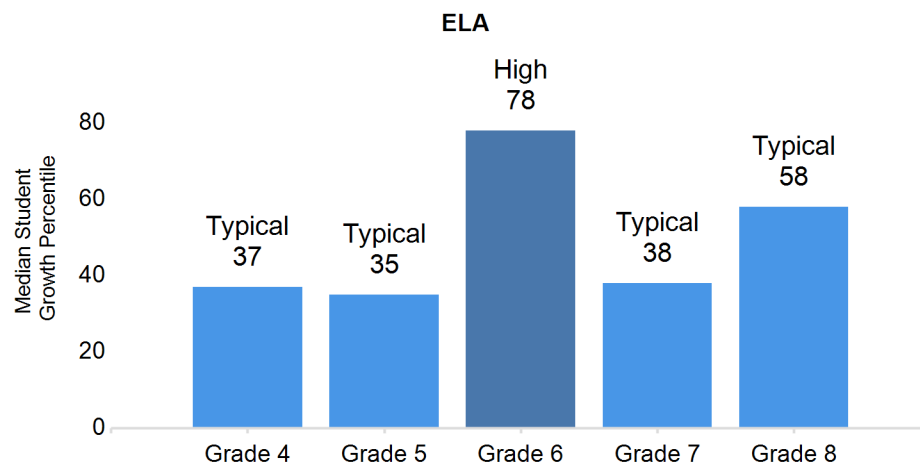

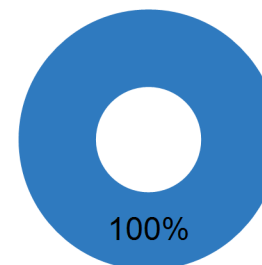

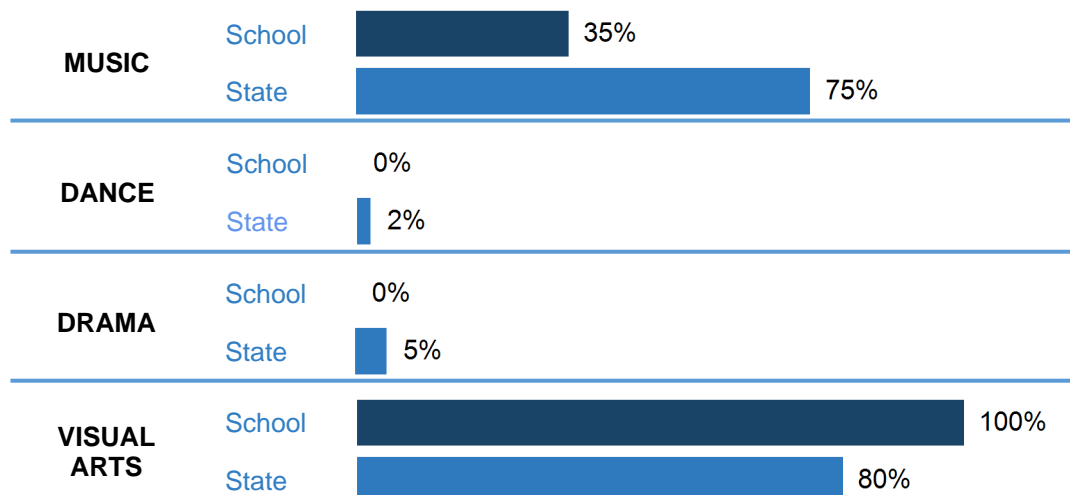

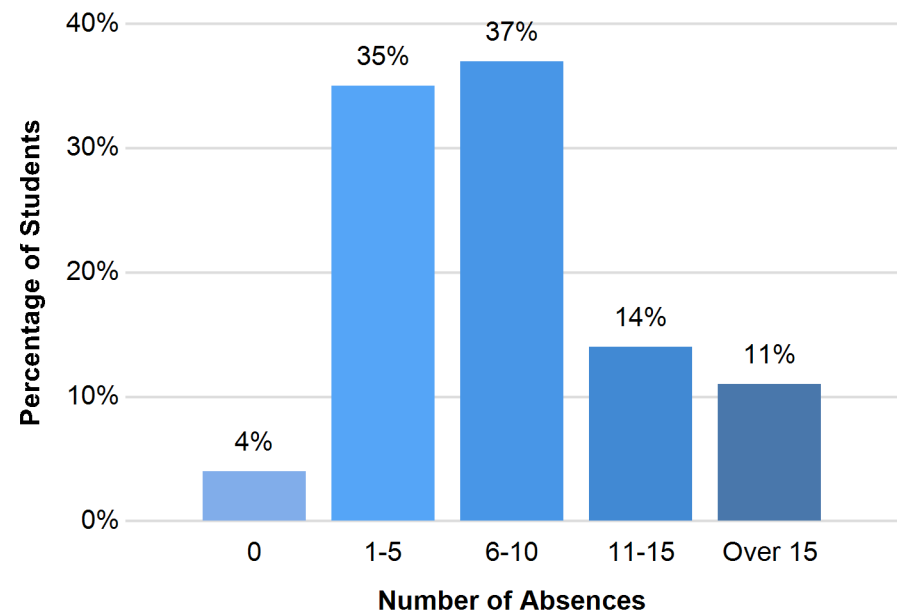

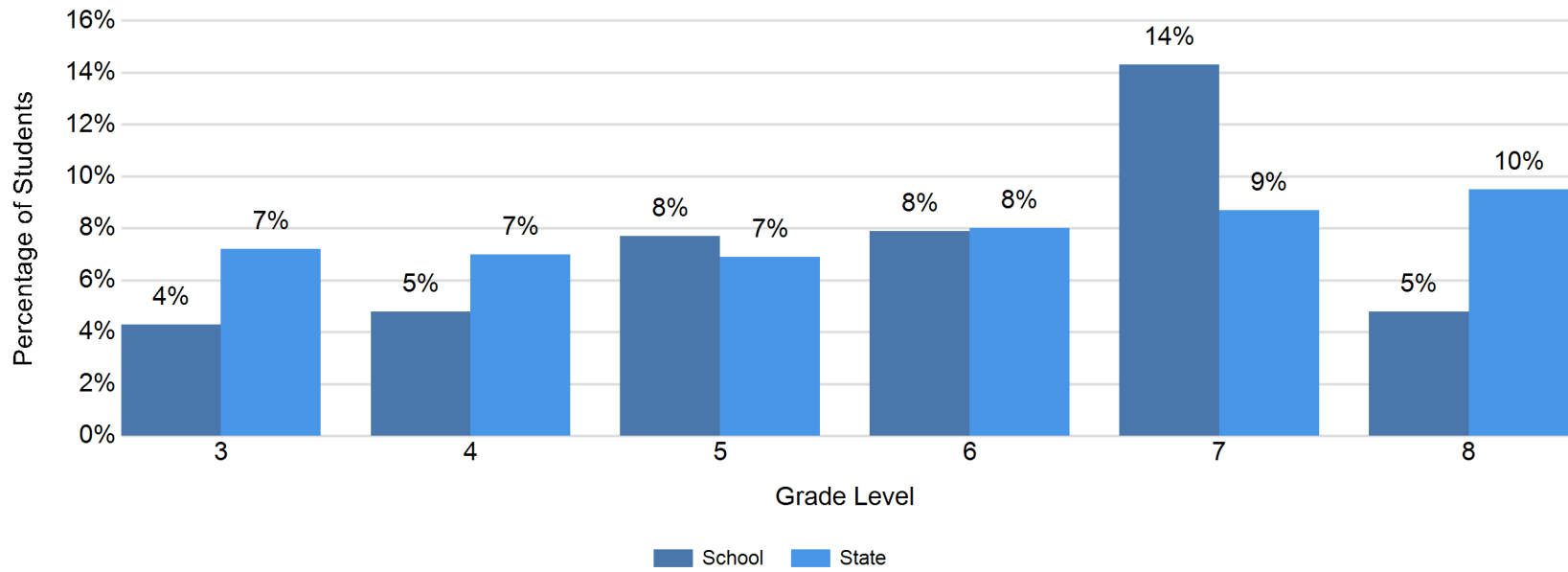

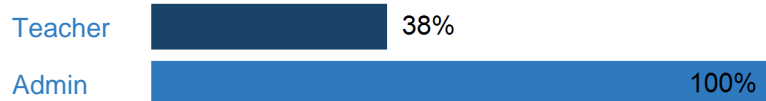
Teachers and Administrators - Level of Education
