Spreading Awareness on Deaf-Blind Services

On October 27 the DDHH Advisory Council welcomed members from the **New Jersey Commission for the Blind and Visually Impaired (CBVI)** and **The College of New Jersey (TCNJ)**. Together the group put on an informative presentation on deaf-blind services and initiatives for community integration. The four main goals of CBVI are to help students in education, provide employment services, encourage independent living and promote eye health.

Services that are available to individuals with combined hearing and vision loss include **iCanConnect New Jersey** and **Support Service Provider (SSP-NJ)**.

Carbon Monoxide Detector Discontinued

The division plans to continue the **Equipment Distribution Program** for its 26th year in January 2018. The program has grown tremendously when only TTYs were first given out. Now, eligible consumers may receive an amplified phone, smoke detector, baby alert system, artificial electrolarynx device, and captioned phone. The carbon monoxide detector that the program distributed, however, is no longer manufactured. The division is seeking an appropriate replacement device vendor with which to contract.

It provided two and a half days of informative workshops and trainings by distinguished presenters. In addition, the conference had exhibits and opportunities for networking. DDHH participated in the fair providing information and responding to consumer questions about hearing loss.
