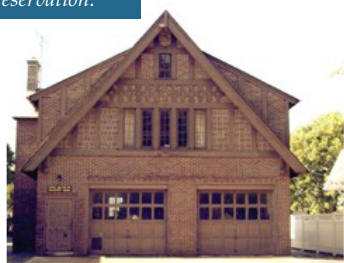

Dear Friends,

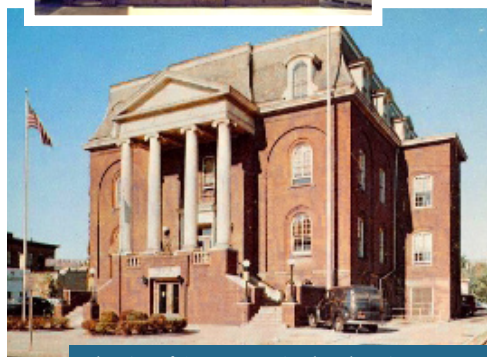
We are excited to present the 2007 New Jersey Historic Trust Annual Report, which illustrates many of the outstanding historic preservation projects that received funding during the year through the Garden State Historic Preservation Trust Fund.

A grant funded study of the First Aid Building will help the Borough of Spring Lake plan for its long-term use and preservation.



In November, New Jersey voters supported a bond referendum that will provide one additional year of funding to the Historic Trust to fund additional capital preservation projects after funding from the Garden State Historic Preservation Trust Fund expires in 2009. We thank all of the trustees who worked so hard to make this funding a reality.

This year also marked the Trust's 40th anniversary celebration of advancing historic preservation in New Jersey. Since 2000, the Trust has awarded nearly \$55 million to help preserve 324 landmark properties through the Garden State Historic Preservation Trust Fund. This program continues the significant funding of the Historic Preservation Bond Program, which provided more than \$52 million in matching grants to 182 capital preservation projects between 1987 and 1997.



The city of Orange received a planning grant to study the preservation needs of its City Hall.

The 2007 Annual Report highlights many of the projects the Historic Trust supported throughout the year. The Trust awarded \$11 million in matching grants to support 61 capital and preservation planning projects, after receiving 148 applications requesting \$34 million dollars. These figures demonstrate the growing need of our state's communities for preservation funding and the continued enthusiasm for saving New Jersey's history for future generations.

New Jersey's historic sites symbolize our state's great past, present and future. Working together, we can preserve these treasures for generations to come.

# New Jersey Historic Trust

Dear Friends,

What an exciting year it has been! Celebrating the Trust's 40th anniversary was a milestone that allowed us an opportunity to reflect on the progress that New Jersey has made to identify, preserve, restore and reuse its many valuable historic resources. Many friends and colleagues gathered at the anniversary reception, and images from the event are featured on the cover of this report.

Another highlight was the Trust's first partnership with the New Jersey League of Municipalities. The Trust assembled an educational seminar that was sponsored by the League and attracted 100 participants. The audience received an outline of services offered by the Trust, the Historic Preservation Office, and Main Street New Jersey. They learned from Collingswood Mayor Jim Maley about how historic preservation and community redevelopment can compliment each other when municipal leadership is committed to making it work. The Trust plans to work with the League to develop additional issue-specific seminars.

A record number of open grants for capital and preservation planning exercises kept the staff busy throughout the year. Fifty-five Historic Site Management applications submitted to the 2007 grant round included many projects that met one or more of the year's special initiatives: developing heritage tourism, improving site interpretation, preserving urban historic sites and addressing long-term sustainability. The Historic Trust is seeing many quality applications for innovative projects that will help maintain, use and interpret New Jersey's historic resources.

In May, the board reluctantly accepted the resignation of Executive Director Barbara Irvine. Under her leadership, the Trust efficiently administered its grant programs, successfully assembled a strategic plan and worked with public and private partners to create new forums for historic preservation. The board appreciates Ms. Irvine's dedicated and effective service.

Finally, in November the state's voters supported a bond referendum that will provide one additional year of funding. This money will enable the Historic Trust to fund additional capital preservation projects after funding from the Garden State Historic Preservation Trust Fund expires. I thank my fellow trustees who worked so hard to create public interest in this referendum, and I am gratified that their hard work was successful.

Thank you for your continued support of the Historic Trust's preservation efforts.

### **Carolann Clynes (Chair), Union County**

A professional real estate broker, former branch office manager and appraiser for 35 years, Ms. Clynes chaired the Summit Historic Preservation Commission in the 1990s when the community identified its 12 historic districts in preparation for the 1994 master plan. She spearheaded the movement to save Summit's Richardsonian-Romanesque Town Hall, which was built in 1892 and had been slated for sale or demolition.

### **Joseph J. Alessandrine, Jr., M.G.A., Cape May County**

Mr. Alessandrine is the township administrator in Dennis Township, Cape May County. A sitting Ocean City councilman since 1998, he continues to be a passionate advocate for the preservation of the Historic Ocean City 4th Street Life Saving Station. Mr. Alessandrine currently chairs the Trust's Education and Outreach Committee.

### **Thomas H. Brown, Ph.D. (Treasurer), Union County**

Dr. Brown serves as president of Union County College, where he is responsible for 37,000 students in 89 programs of study. Active in many community organizations throughout his teaching and administrative career, Dr. Brown currently serves on the boards of the Elizabeth Development Corporation and the Union County Economic Development Corporation. He also serves on the Education and Outreach Committee and is the Immediate Past Chair.

### **Daniel T. Campbell, Ph.D., J.D., Atlantic County**

Dr. Campbell is the historic preservation specialist at Somers Mansion, a state-owned historic site. Prior to entering the field of historic preservation, Dr. Campbell was a practicing attorney in his own firm for Burlington County and the State of New Jersey. He has a Ph.D. from Temple University, and currently serves on the Education and Outreach Committee and chairs the Legislation Committee.

### **Maia Farish (Vice Chair), Gloucester County**

Ms. Farish has served as an administrator and communications specialist for a variety of nonprofit organizations, including the Preservation Foundation of Palm Beach and the Nantucket Historical Association. Currently, she is leading the effort to restore historic Hollybush at Rowan University in Glassboro, New Jersey. Ms. Farish serves on the Grants and Loans Committee.

### **John D. S. Hatch, A.I.A., Mercer County**

Mr. Hatch specializes in historic preservation design and the adaptive use of historic structures. He is a partner with more than 18 years experience at the Trenton-based firm of Clarke Caton Hintz. In addition, he serves on the boards of the Trenton Landmarks Commission, Trenton Historical Society and Preservation New Jersey. Mr. Hatch chairs the Easement Committee.

### **Peter Levasseur, A.I.A. LEED AP, Camden County**

Mr. Levasseur is an architect and the director for sustainable design at Philadelphia-based EwingCole. A Leadership in Energy and Environmental Design (LEED) accredited professional, he applies green building technology and practices on existing, historic and new buildings. Mr. Levasseur worked on the first LEED certified historic building in the State of New York and spent five years working on historic preservation projects in Washington D.C. He serves on the Historic Preservation Action Committee.

### **Deborah Marquis Kelly, Burlington County**

Ms. Kelly is a former executive director of Preservation New Jersey and since 1996 has been an independent historic preservation consultant. She is the co-author of the New Jersey Women's Heritage Trail and co-chair of the Chesterfield Township Planning Board, on which she has served for 18 years. Ms. Kelly chairs the Grants and Loans Committee.

### **Allen W. Kratz, J.D. (Secretary), Hudson County**

Mr. Kratz is manager of property sales and acquisitions for New Jersey Transit, which has 48 rail stations listed on the National Register. An instructor in Drew University's Historic Preservation program, Mr. Kratz is a preservation advocate in the city of Hoboken and currently serves on the Easement Committee.

### **Chris Perks, P.E., Camden County**

A civil engineer and president of Perks Reutter Associates who resides in Camden, Mr. Perks designs and manages a variety of surveying, civil engineering and building projects in Philadelphia and New Jersey communities. Active for many years with historic preservation organizations in South Jersey, he serves on the Grants and Loans Committee.

### **Elan Zingman-Leith, Cape May County**

Mr. Zingman-Leith has more than 25 years of experience in historic preservation, working for the NY Landmarks Preservation Commission and as a private consultant. With his wife, he is the co-author of two books on Victorian-era architecture and interior design. A real estate professional in Cape May, Mr. Zingman-Leith serves on the Education and Outreach Committee.

### **Former Trustees – Mary-Anna Holden and Ed Fox**

The New Jersey Historic Trust expresses its special thanks to Mary-Anna Holden and Ed Fox, who left the Board of Trustees in 2007. Ms. Holden served on the Trust's board for 10 years, and held the positions of Board Secretary and Chair of the Legislative Committee for much of that decade. Mr. Fox served on the Grants and Loans Committee and was instrumental in helping the Historic Trust complete its year-long strategic planning initiative in 2005.

## **Barbara Irvine Receives National Honor**

While executive director of the Historic Trust, Barbara Haney Irvine was named a 2007 National Women's History Project honoree for her efforts to preserve women's historic sites throughout the country. Ms. Irvine was among 14 individuals honored at a Washington, D.C. ceremony held on March 21, 2007 in celebration of Women's History Month.

Ms. Irvine is a nationally recognized advocate for the identification and preservation of women's historic sites. Prior to joining DCA, she founded the Alice Paul Centennial Foundation (now known as the Alice Paul Institute), and spearheaded a national campaign to preserve Paulsdale, Alice Paul's birthplace and home in New Jersey. She is also the founder of the National Collaborative for Women's History Sites, an organization dedicated to preserving women's history sites and interpreting women's history at historic sites throughout the United States.

Founded in 1980, the National Women's History Project is a national clearinghouse that provides information and training in multicultural women's history for educators, community organizations and the public. Each year, March is designated as National Women's History Month to ensure that the history of American women will be recognized and celebrated in schools, workplaces and communities throughout the country

## Historic Trust Celebrates its 40th Anniversary

The New Jersey Historic Trust and Historic Sites Council celebrated their mutual 40th anniversary at a reception event in Morristown on the eve of the annual historic preservation conference in May 2007. More than 350 current and former trustees and council members, grant recipients, architectural, history and historic preservation professionals, and other well wishers gathered at Fosterfields Living Historical Farm to reminisce and discuss the new challenges that face the historic preservation movement in New Jersey.

To start off the evening's program, Morris County Freeholder Margaret Norstrom and Morris County Parks Director David Helmer welcomed attendees. Leslie Bensley, Executive Director of the Morris County Visitors Center, presented an anniversary citation to Historic Trust Chair Carolann Clynes and Council Chair Marilou Ehrler on behalf of Congressman Rodney Frelinghuysen.

Keynote speaker and former Senator William Schluter described the environment in the early 1960s at which time the state's key historical agencies were founded. Marking New Jersey's Tercentenary, the Civil War Centennial and preparing for the American Bi-Centennial were occasions that encouraged leaders to establish statewide programs for historical research, historic landmarks and historic preservation.

Michael Murphy shared stories about his step father, Governor Richard J. Hughes, who signed the landmark legislation that created the Trust and Sites Council.

When touring through Burlington County, Governor Hughes noted that

many farms were giving way to housing and commercial development and said, "I should do something about that." The story illustrates how historic preservation and open space conservation became part of his legacy.

In closing, the Trust's Executive Director Barbara Irvine read Governor Corzine's proclamation acknowledging the 40th anniversary of the two historic agencies.

## New Jersey Heritage Tourism Task Force Begins Work

The New Jersey Heritage Tourism Task Force convened its first meeting in May 2007 to kick off an 18-month investigation and planning process. The Task Force is responsible for gathering information through public meetings, surveys of cultural and heritage sites, marketing studies and conducting analyses of heritage marker and signage programs. The end result will be a Heritage Tourism Plan that will serve as a blueprint for the state's efforts to increase and improve the heritage tourism experience in New Jersey.

The Task Force, created through legislation sponsored by Senator Barbara Buono and Assemblyman Jeff Van Drew, is charged with improving New Jersey's performance in the regional and national heritage tourism market. The 17 members include Chair Cate Litvack, Executive Director of the Crossroads of the American Revolution Association, and two vice-chairs - Leslie Bensley, Executive Director of the Morris County Visitors Center and John Seitter, President of the South Jersey Tourism Corporation.

The executive director of the Historic Trust serves on the Task Force, whose work is funded by revenue from the "Discover NJ History" license plate that is available from the Motor Vehicle Commission. When the heritage tourism plan is complete, remaining money will be distributed through a grant program administered by the NJ Historic Trust to help implement the Task Force's recommendations.

## New Jersey Historic Trust Grant Recipients Receive Preservation Honors

During Historic Preservation Month in May, the Historic Preservation Office honors the best examples of historic preservation in New Jersey. Three award winning projects in 2007 were funded in part with grants from the Garden State Historic Preservation Trust Fund, which is administered by the New Jersey Historic Trust:

### *Eversole Hall House, Readington Township, Hunterdon County*

The Eversole-Hall House is a rural, vernacular 18th century structure that is interpreted as a home and shop with a small family farm. In 1988, Readington Township purchased the property, which now serves as a museum and living history site for school groups, and hosts horticultural and archaeology programs.

A Trust grant of \$42,660 helped to fund the preparation of a 2003 conditions assessment and subsequent construction work that included roof repair and replacement, porch stabilization, window rehabilitation, clapboard and shingle repair and painting. A paint analysis of the property uncovered blue house paint dating to the early 19th century, which was considered unusual for the time and style of the home.

### *Roebling Mansion, Trenton City, Mercer County*

The Ferdinand Roebling Mansion is the last remaining residence in the city associated with the Roebling family, producers of wire rope that helped make Trenton a major industrial center. Built c.1856, possibly in a Greek or Italianate style, the structure was remodeled c. 1870, and a distinctive octagonal, paneled room was added. Located in the State House Historic District, the mansion was vacant for 30 years until the city sold the building to the League of Municipalities for its new headquarters in 2005.

A Trust grant of \$750,000 helped fund the restoration of the building's stucco and brick exterior, roof replacement, stabilization of the building and preservation of at least three rooms in the mansion by salvaging and restoring mantels, plaster, paneling, stained glass, doors, hardware and ironwork. The octagonal library was reconstructed. The preservation project was part of a \$5 million effort that included the construction of a three-story addition and parking facility.

### *The Castle at Felician College, Rutherford Borough, Bergen County*

The Castle at Felician College is the only 19th century resource on the campus of mid-20th century buildings. First constructed in 1869 and expanded in 1887, the mansion has projecting bays, towers and balconies, and the interior features exquisite mantelpieces and stained glass windows.

A \$750,000 matching grant from the Trust helped to fund planning documents and the exterior restoration including cleaning and repointing of masonry, chimney restoration, skylight replacement, repair and installation of clay tile roofing, window repair, decorative metal restoration and repairs to all exterior doors.

The building is now the focal point of the Felician College Rutherford Campus and will be open for campus use after completion of the next phase of construction to rehabilitate the interior for use as a student center.

## Garden State Historic Preservation Trust Fund Completed Projects

The following six projects closed last year, while more than 80 other preservation planning and construction projects were underway.

### Historic Site Management Grants

*Historic Site Management Grants support planning exercises that promote effective management at historic sites. Such work may include the preparation of construction documents, building conditions assessments, preservation plans, historic structure reports, engineering assessments, heritage tourism plans, accessibility studies, feasibility studies, fundraising plans and more.*

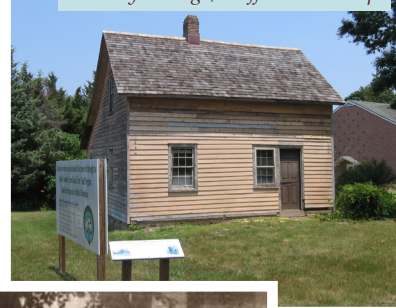
**Stafford Township, Ocean County** - received \$14,715 to fund the preparation of a preservation plan for the Cavalry Cottage in Manahawkin.

**Mercer County** - received \$50,000 to fund the preparation of a historic structure report for the Phillips House at Howell Living History Farm in Titusville.

**Stockton Borough, Hunterdon County** - received \$22,462 to fund the preparation of a preservation plan for the District 98 Schoolhouse, which is still an active school.

**Colonial Dames of America in New Jersey, Westampton, Burlington County** - received \$49,155 to fund a vision plan for the use, interpretation and preservation of Peachfield, a Colonial Revival era historic house and 18th century one-room school.

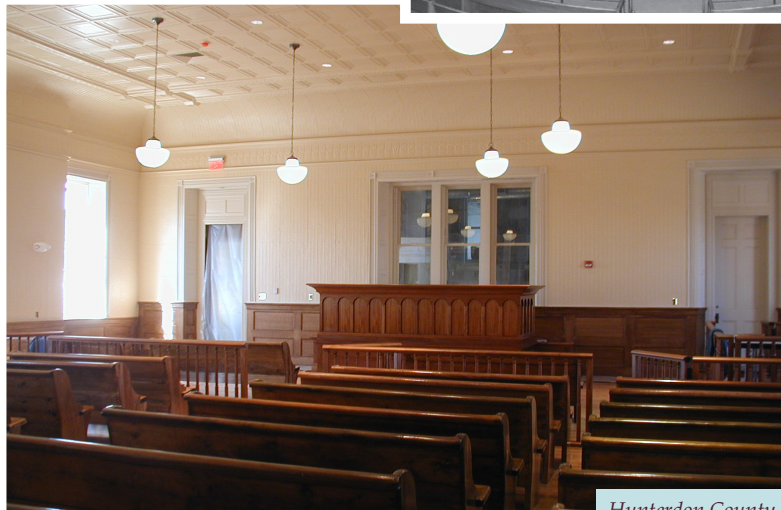
## Capital Preservation Grants

*Capital Preservation Grants help support the 'bricks and mortar' repair, preservation, restoration and adaptive use construction work necessary to maintain historic properties.*

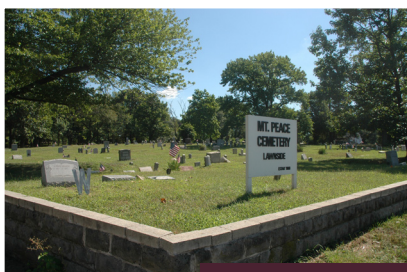

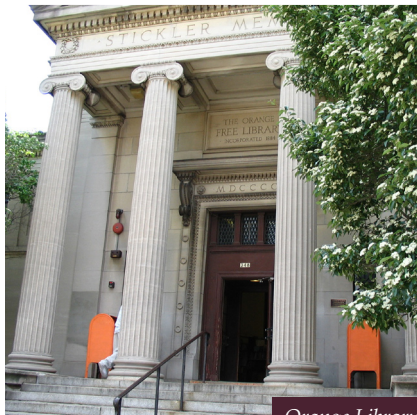

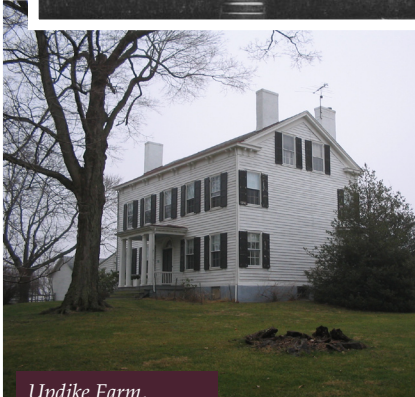

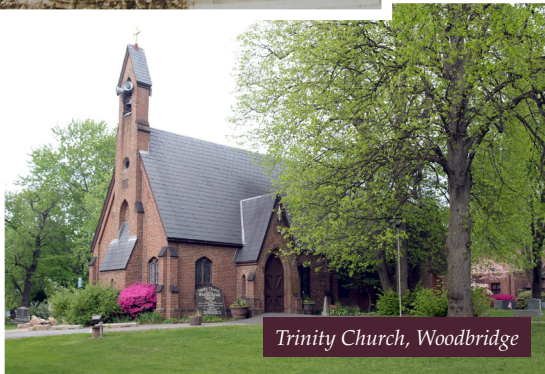

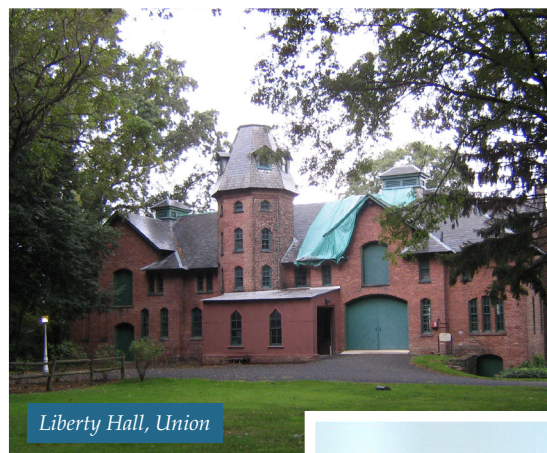

### Revolving Loan Fund Recipient

#### Liberty Hall

In January 2007, the New Jersey Legislature approved the Trust's recommendation to loan \$56,835 to the Liberty Hall Museum in Union County. The money will help pay for repairs to the roof of the Carriage House. The structure was built in the late 19th century and expanded in the early 20th century to provide a car shed.

The carriage house is a contributing feature to the Liberty Hall Museum in Union. Built on the eve of the Revolution, Liberty Hall was home to the prominent Livingston and Kean families from whom came many important New Jersey leaders, including William Livingston, the state's first governor. The house was occupied until the 1960s and restored by Mary Alice Kean in 1974, but has since deteriorated. The historic house is a public museum and the grounds and gardens are also open to the public. The first floor of the carriage house exhibits a collection of carriages and is also used for public educational programs.

### Emergency Grant and Loan Fund Recipient

#### Polhemus House

In September 2007, the Historic Trust's board approved an Emergency Grant in the amount of \$10,000 for stabilization work at the Polhemus House, owned by the Newark Museum Association. The money will help fund construction of a temporary waterproof structure around the skylight, temporary roofing on additions, flashing over parapet walls, chimney caps, and temporary window coverings. The entire project cost is estimated at \$87,000.

The Polhemus House is a four-story brick and brownstone townhouse, built c. 1860 for Eliza Brodhead Heyer Polhemus, widow of the first minister of the North Reformed Dutch Church of Newark. It is the only mid-19th century row house remaining in the James Street Commons Historic District. In 1906 the interior was redecorated by the Associated Artists, the decorative arts firm founded by Candace Wheeler and Louis Tiffany. While the building was owned by the city, the structure suffered deferred maintenance and was vacated in 2004. Now owned by the Museum, the stabilization effort is designed to prevent further deterioration of interior finishes caused by water infiltration until the Museum can thoroughly assess the building's condition and design a plan to preserve and utilize the structure.

# *New Jersey Historic Trust*

The Mission of the Trust is to advance historic preservation in New Jersey for the benefit of future generations through education, stewardship and financial investment programs that save our heritage and strengthen our communities.

The Historic Trust seeks to achieve its mission by serving as:

- A leading voice for preservation at the state level.
- A catalyst for preservation and community revitalization activities.
- A full partner in state policy development.
- A technical and financial resource for the stewardship of historic properties.

The Historic Trust currently administers six active programs:

The Garden State Historic Preservation Trust Fund guarantees funding through 2008, allowing the Trust to meet New Jersey's capital preservation needs. Since 2000, nearly \$55 million has been awarded to help preserve 324 landmark properties. This program continues the significant funding of the Historic Preservation Bond Program (1987-1997), which provided more than \$52 million in matching grants to 182 capital preservation projects.

The Cultural Trust Capital Preservation Grant Program awards funds to nonprofit history or humanity organizations for the stabilization, preservation and accessibility improvement projects at historic properties. This program is administered in cooperation with the New Jersey Cultural Trust. Since 2004, the Historic Trust has recommended funding for 31 projects totaling \$560,000 in funding.

The Historic Preservation Revolving Loan Fund provides long-term, low-interest loans for the acquisition, rehabilitation or restoration of historic properties.

The Emergency Grant and Loan Fund provides limited seed funds for critically needed work on endangered historic properties.

The Preservation Easement Program ensures the protection of privately owned historic properties in perpetuity through the use of deed restrictions. Property owners may be eligible for charitable deduction tax benefits through this program.

The New Jersey Legacies Program encourages the donation of historic real estate to the Trust, and donors may realize significant income and estate tax benefits. Donated real estate is protected by historic preservation easements before resale.

## Proclamation

WHEREAS, 2007 marks the 40th anniversary of the creation of the New Jersey Historic Sites Council and the New Jersey Historic Trust, as signed into law by Governor Richard J. Hughes on June 21, 1967, established to promote excellent stewardship for historic resources in the public trust; and

WHEREAS, the Historic Sites Council is a body of 11 citizens appointed by the Governor to advise the Commissioner of the Department of Environmental Protection on the development of a local and statewide broad historic sites preservation program, as well as to offer advice and recommendations on proposed "encroachments" to publicly-held historic resources; and

WHEREAS, the Historic Trust, affiliated with the Department of Community Affairs and governed by a body of 12 citizens appointed by the Governor, advances historic preservation in New Jersey through education, stewardship and financial investment programs and which has, since 1990, awarded more than \$107 million in matching grants in support of more than 500 preservation planning and capital preservation projects; and

WHEREAS, the Historic Sites Council and Historic Trust have set a high standard for professional historic preservation practice and public stewardship of historic resources throughout the state, protecting and preserving structures, districts, landscapes, and archaeological sites; and

WHEREAS, over the course of 40 years, the Council and the Trust have helped encourage historic preservation as a tool for managing growth, revitalizing neighborhoods, fostering local pride and promoting tourism and economic development while maintaining community character and enhancing livability; and

WHEREAS, the Morris County Visitors Center and Friends of Fosterfields are hosting a reception at Fosterfields Living History Farm on May 22, 2007, in celebration of the 40th anniversary of these two entities and acknowledgement of current and former volunteer members; and

WHEREAS, this celebration is an appropriate time to recognize New Jersey's tremendous historic resources and to honor those dedicated individuals who work to save the tangible history of all our communities for the benefit of future generations;

NOW, THEREFORE, I, JON S. CORZINE, Governor of the State of New Jersey, do hereby proclaim

MAY 22, 2007

as Celebrate the New Jersey Historic Sites Council and New Jersey Historic Trust Day

in New Jersey in recognition of the 40th anniversary of the establishment of these important bodies, and ask all our residents to join in acknowledging this special observance.
