The library is in about the same condition that it has been for three or four years past, with no chance for improvement. In waiting year after year for the proposed completion of the room, the shelves had become very much crowded, so that I have been compelled to have more temporary shelves erected for the law library, and have moved all of the books, placing them so as to leave room for additions, which we are constantly receiving by exchange. The added shelves are now about filled by the law library, while the miscellaneous library is still very much crowded, with no means of relief, until the gallery is extended. We have no shelf room for the congressional documents and State legislative journals and documents, which we are constantly receiving. The office is also more than full, and I would suggest that a room in some other part of the building be allowed to the library, for duplicates and papers on file, which are accumulating very fast. It is very necessary that the room should be finished, so that the books can be permanently placed, in their proper order, and a catalogue made.
