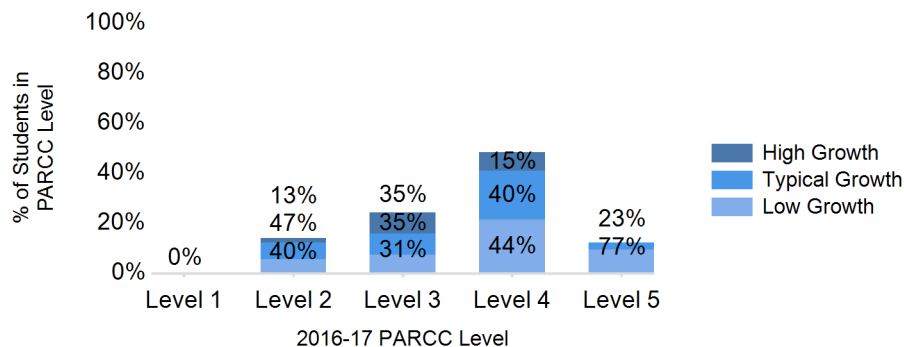

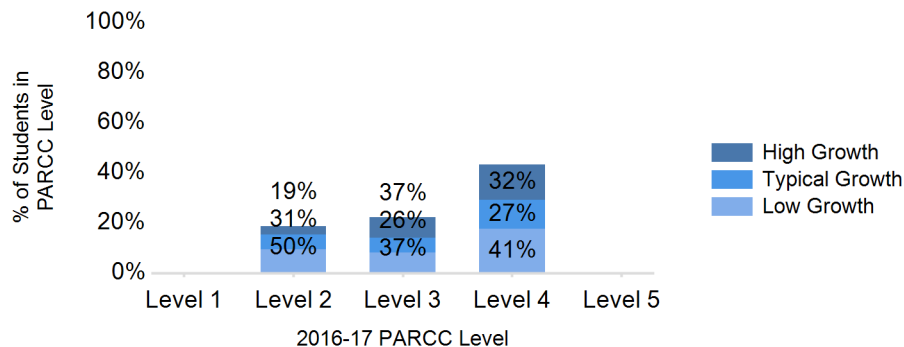
Student Growth by Performance Level

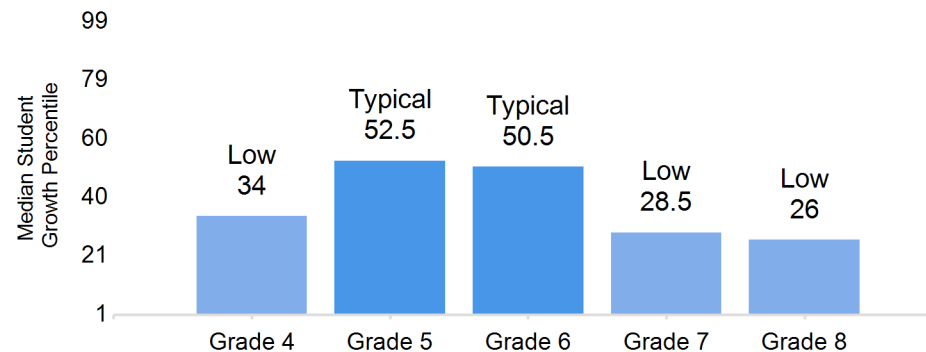

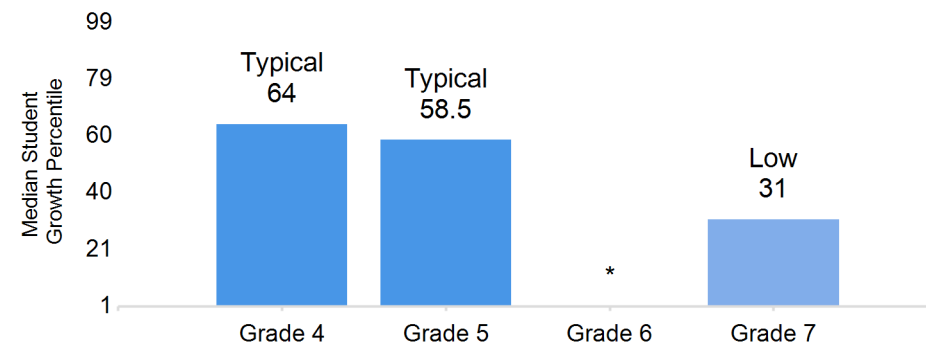
Student Growth by Grade

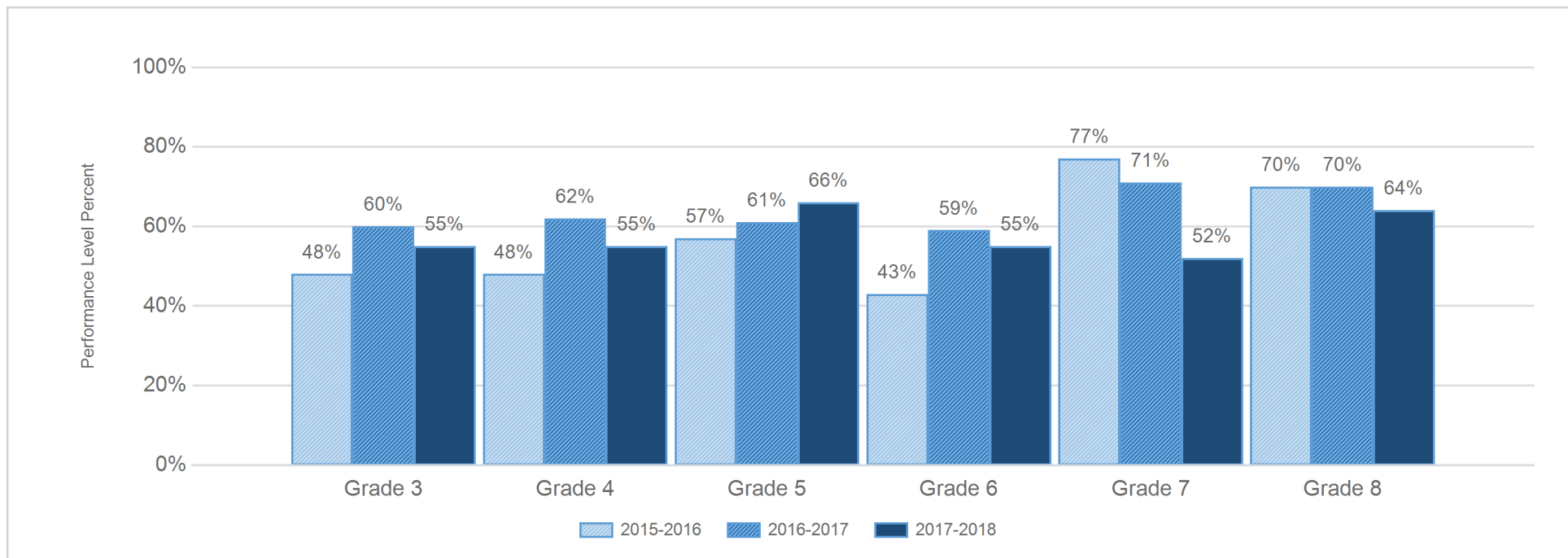

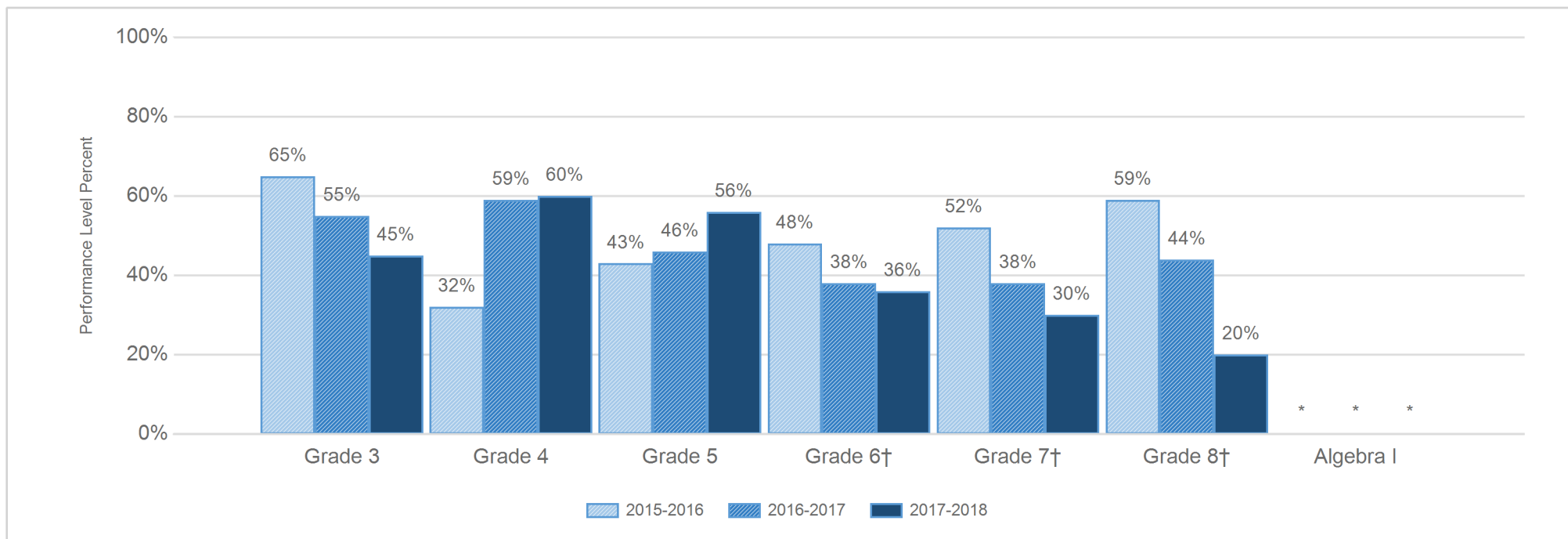

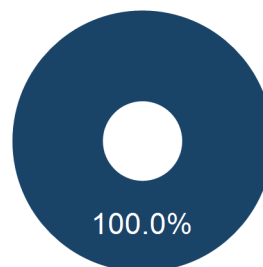

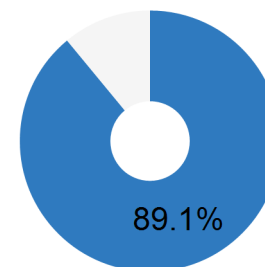

Students enrolled in one or more **visual and performing arts** classes

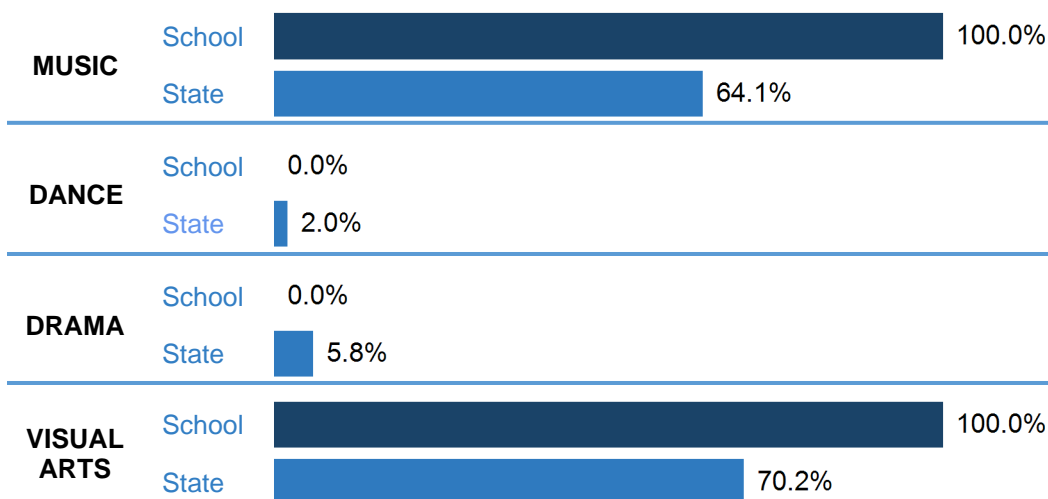

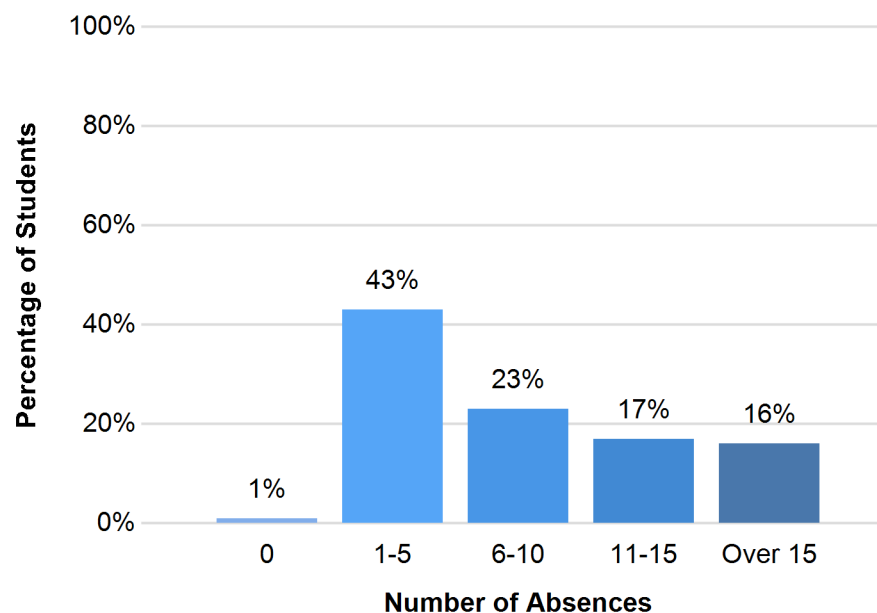

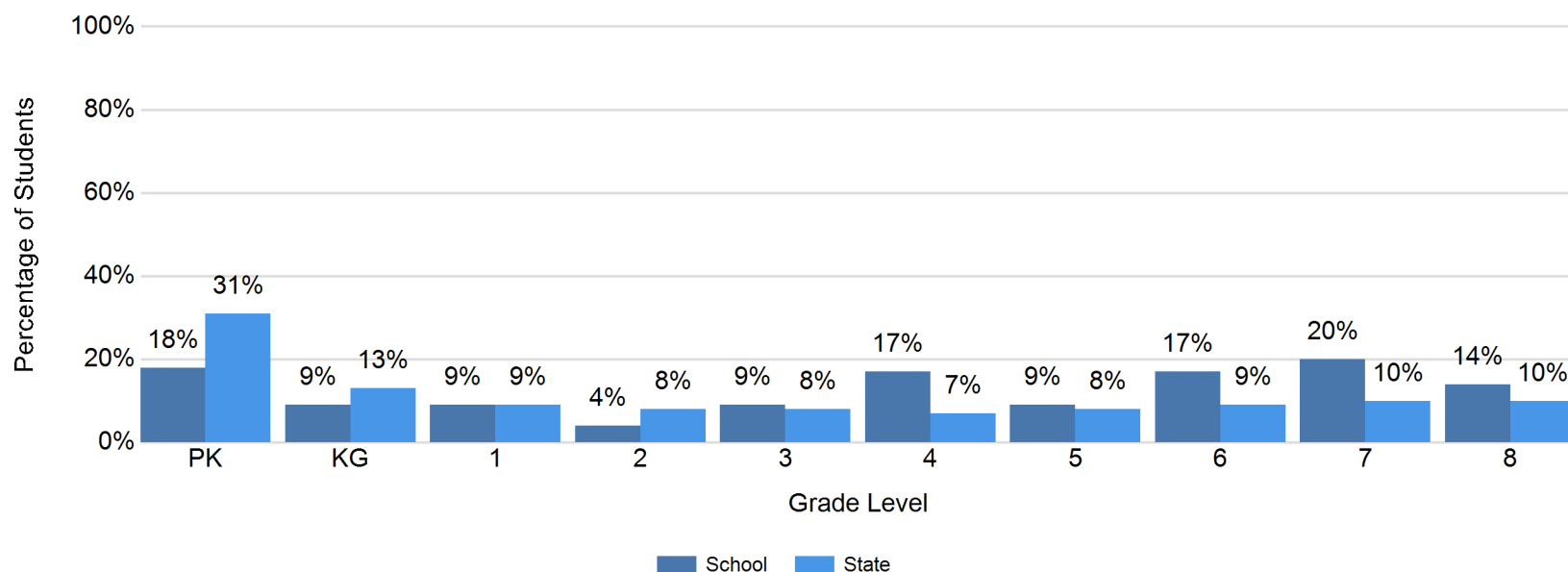
