Our school day begins at 9:00am for students. There are 8 instructional periods per day in addition to lunch and recess. Each instructional period is 40 minutes with the exception of math which is an extended to 50 minutes. Classes are dismissed at $3: 10 \mathrm{pm}$. As stated above, our students have access to technology throughout the school day to enhance their learning experience. We work in concert with the Oakland Police Department and other experts in the field to train our staff to implement common safety procedures to keep our students safe across the district.

Heights,, constructed in 1959 is the oldest elementary school in our District and houses approximately 350 students in Preschool through Grade 5. Our classrooms are equipped with SMART Boards in addition to sets of either lap tops, Chrome Books or iPads. Technology is infused into the curriculum throughout the content areas. We have a school safety team that monitors the procedures that are put in place to ensure the health, safety and welfare of all students and staff. We also promote our Conflict Resolution Program by conducting lessons for children on resolving conflict in a non-vilolent manner, peacefully. These lessons are provided by the New Jersey State Bar Association. We partner with community based organizations, e.g., Oakland Education Association, Municipal Alliance, Police Department, Mothers' and Fathers' Club, etc., to bring enrichment experiences to our students. Our school holds an annual musical production which is performed by our fifth graders supported by our fourth grade chorus. This production has community support and is extremely well received. It is our intention to provide a meaningful, well rounded education for all of the children in our care.

Our rigorous academic curriculum is complemented by special area teachers who present lessons in physical education, health, art, and music. In addition, students begin their cultural study of a world language (Spanish) in Grade 3 and continue with more language-based instruction in Grades 4 and 5. Using SMART boards, iPads, Chromebooks, mobile computer labs, and document cameras teachers utilize the available technology in the school to create challenging, problem-based applications that can be integrated into each content area. Our character education initiative is also integrated across the curriculum. During the year, students will learn to practice the Six Pillars of Character (Trustworthiness, Citizenship, Respect, Fairness, Responsibility and Caring).
