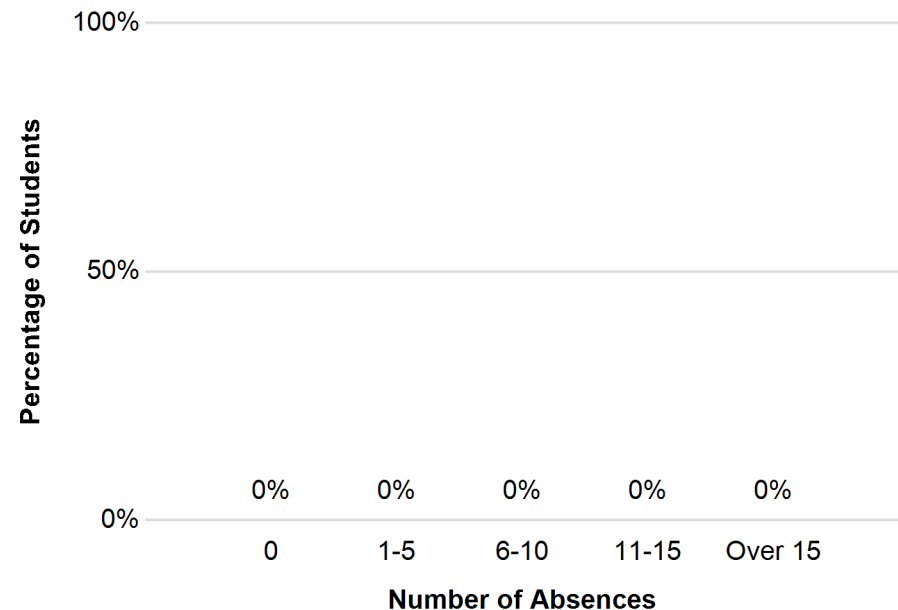

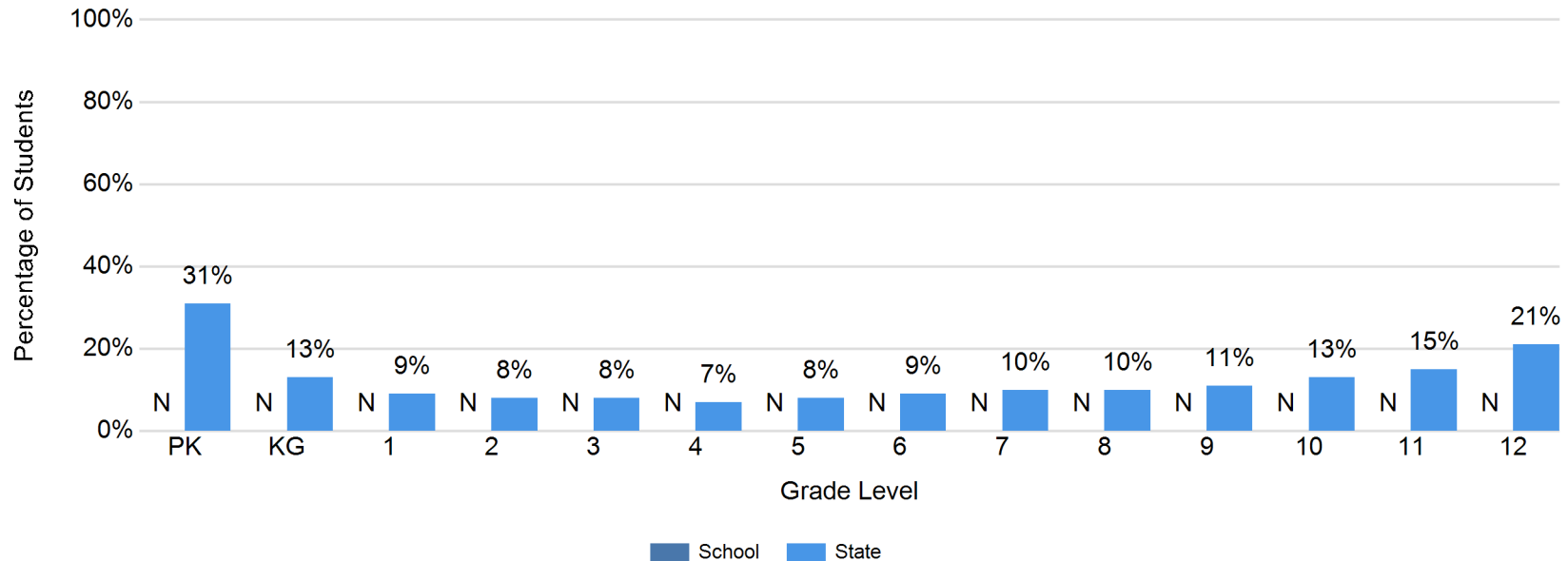

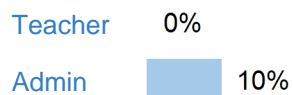
Bachelor's Degree
