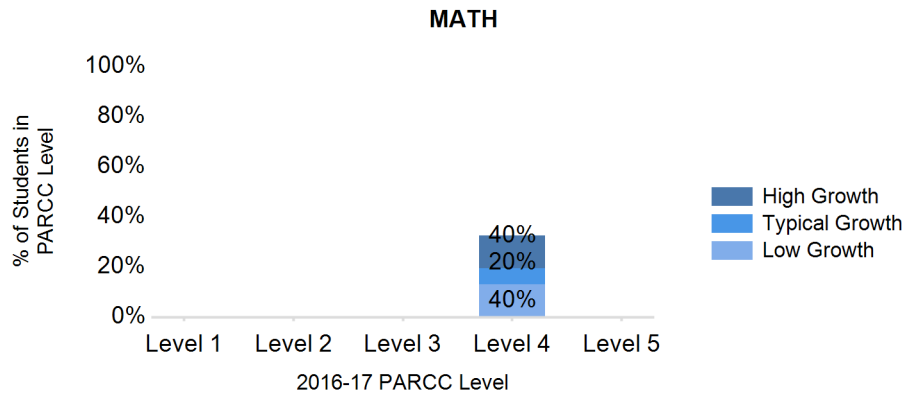
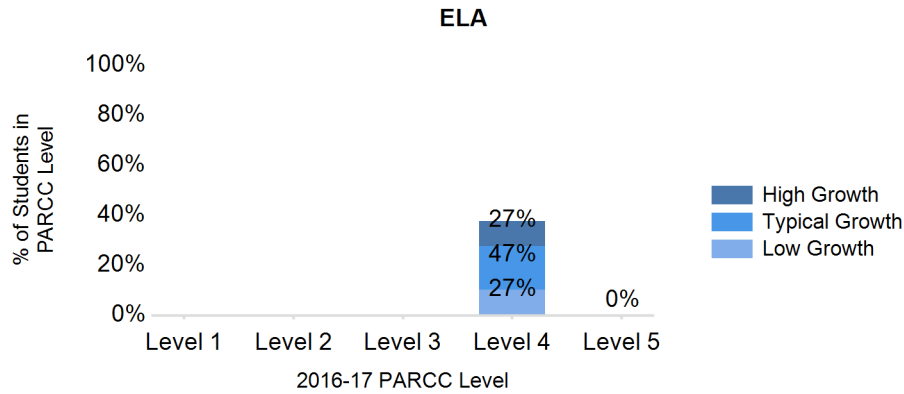

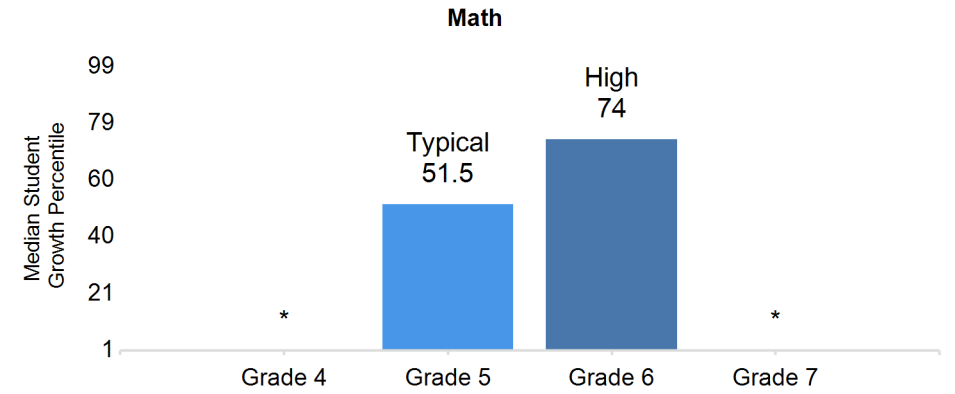
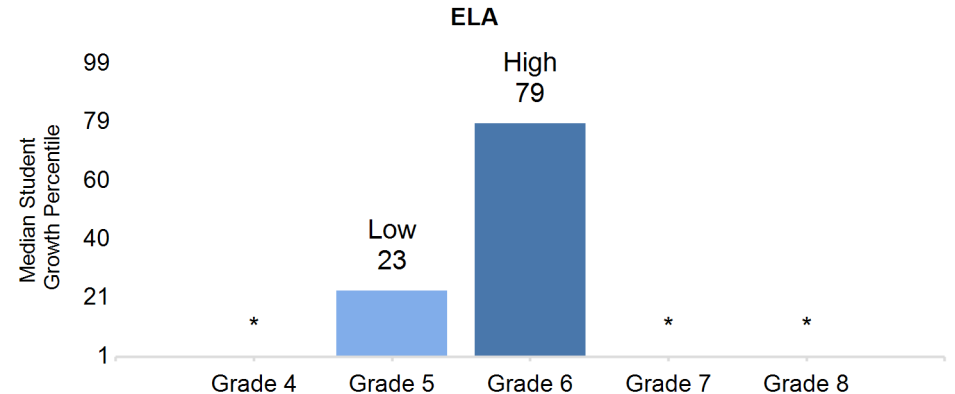
**Student Growth by Performance Level**

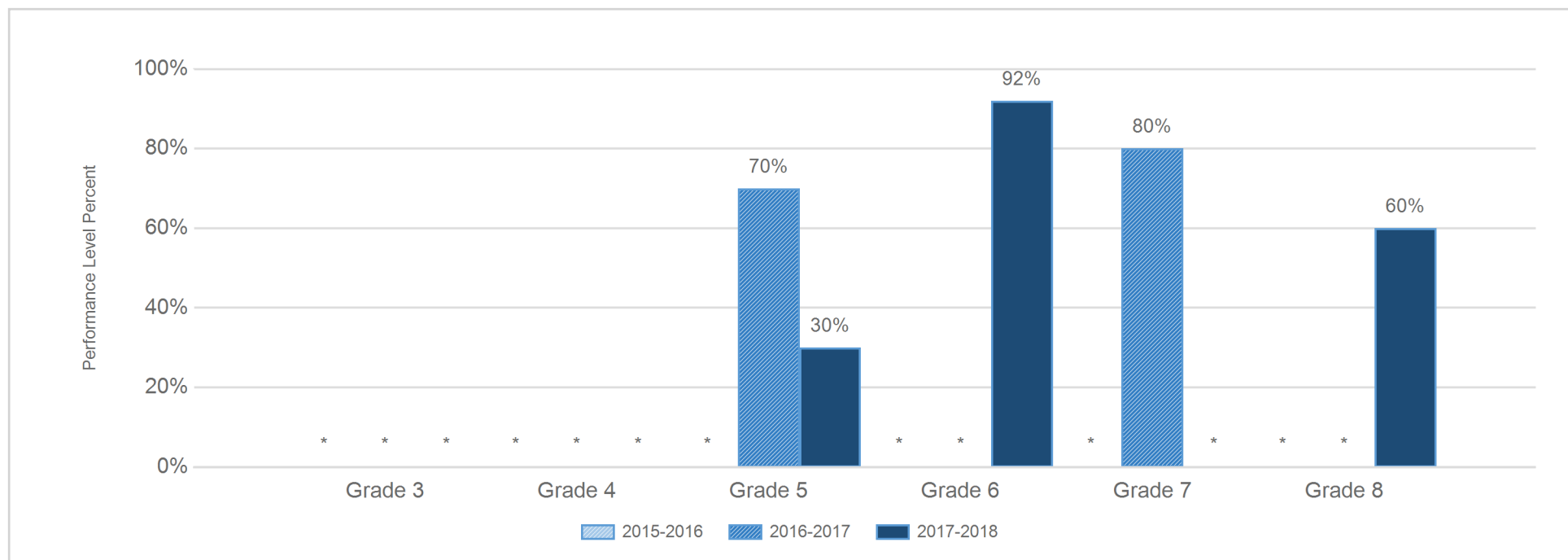

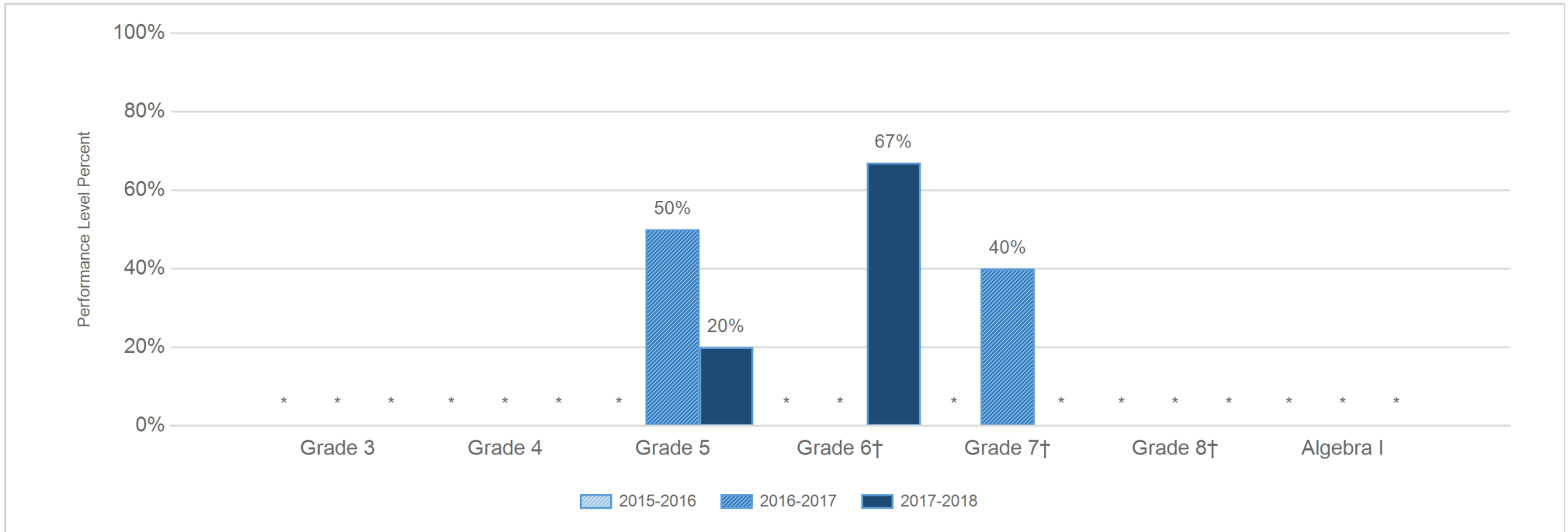

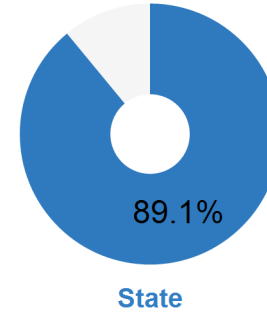

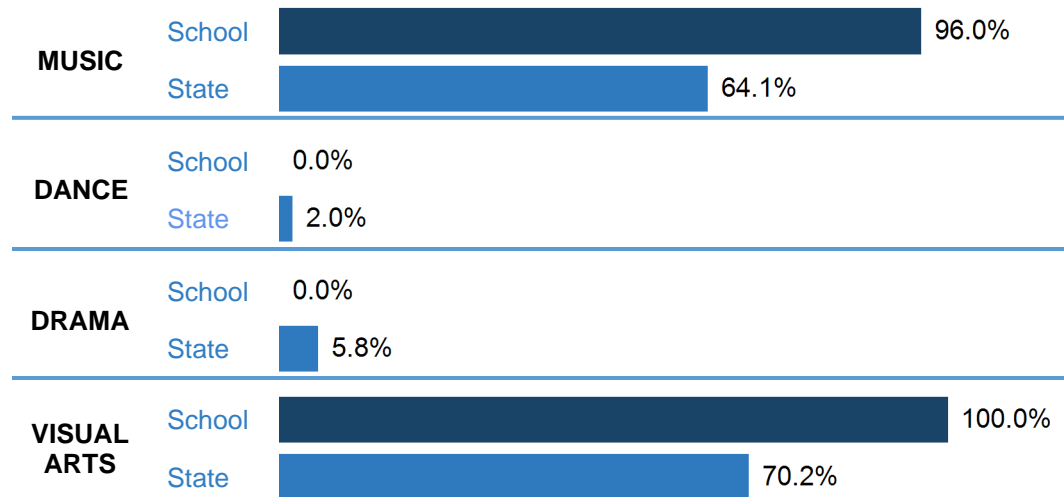

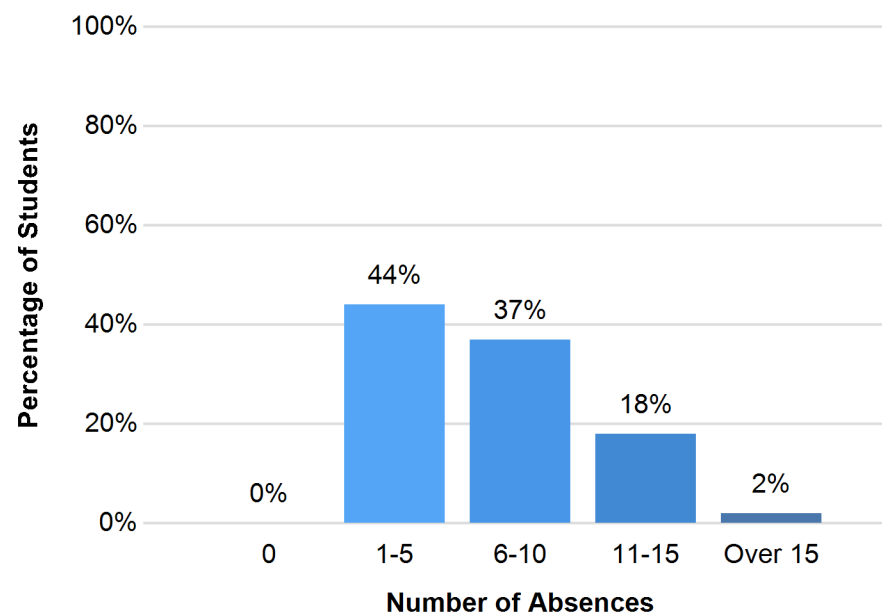

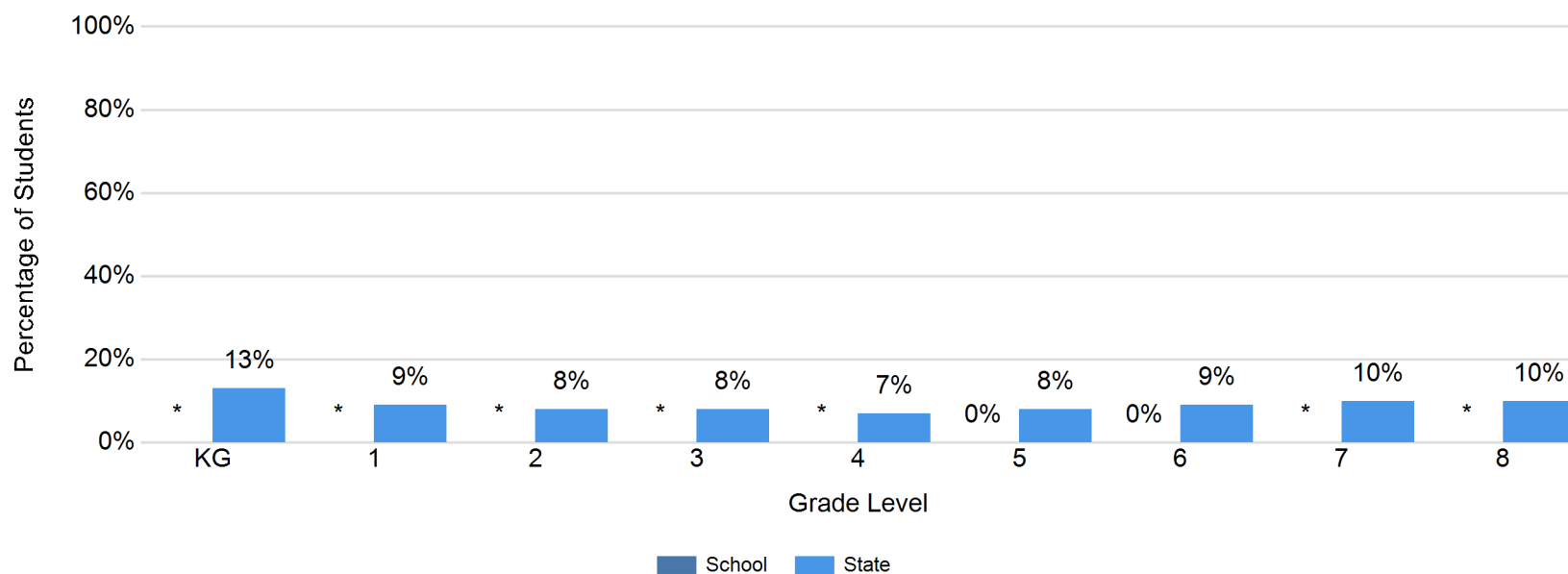

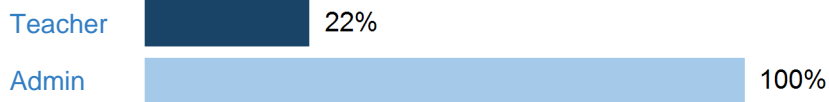

Morris Goodwin School in Greenwich Township is a small school in a rural community with a high quality of life reminiscent of a bygone period. By realizing and maximizing their limited financial resources and taking advantage of the economies of scale their combined numbers permit, the Greenwich-Stow Creek Partnership endeavors to provide the students from both communities with the best education possible.
