# Message From The Governor

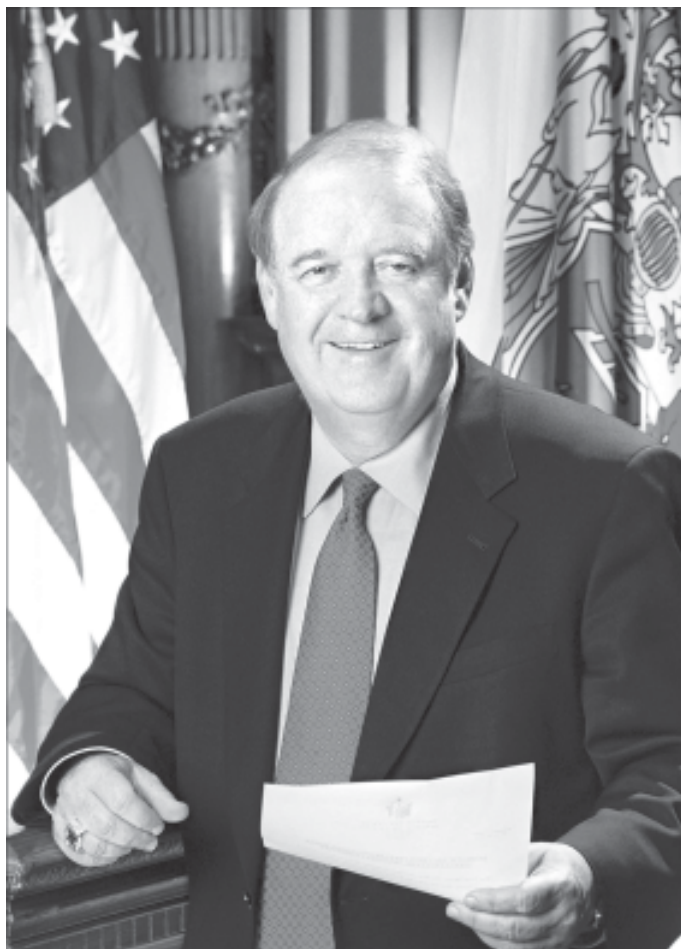
Dear Friends:

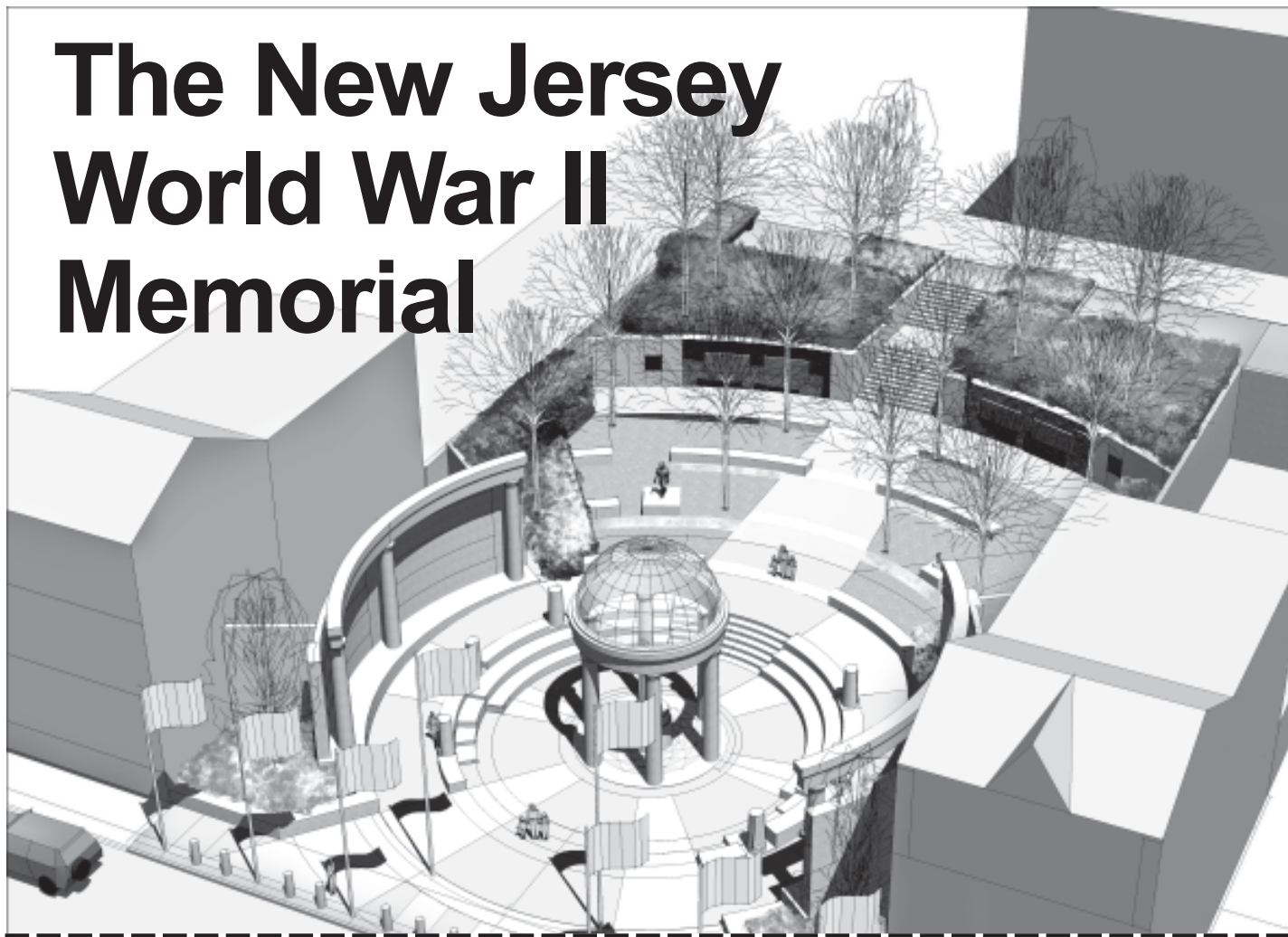

# Kiosk Highlights Veterans' Benefits

Beginning in January, the Department's veterans' kiosk will be traveling to a different mall each month around the state. The kiosk highlights the various programs and points of contact for applying for benefits.

This is in direct response to the recent Inspector General Report documenting the inequity in VA service-connected compensation to N.J. veterans versus other states' veterans populations. NJDMAVA has embarked on an ambitious outreach program that is designed to inform veterans of their benefits and entitlements.

It is estimated that approximately 12,000 N.J. Veterans are entitled to VA service-connected compensation, but have failed to make application for their benefits.

Veterans and their dependents wishing to learn more about their benefits can call 1-888-8 NJ VETS. This number can also be found on a bumper stickers. Counseling for Post Traumatic Stress Disorder can be reached at the new 24/7 Hotline number 1-866-VETS - NJ - 4U.

Finally, a new series of public service announcements detailing the services available to veterans and their dependents and contact information can be seen on television.

# Veterans Memorial Homes Admission Criteria

Recently, there have been some questions about eligibility for admission into our New Jersey Veterans Memorial Homes.

Our homes are open to veterans of all wars who served on active duty (90 days total active duty service) and were honorably discharged. Veterans must have been state residents for at least two years prior to application for admission or were citizens of New Jersey at the time of entrance into military service. National Guard and Reserve Retirees who were never deployed but have 20 good years of service are also eligible.

The veteran's spouse, including widows and widowers and Gold Star Parents, are also eligible for admission. A spouse, widow, or widower must be at least

50 years of age and must have been married to the veteran for a period of not less than 10 years. Residents' pay according to ability based on income and accrued assets.

The process for admission begins with the submission of an application, which can be obtained from any of our homes. Family members and caregivers are encouraged to visit the home of their choice for assistance in the admission process. If you are interested in a tour, please contact the facility directly.

## New Jersey Veterans Home Update

### ***Paramus Veterans Memorial Home***

Ms. Doris Neibart, Chief Executive Officer of the Paramus facility, was recently inducted as President of the National Association of State Veterans Homes (NASVH) at the National Conference held in Washington State.

As president, Ms. Neibart will be meeting with the VA, Senators, and members of the House of Representatives to discuss these important issues. The President serves for a one-year term. Ms. Neibart had recently been the NASVH Vice-President.

The Association is dedicated to the "caring of America's Heroes." NASVH's priorities for the next year are to continue to protect our veterans benefits for all those who served our country honorably, with emphasis on the proposed VA budget cuts, per diem drug reimbursement, and construction and grant programs.

### ***Menlo Park Veterans Memorial Home***

Mr. Joseph Brandspiegel, Chief Executive Officer, food service staff, and residents collected \$1,300 for the Katrina relief effort.

They presented the check to the Salvation Army of New Brunswick, New Jersey on Sept. 23. Theresa Burrows, Juanita Ceralde, Joyce Lin, and Larry Maynes led the Food Service Department in a Bake Sale that raised \$1,000 as part of this effort. Additionally, the Menlo Park facility also collected bottled water for the victims filling the home's SUVs.

### ***Vineland Veterans Memorial Home***

Construction has been completed on the new Vineland home and it is a beautiful addition to our long-term care facilities.

All residents will now be housed in a single two story ultra-modern facility. Residents are scheduled to begin moving into the new home on or about Nov. 1. The final phase of the construction will be tearing down the three older buildings that compromised the Vineland facility and finishing the parking lots and grounds.

# Vets Programs Participates In Reconstitution

Returning service members are more likely than ever to have experienced stressors with deployment and will face significant changes at home.

Soldiers returning from deployment are faced with finding a "new normal." They have to adjust to their family, workplace and community. In order to do this successfully, The New Jersey Department of Military and Veterans Affairs has initiated a Reconstitution Program for our demobilized Soldiers.

During the Reconstitution briefing the soldiers and families are made aware of the psychological challenges of transitioning from active duty to a citizen lifestyle and they are provided with an opportunity to meet with a counselor. All soldiers are educated on enrolling into the VA Health Care system after deployment, applying for VA Disability Compensation, Educational Benefits, Home Loan opportunities, the soldiers are immediately entered into the state system as veterans for civil service and pension purposes. Additionally, they are approved for the New Jersey Distinguished Service Medal and they are also given information on specific state and federal benefits. Once the soldiers return to their drill status, which is 60 days after demobilization, our Veterans Affairs Team provides a follow up at the drill site.

Family members are unsure what to expect, their soldier may seem distant and unemotional when they return and may have dif-

ficulty warming up to their family, therefore causing additional stressors for the entire family.

Among soldiers serving as part of Operation Iraqi Freedom there is an increase in divorce rates, suicide rates and vehicle fatalities. PTSD is also a large concern; a recent study from Walter Reed reported one in six returning troops suffer psychological damage.

The New Jersey Department of Military and Veterans Affairs (DMAVA) in conjunction with the University of Medicine and Dentistry of New Jersey developed a free 24 hour confidential helpline staffed by veterans, volunteers, counselors, and clinical professionals who understand what our service members are going through.

Participating in this program, veterans will receive peer support, clinical assessments and case management. Veterans are referred to a Comprehensive Mental Health Vet work of providers within their home of record. The hotline number is 1-86-VETS-NJ 4 U (1-

866-838-7654).

To date we have 71 percent of our reserve soldiers deployed, the Army and Air Force will increase the number of reservist in support of the partial mobilization which will bring the total percentage to 75 percent by the end of the year. These service members are heroes who are returning to their civilian lives and jobs as fully productive members of their communities. Every one of them is a veteran with full state and federal entitlements.

# Your New Jersey Veterans Benefits

## **Education Benefits/ POW/MIA/ War Orphans**

The Veterans Tuition Credit Program provides an educational support entitlement to full-time and part-time students who are resident veterans and served on active duty in the Armed Forces of the United States from December 31, 1960 to May 7, 1975.

POW/MIAs program is available to any dependent of a prisoner of war or missing in action that was a resident upon being accepted to pursue a course of undergraduate study in any private institution of higher education. The dependent shall be allowed to obtain a bachelor's degree free of tuition.

## **Veterans Preference for Civil Service and Pension Purposes**

Effective March 1, 2001, NJ Department of Military and Veterans Affairs is the agency to determine veterans preference for hiring in New Jersey civil service and veterans status for New Jersey civil service pension plans.

War period veterans who pass state civil service examinations are given absolute preference over non-veterans when applying for state, county and municipal employment. Absolute preference is not extended to promotions, but if a veteran ranks highest on a promotional certification, a non-veteran cannot be offered the appointment before the veteran. Veterans with service-connected disabilities (at least 10 percent) who pass civil

service examinations are given preference over other veterans and non-veterans.

To claim veteran's preference, file the claim form with a copy of your separation papers (DD Form 214.) Mail the form to the NJ Department of Military and Veterans Affairs, Veterans Benefits Bureau, PO Box 340, Trenton, NJ 08625-0340. You must obtain a veteran preference from the NJ Department of Military and Veterans Affairs BEFORE CLOSE DATE for a job or a test.

## **Veterans Property Tax Deduction/Exemption**

The New Jersey Property Tax Deduction is an annual property tax deduction of \$250 for veterans honorably discharged from active war-time period. Filing must be done prior to Dec. 31 of the pre-tax year.

Documentation will include the property deed and discharge (DD-214) for the veteran. Widows will need to re-submit the property deed, marriage certificate, death certificate and discharge (DD-214).

Eligibility criteria requires service during a specified wartime period, honorable discharge and rated 100 percent permanent service-connected by Veterans Affairs.

## **Catastrophic Entitlements**

Residents of the state who served in any capacity with the Armed Forces of the United States during a wartime period and who have a 100 percent permanent service-connected disability rating

from the United States Department of Veterans Affairs for one of seven disabilities declared to be catastrophic in nature by the New Jersey Department of Military and Veterans Affairs. A monthly entitlement of \$62.50 is available. To apply see a State VSO for a New Jersey Catastrophic Entitlement Application or contact the Division of Veterans Programs at 609-530-6854.

## **Transportation Program**

Free transportation is offered to VA medical centers and clinics, other hospitals, private physicians, VA Regional Office and local Veterans Service Offices.

# Stand Down 2005: A Hand Up

On Sept. 23, the New Jersey Department of Military and Veterans Affairs (DMAVA) and Stand Down of South Jersey, Inc., hosted Stand Down 2005 at the National Guard Armory in Cherry Hill.

This follows a Stand Down that was held a week previously at Essex County Community College in Newark on Sept. 17.

DMAVA, along with many volunteers and civic organizations held the Stand Down to provide homeless veterans with access to healthcare, mental health screening, substance abuse counseling, social services availability, religious

counseling, a hot meal, a haircut and winter clothing. Stand Down's ultimate goal is to show disenfranchised veterans that someone still cares and to assist them in bringing their homelessness to a close.

This is the fourth year that

Stand Down was held at the Cherry Hill Armory. Before 2000, Stand Downs were held at Fort Dix and Naval Weapon Station Lakehurst. Last year 137 homeless veterans and their families attended the Stand Down.

On any given night there are an estimated 341,000 homeless veterans in the U.S., up from 274,000 in 1995. About one-third of the homeless have served in the Armed Forces. The number of homeless Vietnam veterans exceeds the number of servicemembers killed during any given conflict. And finally, there are currently 7,500

homeless veterans in New Jersey.

Stand Down comes from the military term referring to exhausted combat units that were removed from the battlefield to a place of security and safety for rest and recovery. Today Stand Downs are grass roots, community-based intervention program to help homeless veterans battle life on the streets. The program has a philosophy of a hand up not a hand out. The first Stand Down was held in 1988 in San Diego. Today more than 80 are held annually to reach an estimated 100,000 homeless veterans.

The organizations that supported Stand Down 2005 were NJDMAVA, Stand Down of South Jersey, Inc., the Veterans Administration, The Retired Officers Association, Disabled American Veterans, American Legion, Marine Corps League, American Ex-Prisoners of War, Veterans of Foreign War, Gold Star Wives, Jewish War Veterans, Burlington County Veterans Services Office, Camden County Veterans Services Office, Camden County Board of Social Services, Community Services of Camden County, U.S. Department of Labor and the Fort Dix post chaplains.

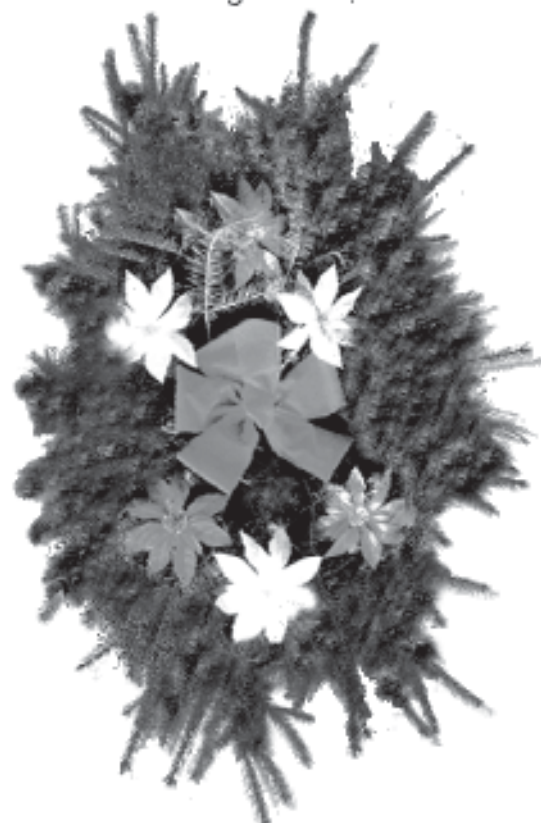
