








Student Growth by Performance Level




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. 











Students attend two related arts classes each day which allows them to explore non-academic interests such as art, music, STEM, Mass Media and Keyboarding. Because our district is a choice district, we have students attending our school from Byram Township as well as other surrounding areas. Student ownership is one of the cornerstones of our philosophy at Byram Intermediate School. This our fourth year where students engage in Student Led Conferences. Throughout the year, students reflected on their educational experiences and spent time setting goals for the year. Twice during the school year, students led their own conferences with their parents in which they shared their portfolios, reflections, and goals with their parents. Our school has also devoted itself to educating our students not only academically but socially and emotionally as well. 






Student Growth by Performance Level

These graphs show the median Student Growth Percentile for students in each grade.




















Teachers and Administrators - Level of Education

Our school day starts at 8:40 each day and ends at 3:15. We offer a half day preschool program for both regular and special education students who are at least three years of age. The school consists of approximately 450 students and 60 staff members. Students attend two related arts classes each day which allows them to explore non-academic interests such as art and music. Because our district is a choice district, we have students attending our school from Byram Township as well as other surrounding areas. Our innovative programs, talented staff, and supportive Board of Education have allowed our students to benefit from programs and resources that help prepare our young learners for the 21st century. Students in grades two through four benefit from having 1:1 Chromebooks that are used to enhance their educational experience. The safety of our students is our number one priority. Our building doors are locked at all times with cameras located at all of the main entrances. Parents and visitors are required to provide their driver's license upon entering the building which is scanned in the main office to be sure that all visitors are authorized to be in the school. Aside from safety, we believe that it is important for lines of communication to be open between home and school. We send out weekly email blasts to all district parents which contains important information about each school as well as district-wide information. We also utilize Facebook and our school's website to post important information about what is going on in our school.
