The Division of Medical Assistance and Health Services has been working in conjunction with the Department of Banking and Insurance over the last several months to identify Medicaid beneficiaries who may be entitled to the "Dollar-a-Day" Auto Insurance program.

To qualify for the "Dollar-a-Day" Auto Insurance program, an individual must be eligible for one of the following Medicaid programs or waiver programs:

Beneficiaries who may qualify for the "Dollar-a-Day" Auto Insurance program will have an asterisk (*) printed to the right of each beneficiary's service package on the Medicaid card along with a code designation of "**SAIP" (State Auto Insurance Program) printed in the lower right concern. If there are no beneficiaries identified on the Medicaid card with an asterisk, "**SAIP" will not be printed.


"Dollar-a-Day" Auto Insurance coverage is available through most insurance agencies. The beneficiary must have a valid driver's license, a vehicle registration and a systems generated Medicaid Identification card which identifies that the person is enrolled in Medicaid.
