1. REVISED APPLICATION FORMS FOR RENEWAL OF MUNICIPAL LICENSES FOR USE IN YEAR 1977-1978 AND THEREAFTER: REVISED LONG-FORM APPLICATION.

NOTICE: REVISED APPLICATIONS FOR RENEWAL OF MUNICIPAL RETAIL LICENSES FOR YEAR 1977-78 AND THEREAFTER, AND REVISED LONG FORM APPLICATION.

TO ALL MUNICIPAL ISSUING AUTHORITIES:

On December 19, 1973 you were advised that, based upon a study and analysis of the effects of the adoption of a "short-form" application, it was determined that each fourth year applicant for licenses shall file a "long-form" application. Samples of application forms showing the several statutory and regulatory changes were sent to municipal issuing authorities, and, in most instances, municipalities complied by having applicants complete the revised "long-form" application for license.

The study also indicated that the "short-form" application is beneficial to the Division, the municipal clerks and the licensees, and should be continued for three successive years, subsequent to which a "long-form" application will again be required.

Accordingly, "short-form" applications shall be filed by all applicants for RENEWAL licenses for the year 1977-1978.

The revised "short-form" application is slightly different than previous "short-form" applications; and you are advised that the only "short-form" application that may be used is the revised form, a sample of which is attached hereto.

In other words, only the new revised (1-77) "short-form" application may be used for RENEWAL for the year 1977-78, and the new revised (1-77) "long-form" application is acceptable for transfers, new licenses and renewal for 1978-79.

I urge all local Issuing Authorities to take immediate steps to obtain a sufficient supply of the enclosed revised forms, A-13, A-14, A-13R and A-14R (1-77), at the earliest possible moment so that you may have them available when the time comes for the renewal of licenses for the next fiscal year (1977-1978), and for subsequent renewal periods.

Please note that applicants must submit applications in triplicate to the municipal clerk, with the Division's fee of \$50.00 (in addition to the municipal fee), for which the clerk will acknowledge receipt on the renewal application form. The municipal clerk will then forward one copy of the application and the \$50.00 fee accompanying such application to this office. The applicant will retain one copy of the "short-form" application which should be attached to the last "long-form" application kept upon the licensed premises, available for inspection.

As set forth above, RENEWAL of licenses for fiscal year 1978-1979 must be made on the 4-page "long-form" application; and renewals or 1979-80, 1980-81 and 1981-82 shall be made on the "short-form" application.
