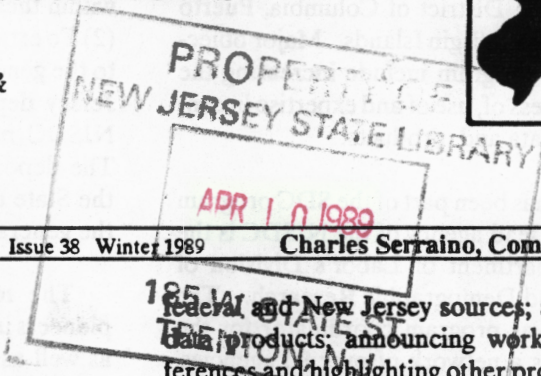

Welcome back! This newsletter marks a renewal of the former New Jersey State Data Center (NJSDC) quarterly newsletter, *Population and Census*. This issue represents not only a change in format and appearance, but it is a combined newsletter for two programs -- the NJSDC and the new Business and Industry Data Center (BIDC) (see page 3 for an article on the BIDC program). Plans are that *Garden State Data News* will be issued in the Winter, Spring, Summer and Fall of each year.

The purpose of *Garden State Data News* will continue to be to promote a forum for an information exchange including: analyzing newly released demographic and economic data from both

federal and New Jersey sources; announcing new data products; announcing workshops and conferences and highlighting other programs as well as NJSDC/BIDC network agency activities.

Since the former newsletter has not been issued since October 1985, the first article will focus on the activities and responsibilities of the NJSDC network while the second article focuses on the the new BIDC initiative. The NJSDC/BIDC electronic bulletin board is described on page 3. Next, the advantages of municipal participation in the 1990 Local Review program are presented to encourage participation. The NJSDC/BIDC can now provide data on diskettes; information on how to obtain these data is provided on page 5. Finally, activities of some of the NJSDC affiliates and upcoming NJSDC workshops and conferences are listed.

advantage of their resources? The SDC program is a cooperative effort established almost ten years ago between the U.S. Bureau of the Census and every state plus the District of Columbia, Puerto Rico, Guam, and the Virgin Islands. Major objectives of the SDC program include increasing the access to, awareness of, use of and expertise in census and related data and products.

New Jersey has been part of the SDC program since 1980. The lead agency of the NJSDC is the New Jersey Department of Labor's Division of Labor Market and Demographic Research. The lead agency acts as program coordinator for the NJSDC, supports a network of over 90 agencies, conducts workshops on using census and related data, prepares a quarterly newsletter to keep the data user community informed, produces publications and reports containing demographic/economic data and analyses, and coordinates an annual conference that discusses a timely demographic/economic issue.

In total, ninety-six county, state, library and university agencies make up the NJSDC network. The primary participants are the State Library, Princeton University Computer Center and the Rutgers University Computer Center. The primary participants receive all available census data and NJSDC publications for all areas of the State. In addition, the Princeton University and Rutgers University Computer Centers maintain an extensive collection of census computer files and will do special data processing for a fee. The academic affiliate is the Rutgers University Department of Urban Planning and Policy Development; its primary role is to assist in the use of census data in research and analysis.

County planning/economic development agencies are included in the NJSDC network. This county network provides local access to and technical assistance in the use of census and related data. These county agencies also collect and maintain other types of data on their county. The Delaware Valley Regional Planning Commission is a member of the network and plays a role similar to that of the county affiliates for the Philadelphia-Southern New Jersey region.

Unlike many other states, the NJSDC network includes contacts in each state agency. Their role is twofold: (1) To serve as a point of first contact within their own department for census data and (2) To extend the availability of their agency's data to the general data user community. The 42 New Jersey depository libraries that are part of the NJSDC network receive all NJSDC products. The depository libraries are located throughout the State thereby providing convenient access to the general public.

The members of the network have been pioneers in the use and distribution of census data as well as providing extensive services to public and private agencies. The complete network list can be found at the end of the newsletter. The most efficient way to use the NJSDC network is listed below.

- NJSDC Publications - See order form at end of newsletter; may be reviewed at any NJSDC network member agency.
- Data Processing - Princeton or Rutgers University Computer Centers.
- State, county & municipal data - All NJSDC network agencies
- Census tract, block group, enumeration district, block data - County planning/economic development agencies (each has data for own county only).*
- Census tract data - State and Newark Public Libraries
- Maps - County planning/economic development agencies (each has maps for own county only), State Library, Princeton University or Rutgers University Computer Centers.

*New Jersey State Government personnel should direct all inquires to their respective agency contact; all others should contact one of the other agencies listed.

The New Jersey Business And Industry Data Center

New Jersey has been selected as one of the 15 states that will pilot test a new program to improve the flow of economic statistics to the business community. The BIDC program is an outgrowth of the Census Bureau's State Data Center (SDC) program. States selected for the pilot program besides New Jersey are Connecticut, Florida, Indiana, Kentucky, Maryland, Massachusetts, Minnesota, Montana, New Mexico, North Carolina, Pennsylvania, Washington, West Virginia, and Wisconsin.

The program, called the Business and Industry Data Center (BIDC) Initiative, was established by the U.S. Bureau of the Census. The project is designed to assist business, governments, and universities in providing and using economic statistics, specifically geared to the needs of the business community.

The New Jersey State Data Center (NJSDC), in the New Jersey Department of Labor, is the lead agency for the Garden State program. The NJSDC has selected over 30 organizations to work with them as affiliates in its outreach efforts to the business community. The Census Bureau will provide data, training, and technical assistance, and the state participants will distribute the information to business, industry and academic data users.

Experience with this program is expected to indicate ways to improve the Census Bureau's economic data products and services. The pilot program will continue through 1989, and if successful, be established nationwide.

New Jersey's involvement in the program reflects the State's concern for meeting its economic development challenges. It will increase awareness of and access to the economic and demographic data that the business sector needs for intelligent decisionmaking.

The network of New Jersey BIDC organizations plans a series of workshops and publications to disseminate economic statistics, and to improve data handling and analysis capabilities. The first of

these workshops was held on December 12 and 13 at Trenton State College. The topic of the workshop was construction and housing statistics and included speakers from the Census Bureau and the New Jersey Department of Labor. Additional workshops on Manufacturing and Foreign Trade Statistics, and Retail Trade, Wholesale Trade, Transportation and Service Industries Statistics are scheduled for the spring.

New Jersey's BIDC program is expected to make increasing use of computerized techniques and of electronic data and information transfer. One example of this is the NJSDC/BIDC Electronic Bulletin Board (see following article) which is now open to affiliate members.

New Jersey State Data Center and Business and Industry Data Center Electronic Bulletin Board

The New Jersey State Data Center and Business and Industry Data Center Electronic Bulletin Board (NJSDC/BIDC EBB) has been on-line since the summer of 1988. The bulletin board, open to all affiliates of the NJSDC/BIDC network, operates Monday to Friday from 9:30 a.m. to 11:30 a.m. The bulletin board's purpose is to provide economic and demographic data in an electronic format to the NJSDC/BIDC affiliates.

The NJSDC/BIDC EBB is modeled on the State Data Center Bulletin Board that the U.S. Census Bureau operates in Washington, D.C. Data collected, maintained and/or developed by the New Jersey Department of Labor constitute the major portion of the contents of the bulletin board. In addition, data from a number of federal agencies which produce economic and demographic data concerning the State are included. All data are New Jersey-specific.

The NJSDC/BIDC EBB contains data from the following categories:

- employment and wage estimates

- employment projections by industry
- employment projections by occupation
- labor force estimates
- business births and failures
- population estimates
- population projections
- residential building permits
- household projections
- per capita money income
- personal income and gross state product
- trade opportunities reports

As mentioned above, use of the NJSDC/BIDC EBB is currently restricted to network affiliates. Anyone interested in obtaining data from the bulletin board should first contact a NJSDC/BIDC affiliate. The affiliate can provide a listing of the data available and arrange for the data to be downloaded. (Note: not all NJSDC/BIDC affiliates currently have the capability to utilize the bulletin board at this time.)

The system operator, Douglas Moore, reports moderate use of the bulletin board at this time. Mr. Moore expects that use will pick-up, as many affiliates are in the process of obtaining the computer hardware and software necessary to contact the NJSDC/BIDC EBB.

1990 Census Local Review by Victor Furmanec

In light of the approach of the 1990 Census, the New Jersey State Data Center (NJSDC) is preparing to assist municipalities obtain the most accurate count of their population and housing. An effective way to ensure the accuracy of census counts is to participate in the U.S. Census Bureau's 1990 Local Review Program. Although participation is voluntary, the NJSDC is encouraging all municipalities to participate.

The Local Review program is designed to improve the accuracy of the census by helping to pinpoint problems such as clusters of missed housing units, housing units listed in the wrong location, or incorrectly displayed political borders. Local governments will be asked to substantiate major discrepancies by compiling data on the number of housing units at the census block level.

Accurate population and housing information ensures that municipalities will receive their fair share of state and federal funds which are distributed based on the results of the decennial censuses. Local public/private decisionmaking is facilitated by the availability of data which correctly portray the demographic characteristics of the local population.

The most important benefit of participating in Local Review is that local officials have an opportunity to review at the census block level housing unit counts and the group quarters population before the census results are published. After reviewing the preliminary housing unit counts, possible errors are to be identified and reported to the Census Bureau. Potential errors are much easier to check and correct, if necessary, at this stage than after the results are published, when errors can become difficult and costly to resolve. Additionally, the program serves to provide local officials with a better understanding of the procedures and concepts involved in taking a census.

Local Review participants should target their limited time and resources to the following potential problem areas:

- areas with minority populations
- areas that may attract undocumented aliens
- areas with changing housing inventories, especially those with high growth and new housing
- areas with conversions of commercial structures to dwelling units
- areas with known illegal alien conversions
- areas with legal conversions from single to multifamily units
- areas with large group quarters populations
- areas with people who maintain multiple residences

- areas with conversions from seasonal to year-round housing.

The 1990 Local Review Program will be conducted in two stages: precensus and postcensus. These two stages are designed to give municipalities an opportunity to check the accuracy of the Census Bureau's housing counts and group quarters population for each block before and after the census is taken.

In order to substantiate discrepancies, the local government must develop a comprehensive housing unit count at the census block level, using current record-keeping systems such as utility records, tax assessment files, or building and demolition permits, in conjunction with other benchmark data. The local governments' count of housing units will then be compared with the Census Bureau's. The Census Bureau will rank the differences between the two counts starting with those where the local count is greater than the census count. The Census Bureau will then select blocks for field review based on pre-established tolerance limits.

During the precensus Local Review, the Census Bureau will initially canvass up to three percent of the housing units within each of the Census Bureau's district offices. During the postcensus Local Review, the Census Bureau will canvass up to two percent of the housing units within each municipality. If additional funding becomes available, the Census Bureau may increase those percentages. All documented group quarters discrepancies will be reviewed during both stages of Local Review.

The NJSDC is strongly urging that all municipalities in New Jersey participate in the 1990 Local Review training workshops. In September of 1987 the NJSDC held its first round of 1990 Local Review training workshops. County affiliates were trained to assist in training their respective local officials to prepare for their 1990 Census Local Review responsibilities.

The second round of training workshops are planned for the Summer and Fall of 1989, just before the Census Bureau distributes maps and

housing unit counts to each municipality. Local officials will then be responsible for identifying census blocks where their housing counts and those of the Census Bureau differ.

The procedures for reviewing and questioning the Census Bureau data are straightforward, but the procedures are very specific and require training to be understood. For further information on the 1990 Local Review Program, contact the New Jersey State Data Center at (609) 984-2593.

New Data: Data on Diskettes

The NJSDC/BIDC can now provide demographic and economic data on 5.25 inch floppy diskettes. All files are in ASCII and/or LOTUS 1-2-3 format. The information available is identical to the files on the electronic bulletin board (see page 3). Generally, the cost is \$10.00 per diskette or \$10.00 for each file on a diskette when more than one subject is copied on a diskette.
