# **Graduation and Post-Secondary**

This school outperforms 47% of schools statewide as noted by its statewide percentile ranking and 71% of schools educating students with similar demographic characteristics as noted in its school percentile ranking in the peer performance area of Graduation and Post-Secondary. Additionally, this is 100% of school meeting its targets in the of performance Graduation area and Post-Secondary.



Academic Achievement measures the content knowledge students have in language arts literacy and math. For high schools, this includes measures of participation in college readiness tests such as the SAT or PSAT and in rigorous coursework as defined by participation in AP courses in English, math, social studies and science.



Graduation and Post-Secondary measures the rate at which students who begin high school four years earlier graduate within four years. Also included is a measure of the rate at which students in a particular school drop out of school.
















# **Proficiency Trends - Math**












# **Enrollment by Ethnic/Racial Subgroup**






























# **Enrollment by Grade**




# **Enrollment by Ethnic/Racial Subgroup**
























# **Enrollment by Grade**




## **Enrollment by Ethnic/Racial Subgroup**








## NJASK Proficiency Trends - Language Arts Literacy -Grade Level - 06


















# **Enrollment by Ethnic/Racial Subgroup**








NJASK Proficiency Trends - Language Arts Literacy -Grade Level - 04
















# **Enrollment by Ethnic/Racial Subgroup**










