Governor's Task Force On Services To Disabled Persons

The above Task Force had its first meeting as a body on 1/9/86 at Trenton's Capitol Plaza Hotel. After discussion of the Mission statement and goals of the Task Force a review of the work plan was presented. The work plan was divided into four phases: Phase I - organization, II - Data Collection, III - Analysis, IV - Recommendations.

The task force meets each month (February thru June) and the various committees are scheduled to meet once every two weeks to collect data from February thru April.

With Steve Janick functioning as chairperson, Dr. Elizabeth Boggs was elected as Vice Chairperson. The committee structure is as follows:

Appointed members of the vocational services committee include George Chizmadia - representing Commissioner Serraino, Department of Labor (DOL), Jeri Crisman, Assistant State Treasurer, Jim Mosher - immediate past President, N.J. Association of Rehabilitation Facilities, and Dr. Monroe Berkowitz - Bureau of Economic Research - Rutgers University.

A like number of volunteers and interested persons will be selected to serve on various committees. In addition, it is expected that some persons will be serving on a Focus Group or in other capacities as deemed appropriate.



Clarification

In the Fall 1985 edition of Facilities Facets a press release was carried which indicated that the Governor had signed A-4085 into law and that this would fund each of the workshops at 100%. When the budget process began, it was believed that this would be the case. The eventual reality will see the program costs funded at 90 some percent.

Local Office Budgets

Where before all DVRS offices drew from the same pot in the past, they are now accountable for the cost of the results that they achieve. Please understand that this is a new system and there may be a problem or two during the initial stages of implementation. We have informed you so that you can work along with our staff to minimize any problems and insure the success of the system.



DVRS And The WATC's

The interplay between the Division of Vocational Rehabilitation Services (DVRS) and the Work Activity Training Center (WATC) has traditionally been viewed from one perspective, that of DVRS administering the WATC program. But there is another aspect between the two that should be addressed. This is the interplay between the local DVRS office and individual WATC's. As there are presently only eight WATC's scattered throughout the state, many local DVRS offices do not have the chance to interact with a WATC and in many cases do not know what a WATC is. However, don't stop reading if you do not have a WATC located near you, as much of what I write will be applicable to the Division of Developmental Disabilities' (DDD) Adult Training Centers (ATC) formerly known as Adult Activity Centers.

The WATC is a vocational habilitation and employment program which works with developmentally disabled (DD) adults who, while they have not attained sheltered or competitive employment, are seen as having the potential to do so.

The relationship among the DVR local office, the WATC and ATC is best when the needs of the client are addressed. When a local DVR office receives a referral of an individual who is severely developmentally disabled, the counselor has a number of choices. The counselor can determine that the client is functioning too severely for DVRS services such as workshop evaluation. In such a case it is best to let the referral source know this and give a prescription as to what is needed by that individual to get him or her up to a level where the client may be assigned as a DVRS client for diagnostic purposes. The client should also be referred to DDD, if the individual is not already a client, for referral to an ATC. The DVRS counselor may believe the client to

be a potential client for a sheltered workshop but after or during pre-vocational evaluation or Work Adjustment Training (WAT) it may be found the client is not ready for workshop placement as a DVRS sponsored extended employee. This individual could best be served by referral to a WATC, if one is nearby, with a prescription as to what work or behavioral skills the client needs to improve to become an extended employee. If no WATC is nearby, referral to an ATC or seeing if such services will be provided by the workshop are the next best options. Again, a prescription should be sent with the client. Hopefully, after the client gains these skills, he or she will be referred back to DVRS for placement in sheltered or competitive employment.

The WATC's should maintain a working relationship with the local DVRS office and if possible with one specific DVRS counselor. When a client of the WATC is believed ready for either sheltered or competitive employment, referral should be made to DVRS for appropriate services. Appropriate services may include diagnostics, workshop evaluation, WAT, on-the-job training or other training as needed by the client. If a referral is made from a WATC within a workshop, a client may not need a full ten weeks of evaluation or eighteen or thirty-six weeks of WAT. In fact, in some cases little or no pre-vocational evaluation or WAT may be needed while in others extensive WAT may be needed.

The important thing to remember is that, while WATC clients are not clients of the regular DVRS program, they are clients of DVRS. The aim of DVRS, the WATC and the client is employment and DVRS and the WATC's should do, within reason, whatever is needed by that client to attain employment.

**Cost Study Report On Facility
VR And Extended
Employment Programs
Operated By Facilities During
FY 84**

Our Grants Management Staff recently completed their review of the VR (Evaluation and Work Adjustment and Training) and Extended Employment Program costs in 18 vocational rehabilitation facilities on the basis of annual auditor's reports filed for their fiscal years ending between June 30, 1984 and December 31, 1984. A similar study was conducted during the 82-83 fiscal year and the results reported in the Winter 1985 issue of "Facilities Facets".

In each fiscal review, the facilities VR and Extended Employment program costs were reviewed for reasonableness, allocability, and appropriateness to the programs and services provided, in accordance with Principles and Procedures for Determining Costs of Rehabilitation Facility Programs, Services, Issued April 1, 1982, per N.J.VR Facilities Rules and Regulations 12:51-8.2(b).

It is our opinion that this study and report, as summarized on the following page, sufficiently documents that DVRS funding policies have provided adequate funding and financial support to those facilities which were managed in a cost-

efficient manner, at levels of service consistent with DVRS requirements, and effectively utilizing all resources available to them.

- In both our 82-83 and current 84 cost studies, in 50% of the facilities reviewed, DVRS fees exceeded their costs, and in the other 50% of them, their costs exceeded the fees, by ten to twenty percent. Overall, DVRS facility fees averaged 100% of reasonable costs which were calculated at between \$12.50 and \$13.00 per day.
- The average actual facility cost to evaluate and train a client for employment was \$3,057 for which it received an average fee of \$3,346 (eleven facilities received average fees in excess of \$3,057 and seven facilities less than that).
- In FY 84, State extended employment support funded 90% of the eligible program costs reviewed during the study (18 facilities); the legislature actually appropriated an average of \$2,187 per client toward an average annual cost to the facility of \$2,238. Facilities also expended an additional ten percent in funds for other client services which were not covered under their sponsoring Agency's contracts.
- Between 1983 and 1986, the average EE facility cost per client increased by 22% from \$2,145 per year to an estimated \$2,621 per year.

During the same period, the funds appropriated annually to the EE program increased by 43% from \$1,670 per year to \$2,391 per year increasing the State's funding share of the program's cost from 77% in 1983 to an estimated 92% in FY 86.

° During 1984, 12 out of the 18 facilities studied reported in their annual auditor's reports net average overall annual operating gain of almost \$50,000, while the other six facilities reported average overall losses of over \$77,000 annually. The same was proportionally also true in our previous year's cost study.



More Tax Tips

This quarter's first "Tax Tip" relates to sheltered workshop wages and other payments to clients engaged in work activities or Rehabilitation Training Programs such as Evaluation, Work Adjustment and Skilled Training.

Effective October 1, 1980, Regulation SI 00810.00 re-defines remuneration (wages) for work activities performed in a program conducted by a sheltered workshop or "Work Activities Center" to be earned, not unearned income, for purposes of determining SSI Income eligibility, regardless of whether such payments constitute wages under the annual earnings test under Title II.

Based on our discussion of this new regulation with SSI officials in Washington, it is our understanding and interpretation that wages paid to clients in a sheltered workshop or Work Activity Center, including Adult Activity Programs, will be considered and treated as earned income in determining an individual's SSI eligibility.

Remuneration paid to clients who are participating in vocational rehabilitation training programs or Work Activities Centers will continue, in spite of this regulation, to not be considered wages for purposes of withholding and payment of FICA contributions, unless a common law employer-employee relationship can be established as a

basis for its payment.

This relationship has previously and presently been determined to exist by the Social Security Administration only in the extended employment program, and therefore only wages paid to clients participating in the program are subject to employer and employee FICA contributions.

Our second Tax Tip for this quarter relates to a change in the Federal Income Tax Law which effective January 1, 1986, permits taxpayers to disregard any income earned by a dependent in a sheltered workshop in determining in whether he or she has received gross income in excess of \$1,000 during the tax year. This is one of the tests that must be met in determining whether an individual may be claimed as a dependent for federal income tax purposes.

We have interpreted this to mean that a person can be claimed as a dependent for federal income tax purposes, if he or she meets all the other requirements (tests), and their gross annual income exceeds \$1,040 only by including the dependent's earnings while in a sheltered workshop.

Please notify parents of your clients of this change in the tax law and suggest that they confer with their accountants, if they have further questions.
