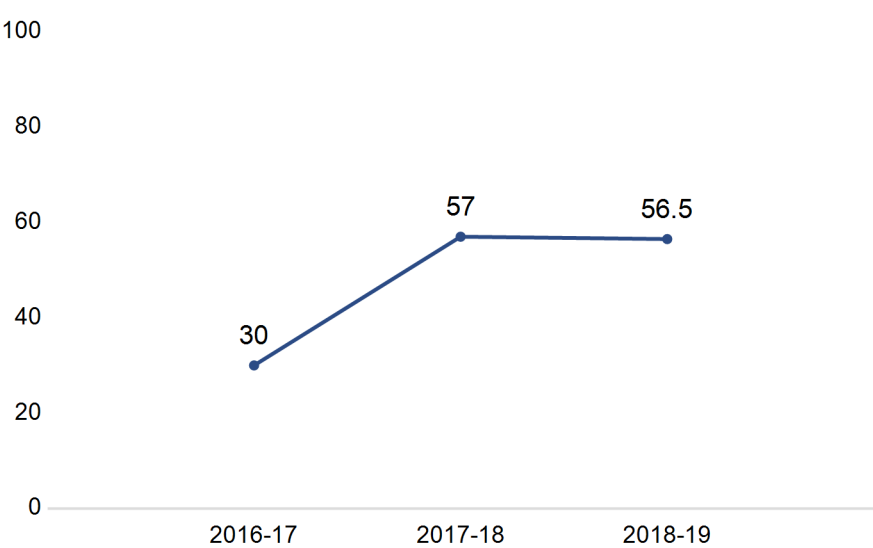

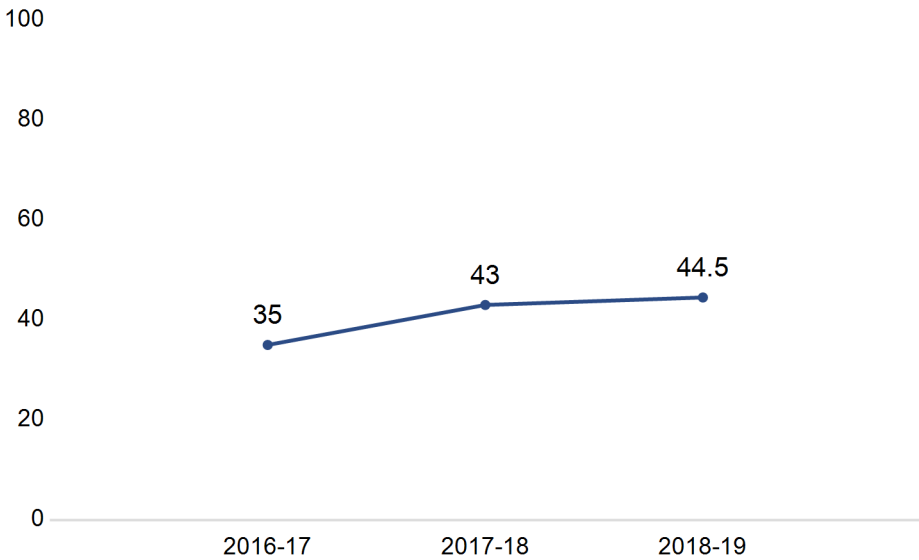
Student Growth Trends and Progress

Student growth is a measure of how much students are learning each year. 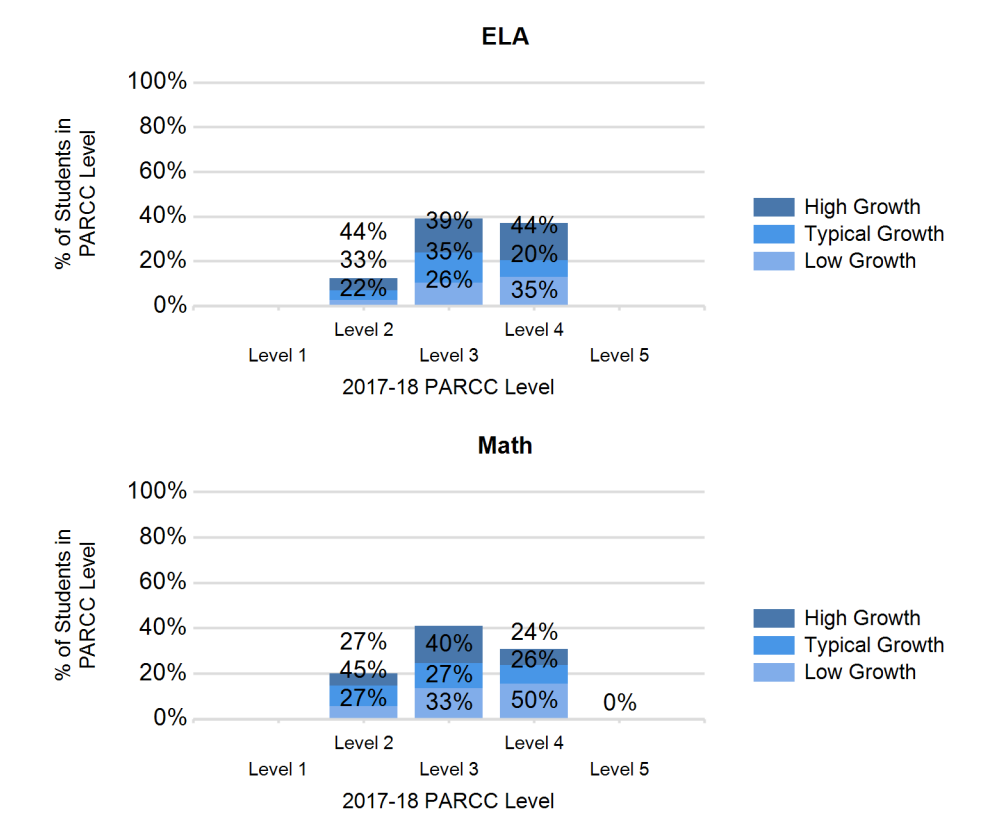

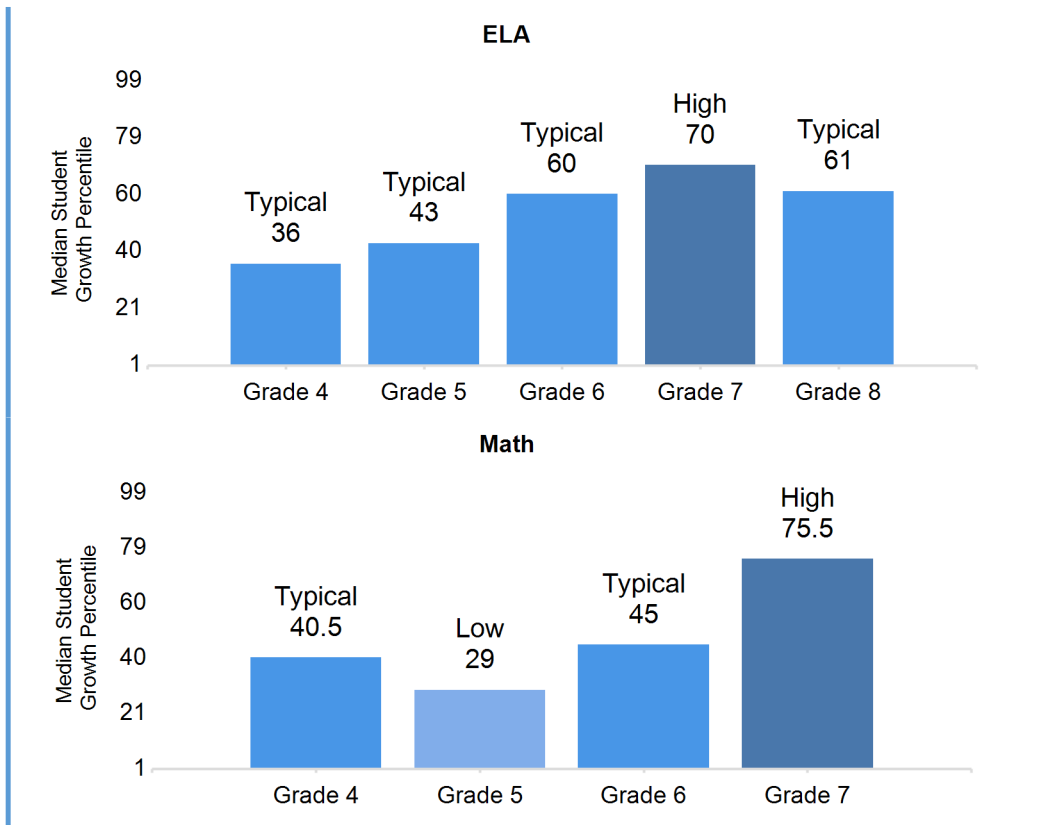
Student Growth by Performance Level

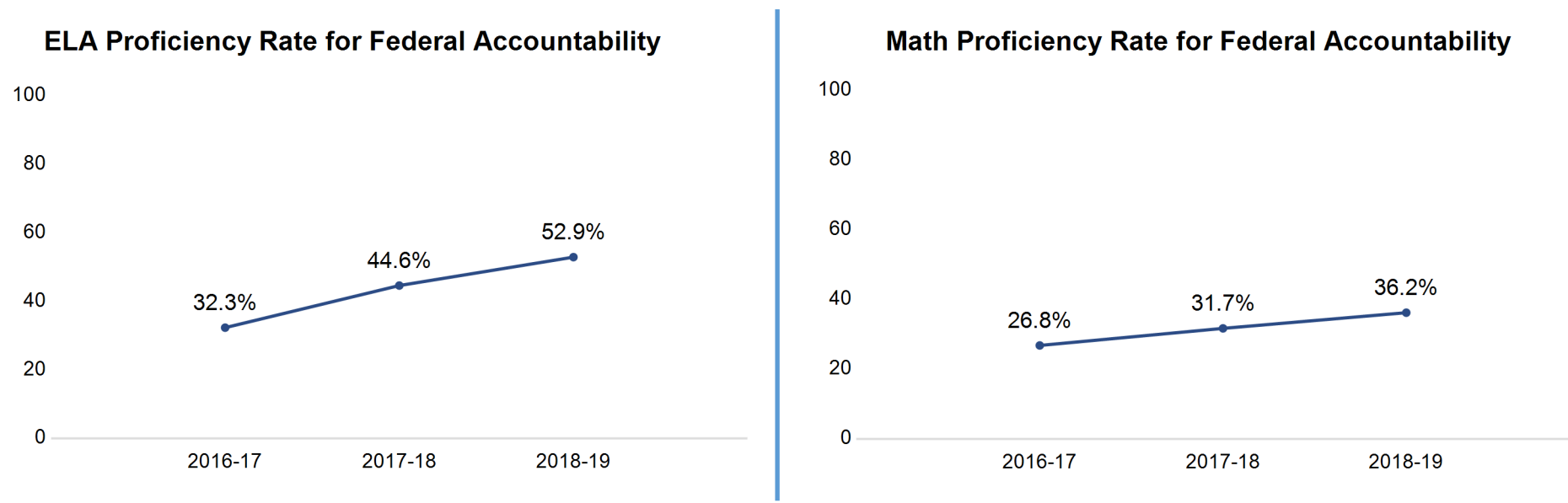

English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English Language Arts both overall and by student group. It includes the results of students taking both the NJSLA and DLM assessments. NJSLA results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. A student is considered to have met or exceeded expectations if he/she scores at Level 4 or 5 on the NJSLA assessment or at Level 3 or 4 on the DLM assessment.

This table shows both the percentage of students that met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long term goal of 80% proficiency by 2030. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 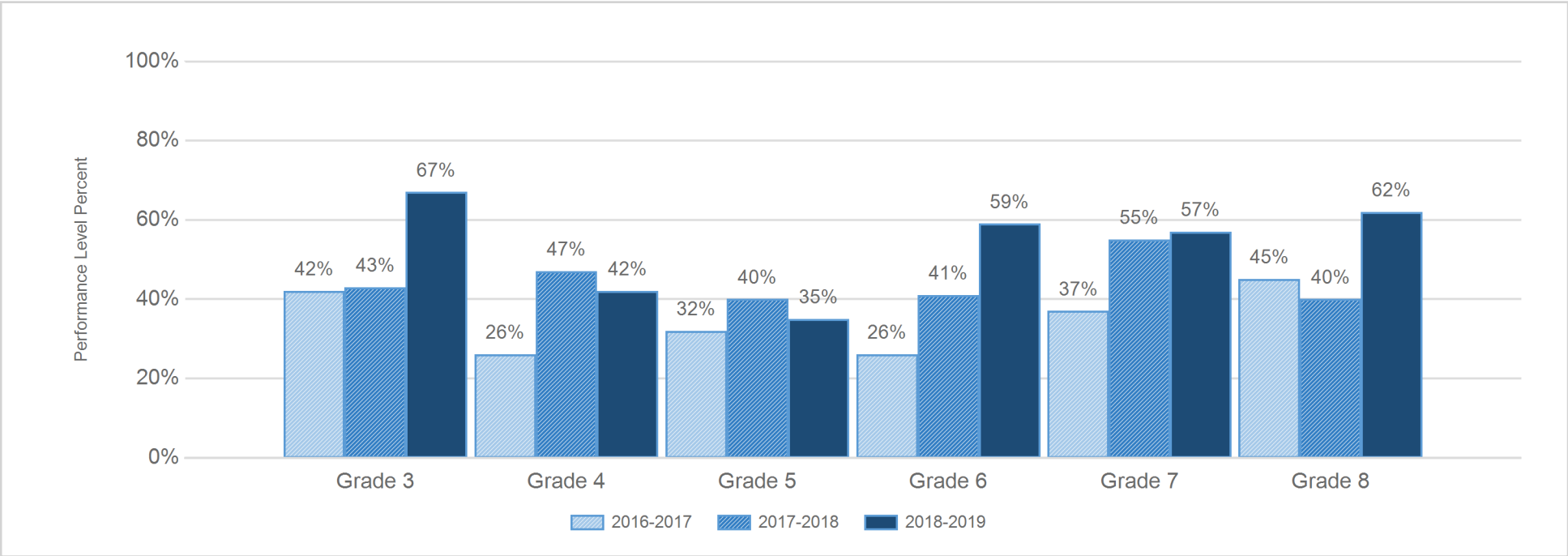

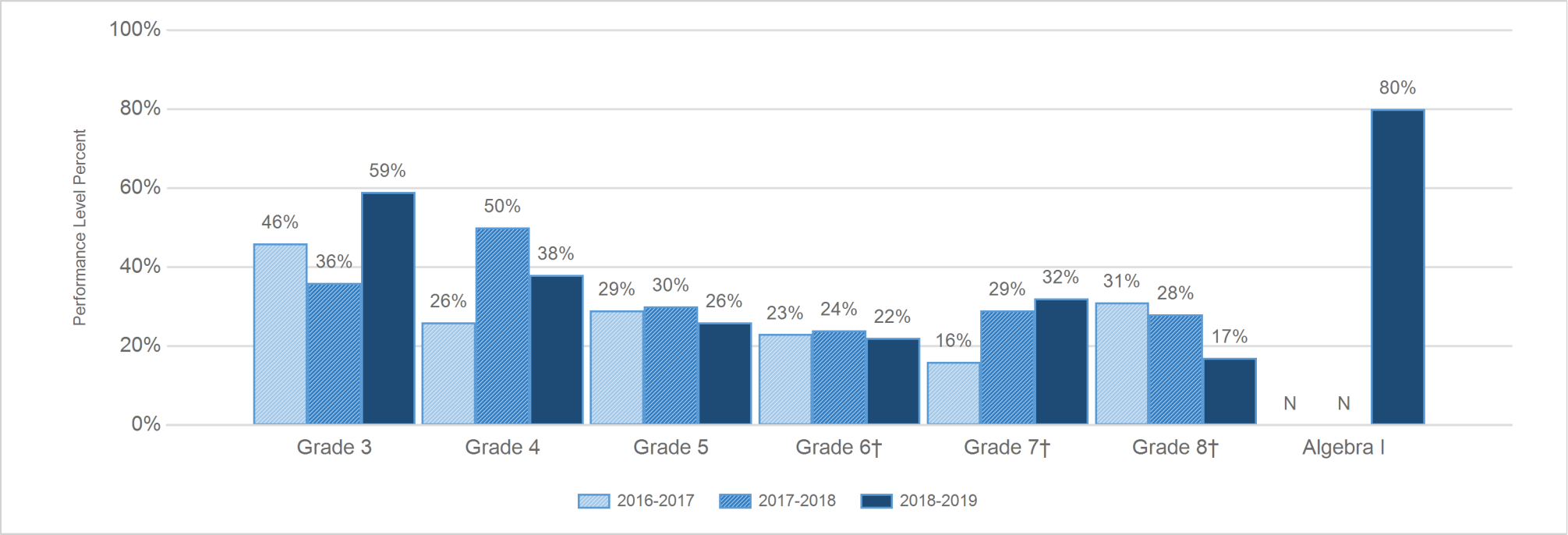

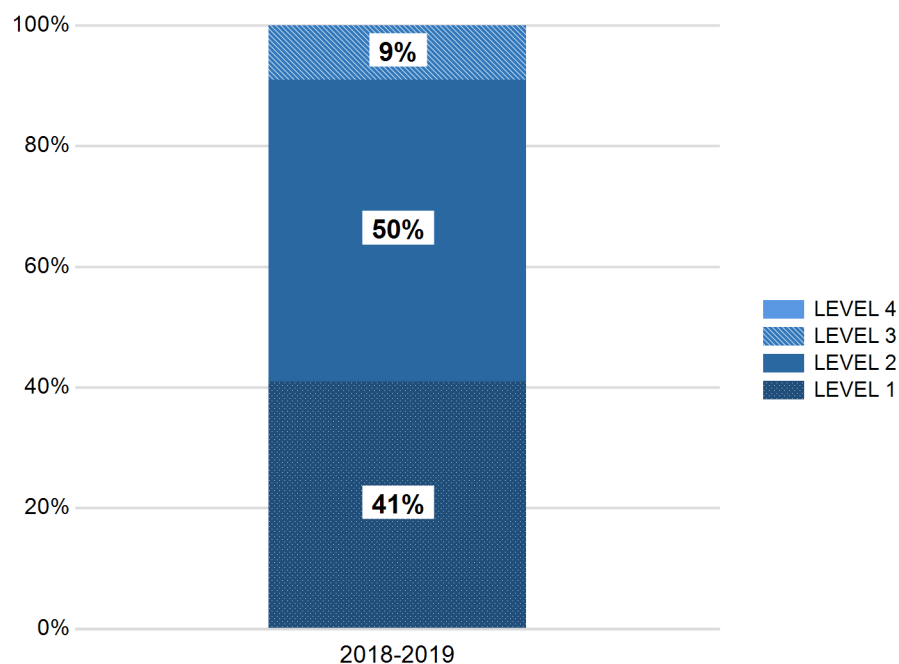

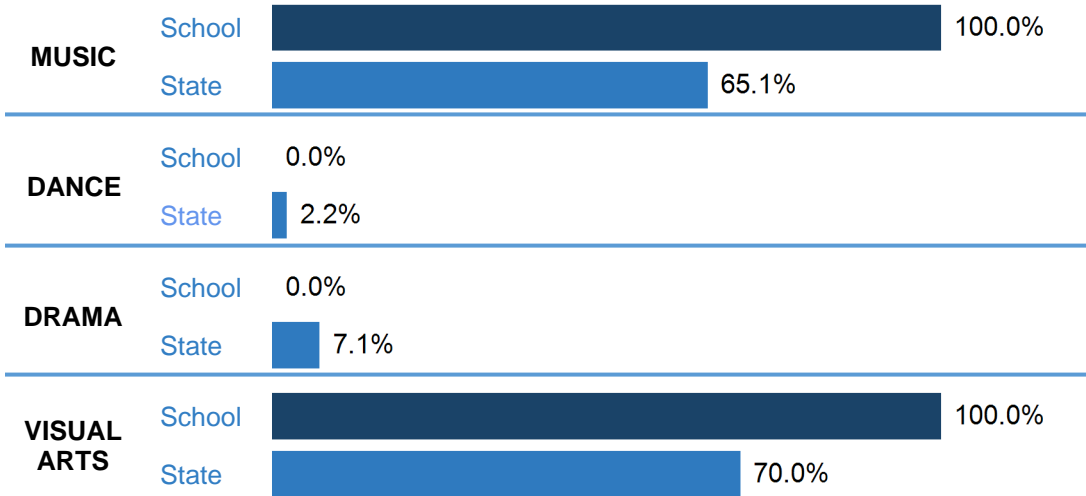

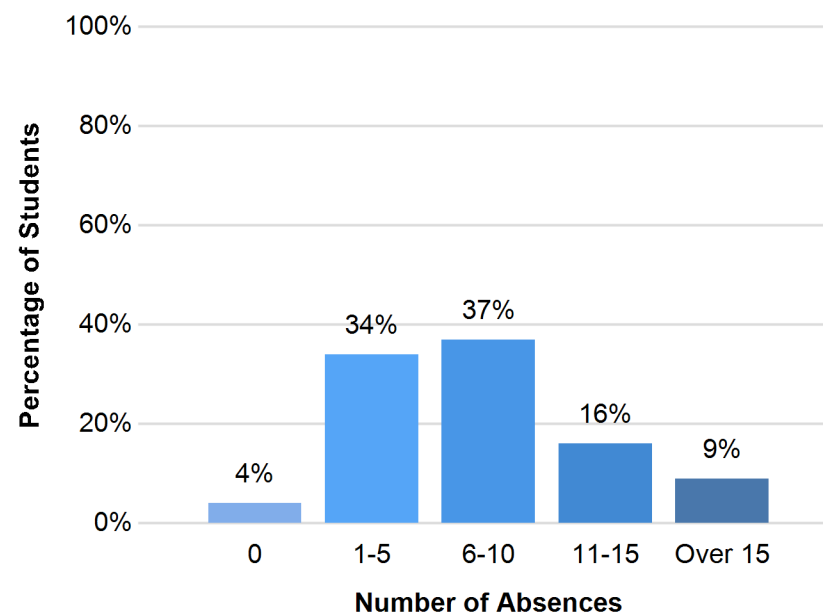

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





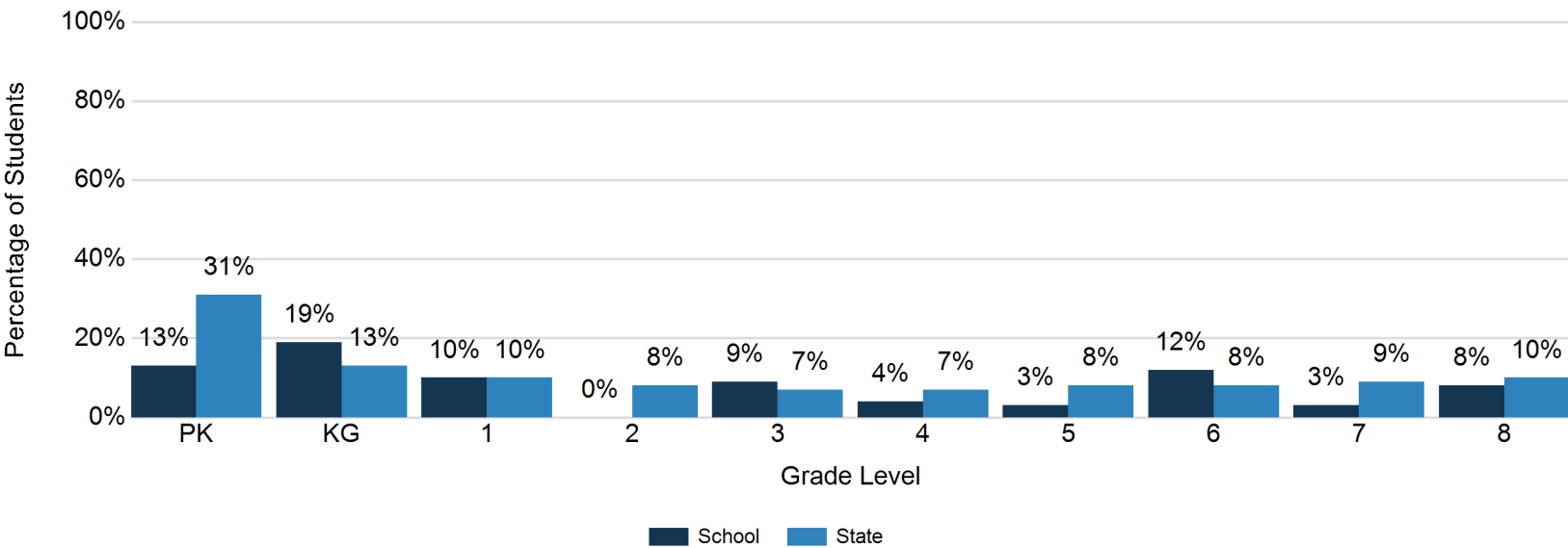

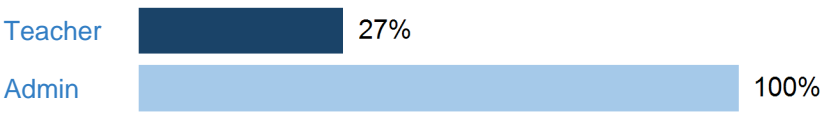

There are also playgrounds, baseball, and soccer fields. Continual improvements in technology include building wide wireless internet access and the infusion of over 300 chromebooks, 7 tablets, 8 Promethean Boards, 2 Active Panels, 6 Interactive Projectors, and 10 digital cameras into classrooms. All computers in the computer lab were replaced during the summer of 2019. Central air conditioning in all areas of the school allows for a more conducive learning environment. Line striping and patching was completed during the past summer and was phase one of a multi-year project. Additional summer projects included HVAC duct cleaning in the library and the installation of new VCT tiles in the art room and gymnasium office. In conjunction with the creation of a security vestibule, safety/security film was installed at two entrances.</p>
 <p>School Safety:</p>	<p>Security cameras have been installed in locations both inside and outside of the building to enhance safety and security measures. The multi-year plan for the purchase of additional cameras is nearing completion. The district's website continues to have much value as a source of updated information for all constituents. Visitor procedures, including collecting a visitor's license, escorting visitors to their destinations and back to the office to sign-out, and requesting lists of expected visitors during holiday parties and events, increase building security levels. Student drop off and pick up procedures allow for a more structured routine which prevents students from entering busy traffic areas, increases staff visibility, and improves the overall timeliness of the process. The main entrance security vestibule project will soon be completed. The Chief School Administrator and School Business Administrator are both certified as School Safety Specialists through the NJ DoE.</p>
