The Option Clause also provided that the Authority would pay the same price or an increased price provided the increase is substantiated by the vendor and approved by the Authority. The Maintenance Department approved Freedom International's request for an increase of \$6,000 per vehicle (approximately 2.8% to a unit price of \$182,381.33). Freedom International explained that the increase is due to essential engine updates needed to meet the Environmental Protection Agency's new emission requirements.

VTDM provides both live and recorded video of all transactions occurring in a revenue collection lane on both the Turnpike and the Parkway and combines that video with transaction data

Until a final recommendation is made and the Board of Commissioners grants authorization to enter into a new contract, the Authority needs to maintain the current EAP Services contract. Therefore, it is necessary to extend the contract with Quantum through September 30, 2010 and increase the authorized amount accordingly, at the same terms and conditions as the original contract.
