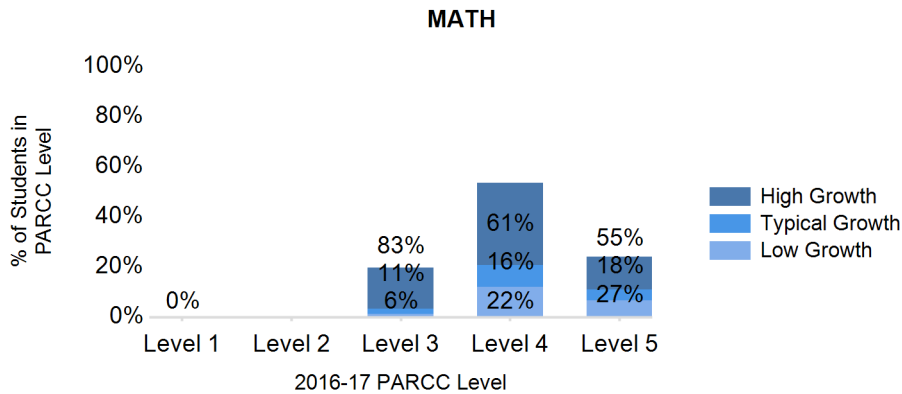
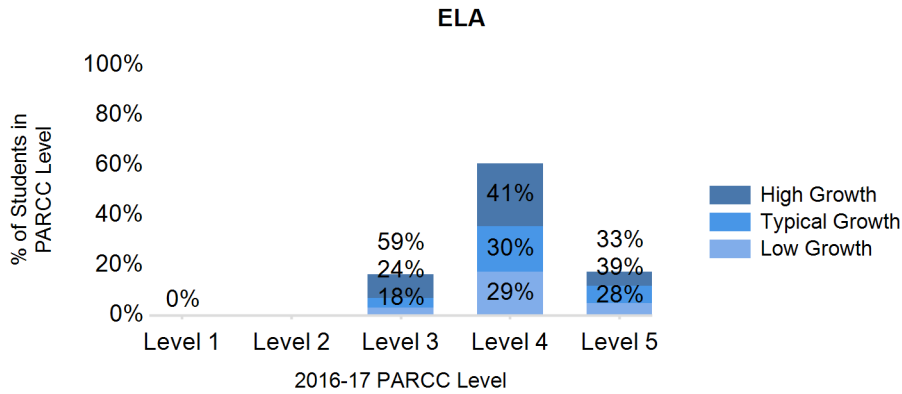

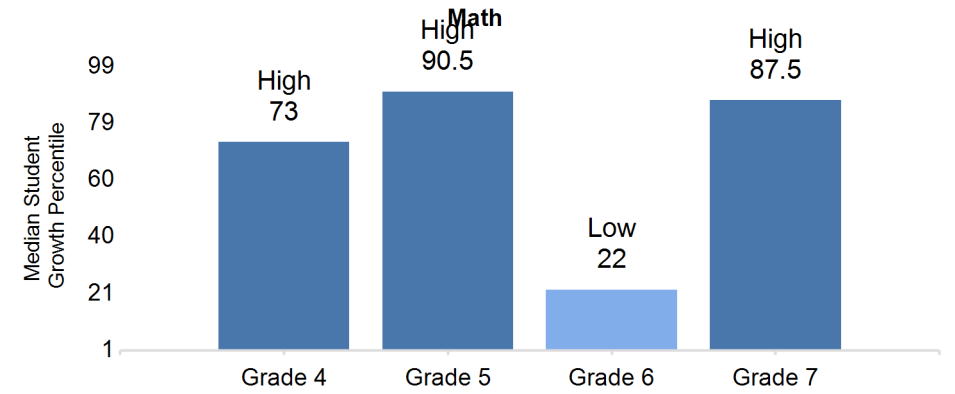
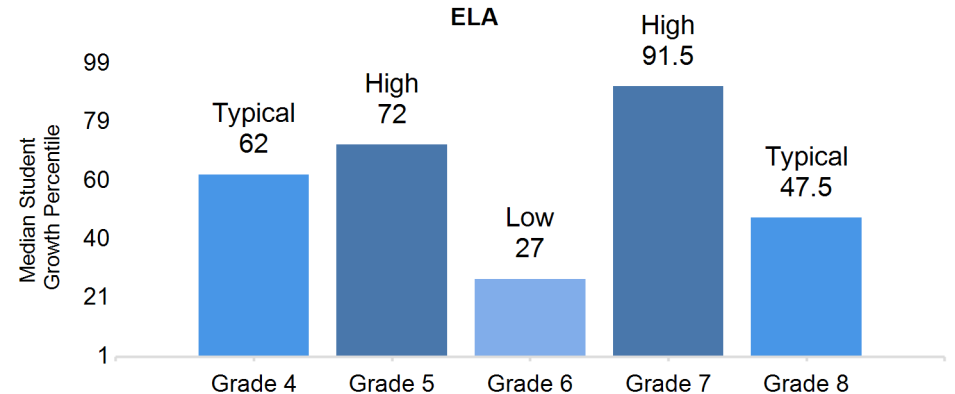
Student Growth by Performance Level

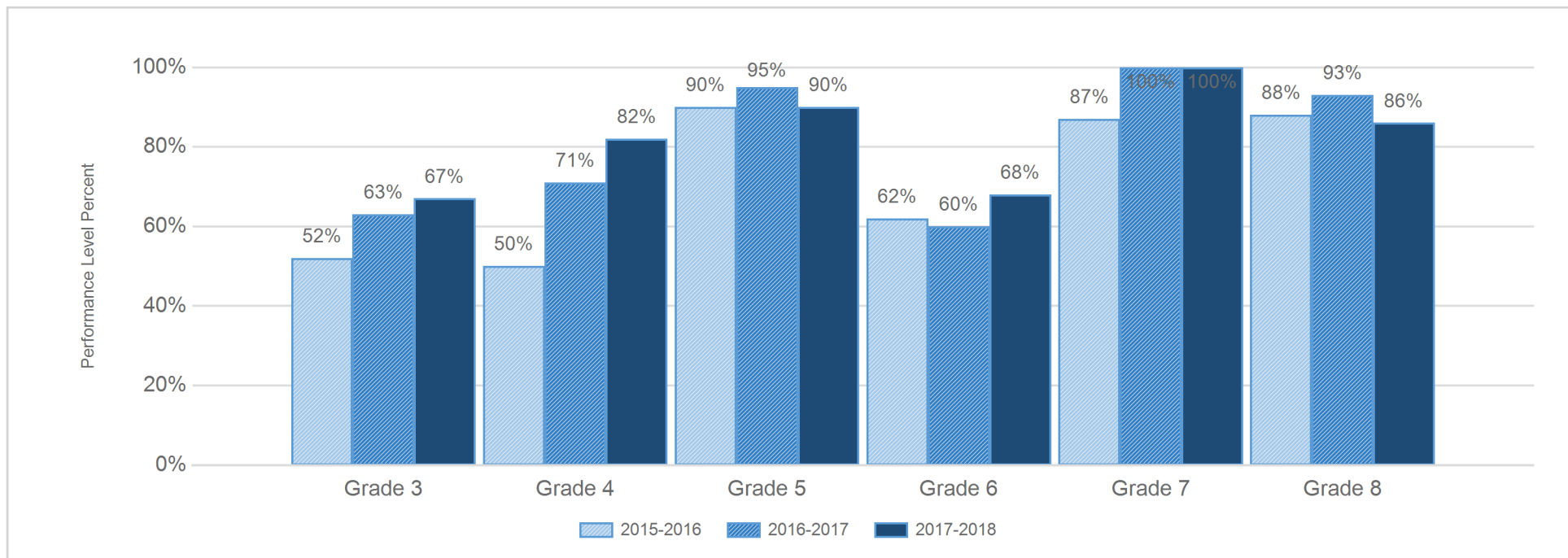

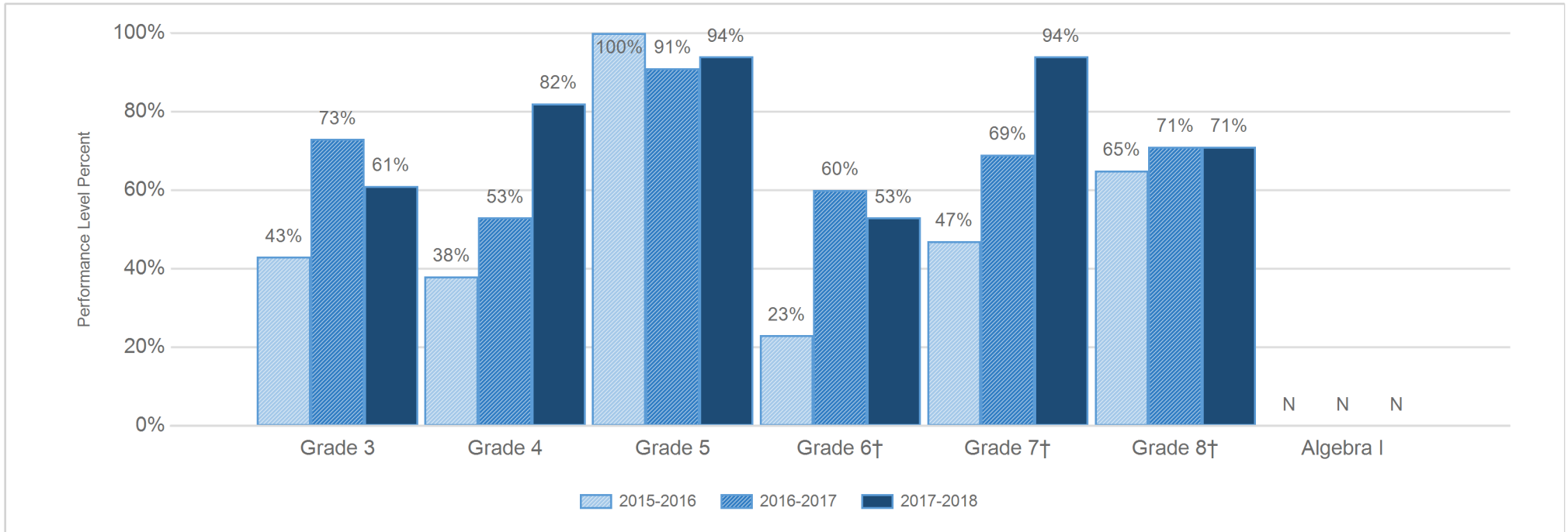

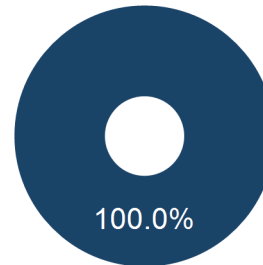

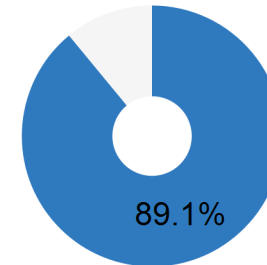

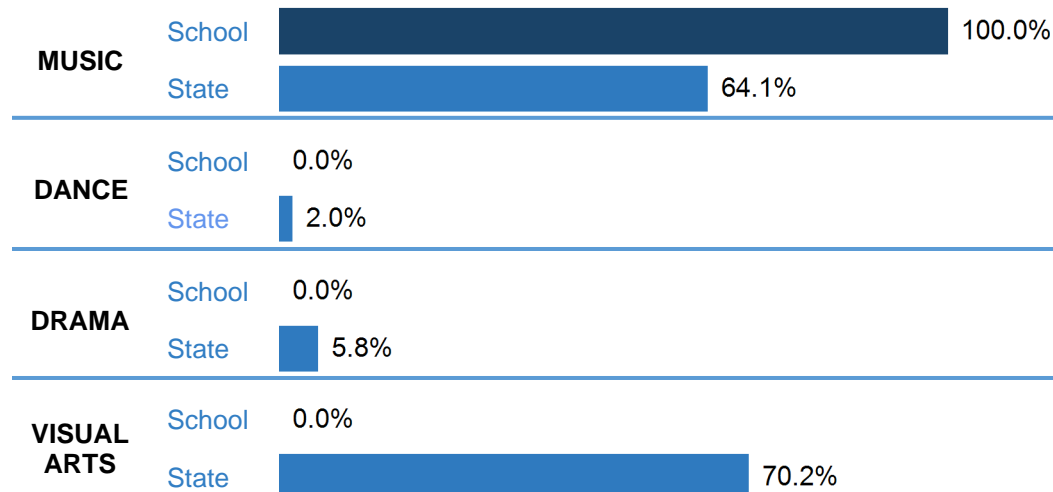

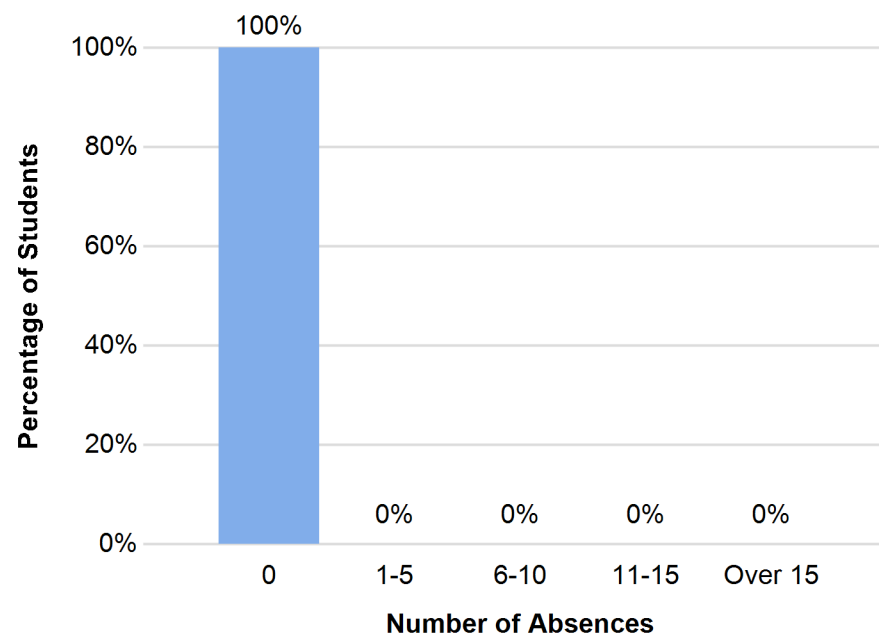

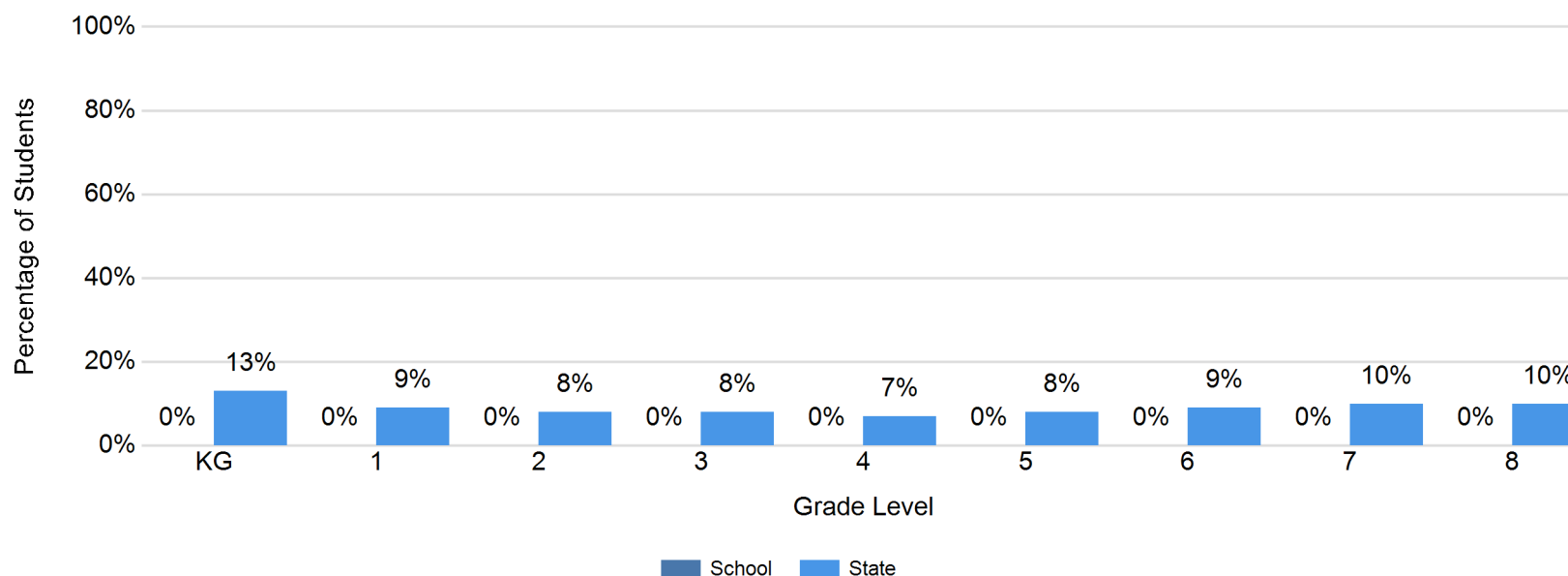

The survey results are posted on the school's website. The results of last year's survey indicated an 85% satisfactory rating from students, parents, and staff.</p>
 <p>Facilities:</p>	<p>During the 2017-2018 academic year, capital improvements were made to the school's physical plant. A completely new 5th floor added an additional 6 classrooms, office space and a partial gym to the building. The schools heating and air conditioning systems were upgraded, wired and wireless systems were upgraded and expanded, and a complete new telecommunications system was developed and installed. The addition currently houses students in grades 6-8, and provided additional space for students in grades 3-5.</p>
