For high schools, this includes measures of participation in college readiness tests such as the SAT or PSAT and in rigorous coursework as defined by participation in AP courses in English, math, social studies and science.



Graduation and Post-Secondary measures the rate at which students who begin high school four years earlier graduate within four years. Also included is a measure of the rate at which students in a particular school drop out of school.








# **Enrollment by Ethnic/Racial Subgroup**






















# **Enrollment by Ethnic/Racial Subgroup**


























NJASK Proficiency Trends - Science - Grade Level - 04










# **Enrollment by Ethnic/Racial Subgroup**

Students in both elementary and middles schools begin to demonstrate college readiness behaviors long before they even enter high school. Among the behaviors that research has shown to be indicative of success and college and career readiness are regularly attending school and challenging themselves with rigorous course work. 
