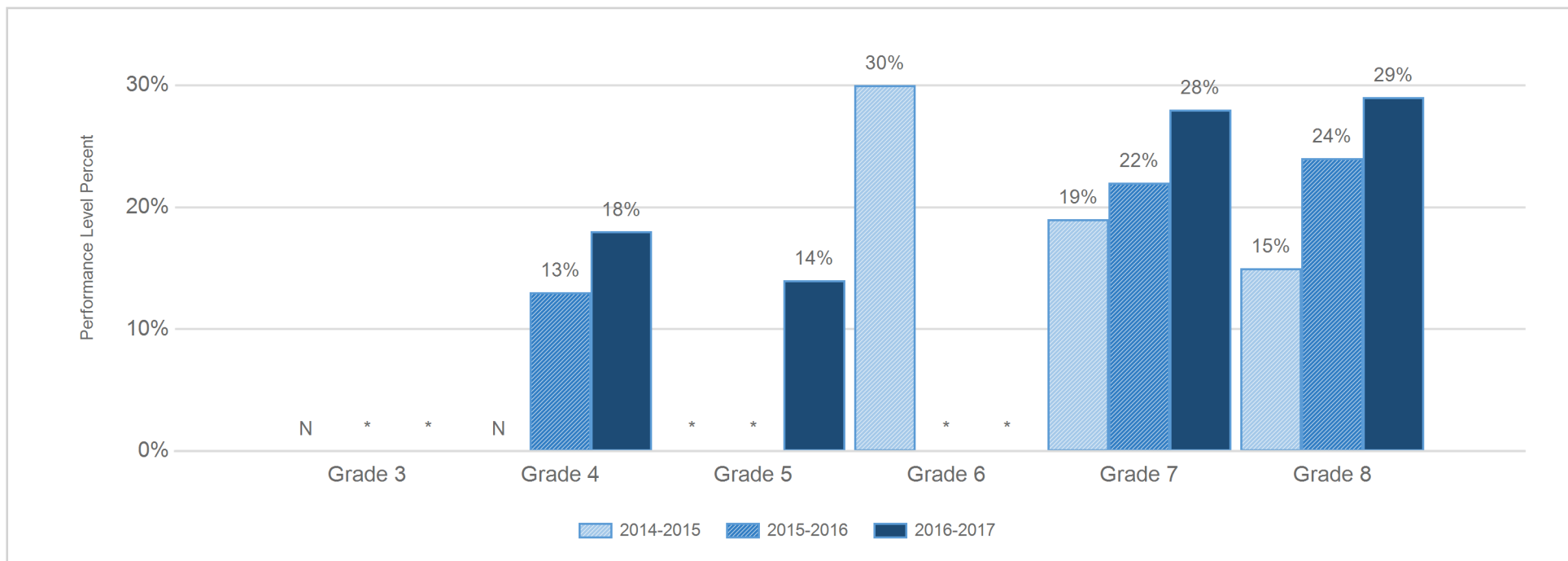

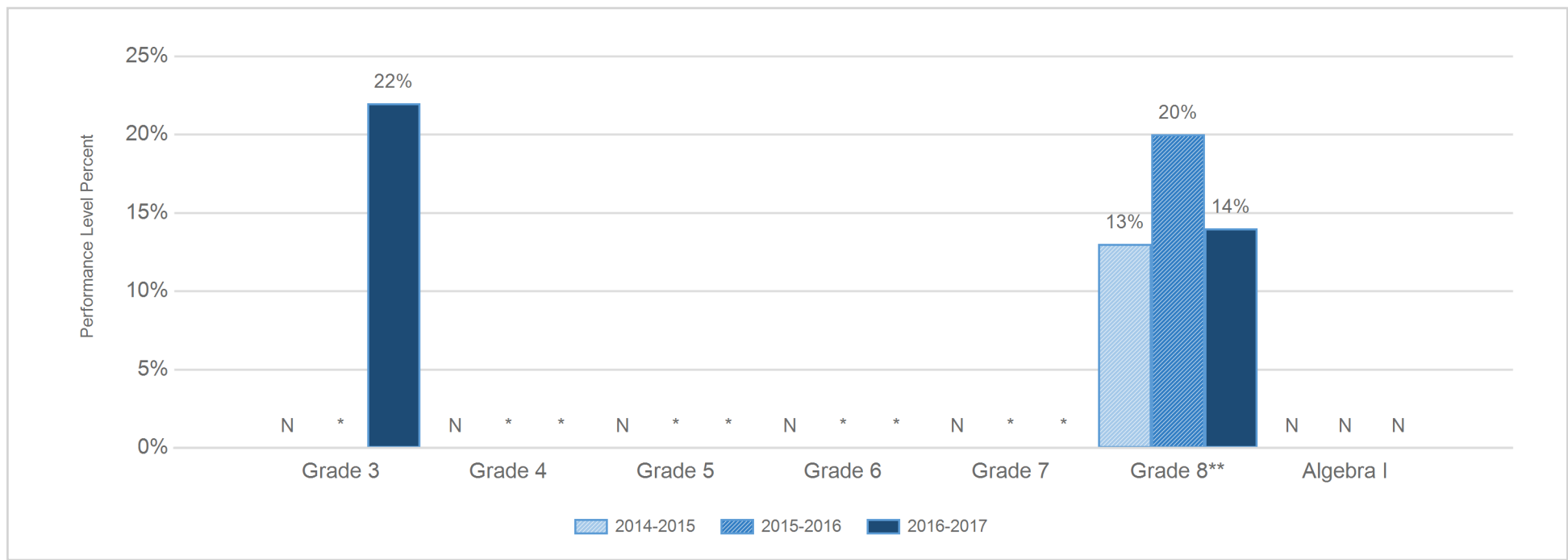

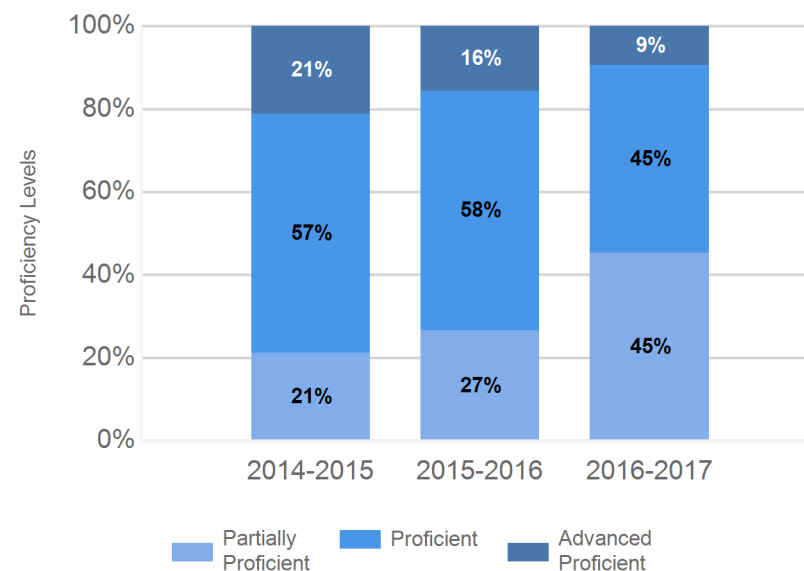

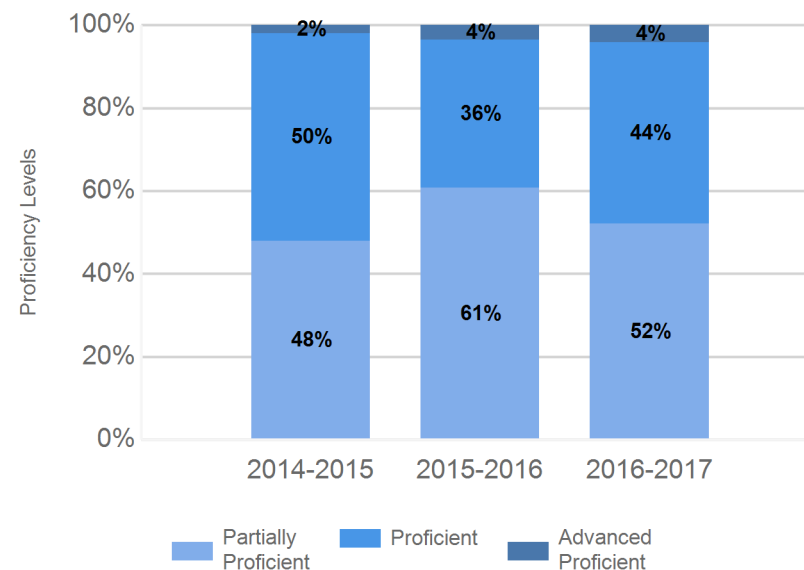

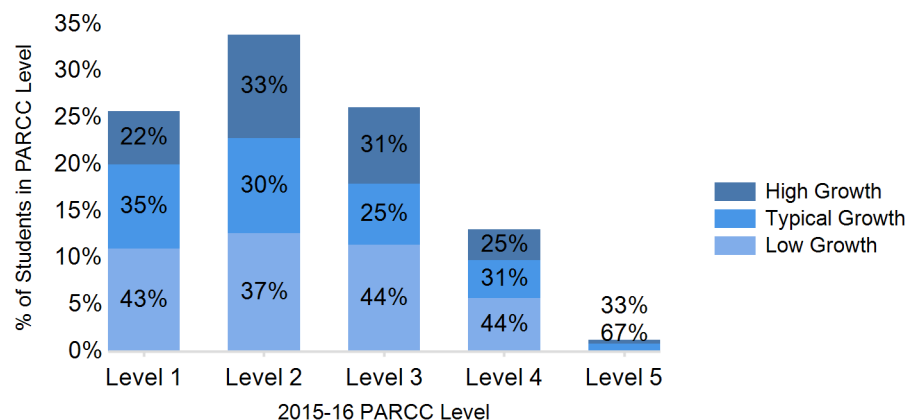

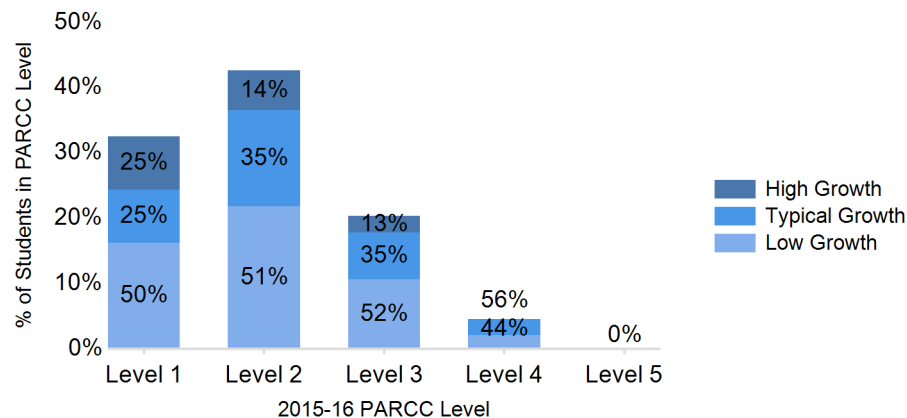

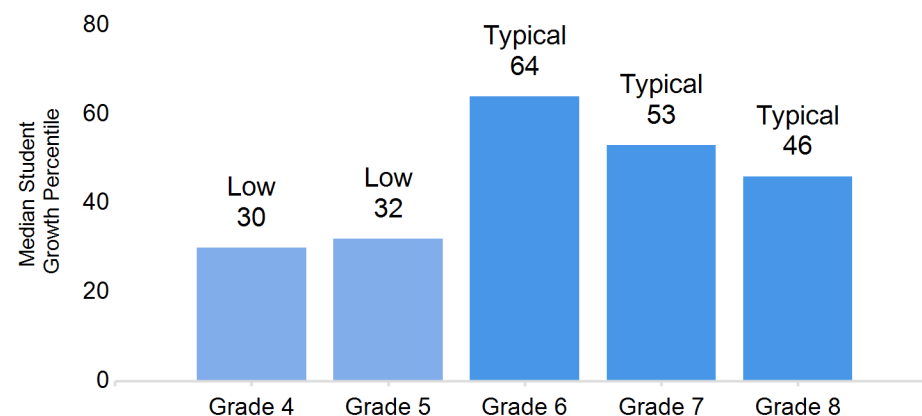

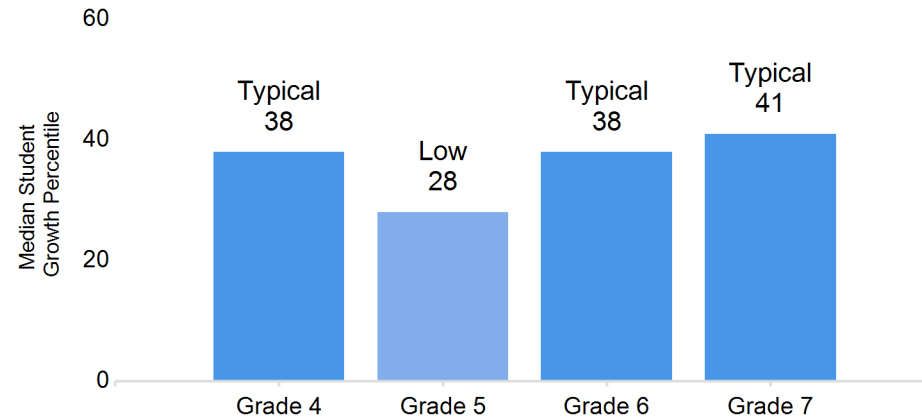
Student Growth by Grade

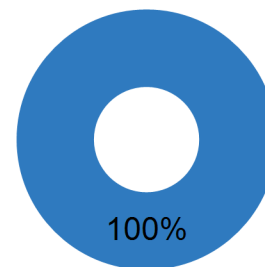

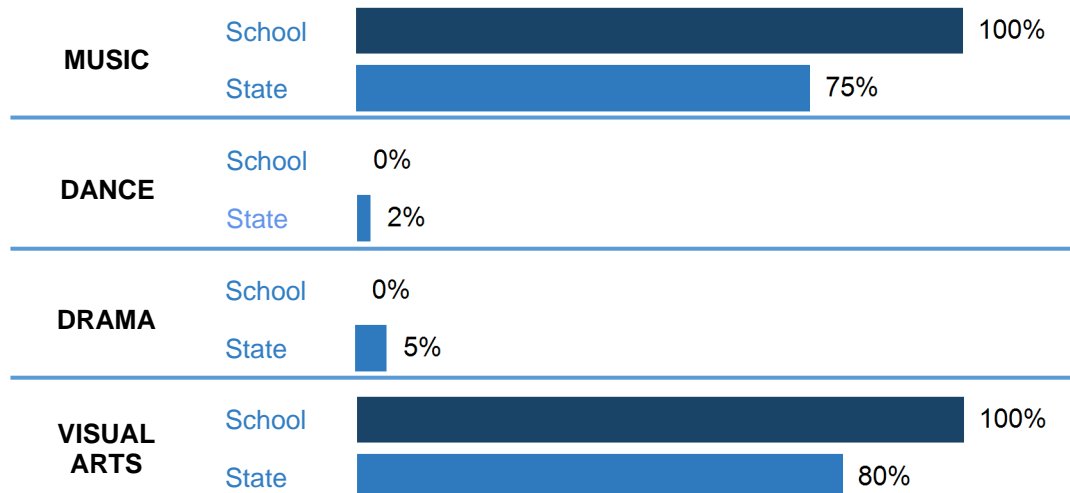

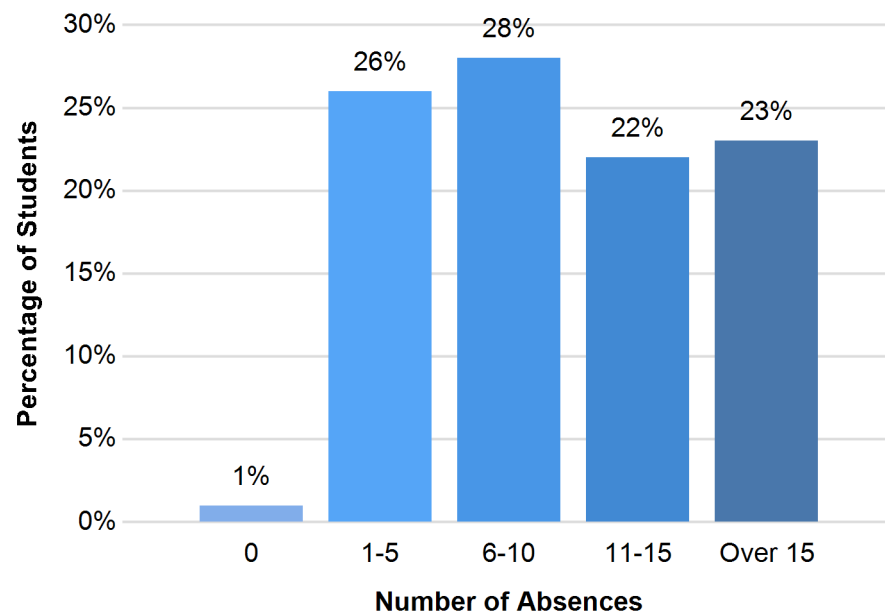

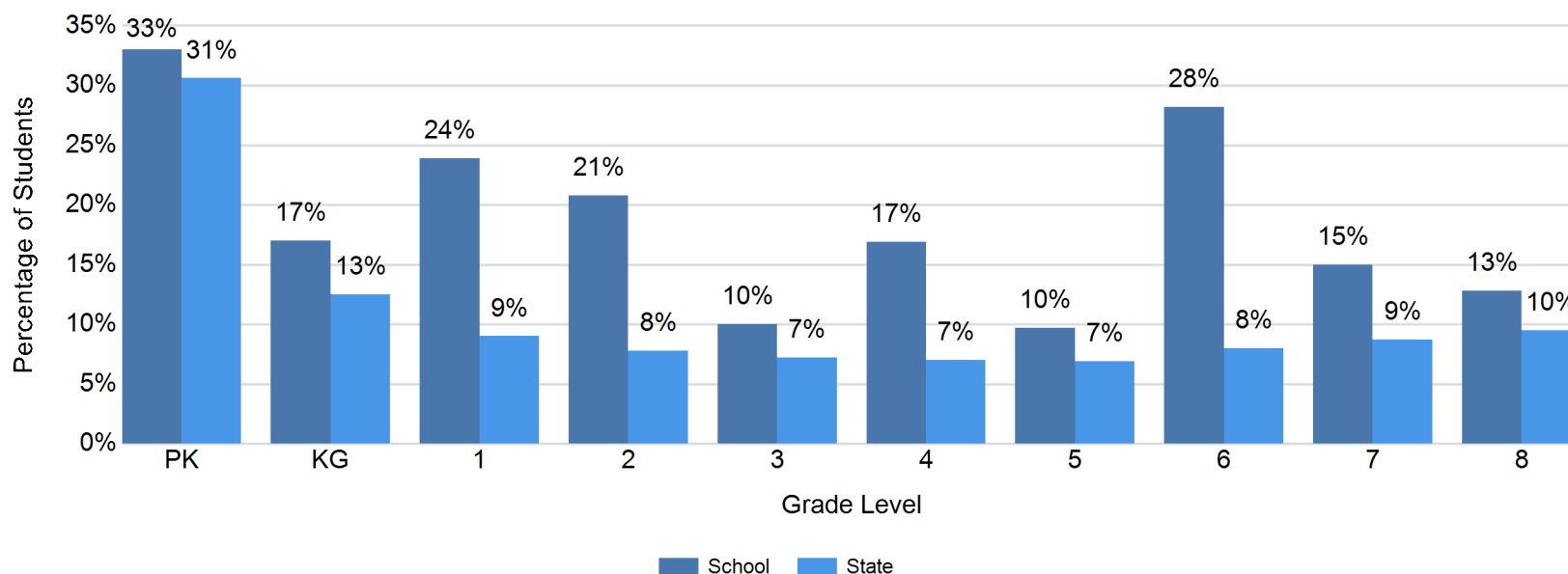
