*TRENTON, Tuesday, October 28, 1788.*

**B** EING the Time and Place appointed by Law for the first Meeting of the General Assembly, chosen at the annual Election, on the fourteenth Instant, the following Persons returned as Members attended, to wit, Isaac Nicoll, returned as one of the Members of the County of Bergen; Henry Garritse, as one of the Members of the County of Essex; John Combs, as one of the Members of the County of Middlesex; Thomas Little and James Rogers, as two of the Members of the County of Monmouth; Edward Bunn, Robert Blair and John Hardenburgh, as Members for the County of Somerset; Joseph Biddle, Robert-Strettle Jones, and Daniel Newbold, as Members from the County of Burlington; Franklin Davenport, as one of the Members of the County of Gloucester; Elijah Townsend and Richard Townsend, as two of the Members of the County of Cape-May; Benjamin Van-Cleve and John Lambert, as two of the Members of the County of Hunterdon; John Sheppard, John Burgin and Eli Elmer, as Members from the County of Cumberland; Aaron Hankinson and Charles Beardlee, as two of the Members of the County of Suffex, attending, the respective Certificates of their Election were read, approved and ordered to be filed: Franklin Davenport, Esquire, was appointed, agreeably to

the Constitution, to qualify Benjamin Van-Cleve, Esquire, who, being duly sworn accordingly, took his Seat ; and the remaining Persons returned as Members, being qualified by the said Benjamin Van-Cleve, took their Seats in the House.

The House proceeded to the Choice of a Speaker, when the Honourable Benjamin Van-Cleve, Esquire, was chosen, and accordingly placed in the Chair.

The House proceeded to the Election of a Clerk, when Maskell Ewing, Esquire, was unanimously chosen.

Maskell Ewing attended ; and, having taken the Oaths of Abjuration and Allegiance, and also an Oath for the faithful Discharge of his Office, he took his Seat as Clerk in the House.

*Resolved*, That David Righter be Doorkeeper to the House during the present Session.

*Ordered*, That Mr. Nicoll do wait on the Council, and acquaint them that the House of Assembly have this Day proceeded to Business, and have chosen the Honourable Benjamin Van-Cleve their Speaker.

The House adjourned till To-morrow Morning ten of the Clock.

*Wednesday, October 29, 1788.*

The House met.

Jonas Wade and John Condit, returned as two of the Representatives of the County of Essex ; Joseph Stillwell, returned as one of the Representatives of the County of Monmouth ; Benjamin Holme, returned as one of the Representatives of the County of Salem ; and Ellis Cook, returned as one of the Representatives of the County of Morris, attended, and produced the respective Certificates of their Election, which were read, approved and ordered to be filed ; whereupon, being duly sworn by the Speaker, they took their Seats, and having severally rendered to the House an Excuse for their Non-Attendance before,

*Resolved*, That the same is satisfactory.

*Ordered*, That Messrs. Blair, Combs and Stillwell, be a Committee to prepare and present a Bill for defraying incidental Charges.

*Ordered*, That Messrs. Davenport and Elmer be a Committee to inspect and correct the Minutes of the House.

*Ordered*, That Messrs. Rogers and Cook be a Committee to report such Business as was referred or left unfinished at the last Sitting.

A Petition from sundry Inhabitants of the Township of New-Brunswick, in the County of Middlesex, praying that a Law may be passed for the Preservation of the Fisheries in South River, was read, and ordered a second Reading.

A Petition from sundry Inhabitants of the County of Monmouth, praying that a Law may be passed to prevent the Destruction of Fish at the Mouth of Inlets of the Sea, was read, and ordered a second Reading.

A Petition from Samuel Dowdney, of the County of Cumberland, praying that a new Note may be given him for the Depreciation of his Pay while in the Service of the United States, in the Place of one which he had lost, was read, and ordered a second Reading.

The House adjourned to three o'Clock, P. M.

The House met.

John Benson and John Outwater, returned as two of the Representatives from

from the County of Bergen; Melancthon Freeman, returned as one of the Representatives of the County of Middlesex; John Starke, returned as one of the Representatives from the County of Morris; Robert Taylor, returned as one of the Representatives of the County of Hunterdon; and Christopher Longstreet, returned as one of the Representatives from the County of Suffex, attending, the respective Certificates of their Election were read, approved and ordered to be filed; whereupon, being duly sworn by the Speaker, they took their Seats in the House, and having rendered an Excuse for their Non-Attendance before this Time,

*Resolved*, That the same is satisfactory.

Mr. Nicoll reported, that he had obeyed the Order of the House.

Several Petitions from sundry Inhabitants of the County of Hunterdon were read, setting forth certain illegal Proceedings had at the late annual Election in said County, and praying that they may be heard before the House to establish the Facts set forth in their Petitions; whereupon,

*Ordered*, That the Petitioners have Leave to appear before the House on Tuesday the fourth Day of November next, at nine o'Clock in the Forenoon, with their Evidences to support the Facts set forth in their said Petitions; and that they serve the Judge and Inspectors of the Election with a Copy of this Order two Days previous thereto.

A Message from the Council by Mr. Haring.

 ' **T**HAT Mr. Haring do wait on the House of Assembly, and acquaint them  
 ' that a Quorum of the Council have this Day met, elected the Honour-

The House adjourned till To-morrow Morning nine of the Clock.

*Thursday, October 30, 1788.*

The House met.

*Ordered*, That Mr. Outwater do wait on the Council, and inform them that the House are ready to go into a Joint-Meeting, to appoint a Governor and other Officers of the State, and do desire that Council will appoint the Time and Place of Meeting.

Mr. Outwater reported, that he had obeyed the Order of the House.

James Schureman, Esquire, returned as one of the Representatives of the County of Middlesex, attended, and produced the Certificate of his Election, which was read, approved, and ordered to be filed; whereupon, being duly sworn by the Speaker, he took his Seat in the House, and having rendered to the House an Excuse for his Non-Attendance before this Time,

*Resolved*, That the same is satisfactory.

Mr. Rogers, from the Committee appointed to examine what unfinished Business was referred from the last Sitting, brought in a Report in the following Words:

1. **T**HE Representation and Petition from sundry Inhabitants of the Townships of Evesham, Chester and Waterford, in the Counties of Burlington and Gloucester, setting forth the baneful Consequences of the too frequent Use of spiritous Liquors, and desiring that Shopkeepers may not be permitted to retail them without License; also that a heavy Excise may be laid on Rum, &c.

2. The

2. The Petition from fundry Inhabitants of the County of Essex, and Township of Newark, praying that a Law may pass to raise an uniform volunteer Company at Orange Dale in said Township, and a Petition from the Militia Officers of said Place in Opposition thereto.

3. The Petition from Hunterdon County, praying some Alterations may be made in the Law for regulating the Fisheries in the River Delaware.

4. The Requisition of Congress for the Year 1788.

5. The Bill, intituled, 'An Act to repeal certain Parts of the Act, intituled, 'An Act for raising a Revenue from certain Stages, Ferries and Taverns,' as also the Supplement thereto.

6. The Petitions from fundry Inhabitants of Cumberland County, praying that the Election Law may be altered so that the Votes in that County may be taken by Ballot instead of viva Voce.

7. The Bill, intituled, 'An Act for incorporating a Seminary for the Education of Youth in New-Barbados, in the County of Bergen, by the Name of 'the Federal Academy of the County of Bergen;' and a Petition and Remonstrance of the Board of Trustees of Queen's College, in New-Jersey, in Opposition to the Passing of the same.

8. The Bill, intituled, 'An Act for the more easy Partition of Lands held by 'Co-Parceners, Joint-Tenants and Tenants in Common, and for the more 'effectually preventing the Waste of Timber on the same.'

9. The Bill, intituled, 'An Act to legalize the Proceedings of the chosen 'Freeholders, together with one of the Judges of the several Counties within 'the State, at their usual and stated Meetings, Adjournments, or when called 'together by the Justices, for any publick Purposes without the Attendance of 'the said Justices.'

10. The Bill, intituled, 'An Act to erect the upper Part of the County of 'Hunterdon, and the lower Part of the County of Suffex, into a separate 'County, to be called the County of Independence, and for building a Court- 'house and Gaol in the said County, and also for annexing the Township of 'Nottingham to the County of Hunterdon, with the several Petitions respect- 'ing the same.'

11. The Petition from the County of Burlington, praying that a Law may be passed for the Preservation of Cranberries.

12. The Bill, intituled, 'An Act to encourage the Raising and Keeping of Ox- 'en for Draught, and to discourage the Keeping a superfluous Number of 'Horses in this State.'

13. The Petition from the Owners and Possessors of Meadows in Penn's-Neck, in the County of Salem, praying an Alteration to the Law passed for the better Improvement of their Meadow.

14. The Petition from a Number of Persons Inhabitants of Trenton, praying a Law may be passed to annex them as an Infantry Company to the first Regiment of the County of Hunterdon, and that they may not be obliged to attend Duty in the Militia Company of the said Town.

15. 22. The Petition of Daniel Smith, of the County of Bergen, praying a Law may pass to direct a Road opened, according to a Return made of a Road on Bergen Point, leading to Kill Van Kull, along Newark Bay.

23. The Bill, intituled, ' An Act to amend an Act, intituled, An Act for regulating and shortening the Proceedings in the Courts of Law.'

24. The Petition from sundry Inhabitants of the Township of Oxford, in the County of Suffex, setting forth the Difficulty of collecting Money from Officers who have been delinquent in paying forward the same for Taxes, and praying that a Law may be passed to authorize the Sheriff to sell Lands, and give a good and sufficient Title, on Warrants issued by the Chief-Justice for the Arrearages of Taxes.

The foregoing Papers were referred from the last Sitting to this Session.

The following Papers were ordered a second Reading.

1. ' An Act to raise a Revenue from certain Offices, Professions and Occupations.'

2. ' An Act for vesting the Residue of the confiscated personal Property of John I. Zabriskie, of the County of Bergen, in certain Persons, for the Use of the said John I. Zabriskie, on the Conditions therein mentioned.'

3. A Petition from Cornelius Hennion, of the County of Bergen, setting forth, that, while he was a Captain in the Army of the United States, he was wounded; that in Consequence thereof he was allowed a Pension amounting to one Quarter of his Pay; and praying that the same may be augmented to Half-pay.

4. The Petition from sundry Inhabitants of the County of Monmouth, setting forth Abuses in the issuing and Proceedings on Certioraries, and praying the Attention of the Legislature thereto.

**T**HAT they have examined the Account of the said Dunham, as Signer of the Convention Money, with the Vouchers in Support of the same, from No. 1 to 15: That Voucher, No. 13, is for £. 324, Continental Money: That Voucher, No. 14, for £. 868 16 0 does not express what Species of Money, nor does either of them express on what Account: They further find, that Voucher, No. 15, dated November 17, 1780, is for £. 1113 15 0 Convention Money, signed only by Hendrick Fisher, and paid to John Stevens, jun. late Treasurer: That the Vouchers, No. 1 to 14, inclusive, amount to £. 24,253 19, Money paid to John Dennis, late Treasurer of the Convention, whose Accounts are at present unsettled, but which, in the Opinion of your Committee, should be settled before the final Allowance of this Account of the said Dunham, to which End we are of Opinion that the said John Dennis be called on to settle his Accounts without Delay.

That they have also inspected the Accounts of the said Azariah Dunham as Superintendent of Purchases, according to which, admitting the Contractor’s Accounts to be all properly settled and allowed, there appears to be a Balance due to said Dunham, as Superintendent, of the Sum of £. 736 18 6 if the said Dunham is to account to the several Contractors for the Balances at the Foot of the said Account stated to be severally due to them, amounting to £. 1260 7 2. But it appearing to your Committee that Daniel Marsh, one

of

of the Contractors therein mentioned, has received his Money from the State, and not knowing whether others may not have received Certificates or been otherwise satisfied by the State, your Committee suggest the Propriety of charging the said Azariah Dunham with the above Sum £. 1260 7 2, and of directing the Treasurer to issue Certificates to the several Contractors for the Sums which shall respectively appear to be due to them, where it shall appear to him that the same has not been otherwise satisfied. Your Committee on this Account further observe, a Balance of £. 35,068 2 11 Continental Money appears by said Account in the Hands of the Superintendent, but are uninformed of the Reasons for calculating the Depreciation thereon so low as November 1, 1780.

That as to Mr. Dunham's Account of Purchases, for the Supply of the Troops on the Lines, this has been settled and allowed by the Assembly, as appears by the Minutes of the Sitting at Burlington in May 1787.

From this general View of the said Accounts your Committee are of Opinion, that no Order can safely be made on the several Balances stated to be due on them until further Information can be had relative to the above Particulars.
