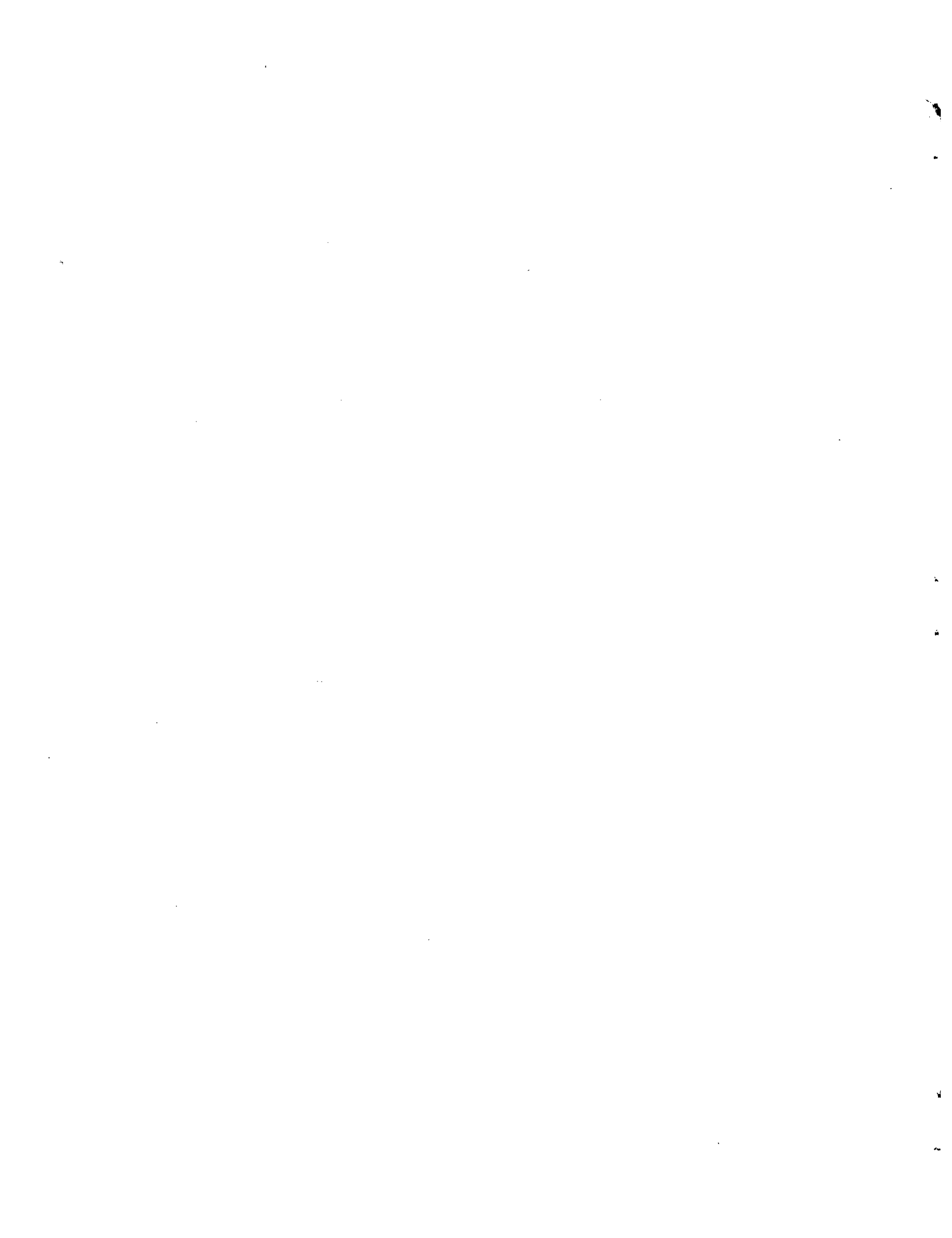

INTRODUCTION

THIS REPORT HAS BEEN DEVELOPED TO PROVIDE INFORMATION REGARDING SELECTED OFFENDER CHARACTERISTICS IN EACH CORRECTIONAL COMPLEX, MAJOR INSTITUTION AND SATELLITE HOUSING UNIT UNDER THE JURISDICTION OF THE NEW JERSEY DEPARTMENT OF CORRECTIONS ON AUGUST 4, 1982. MAINTENANCE OF COMPUTER FILES PRECLUDES THE USE OF JUNE 30, 1982 STATISTICS. THE SELECTED CHARACTERISTICS COMPILED IN THIS REPORT ARE BASE OFFENSE AT ADMISSION, TOTAL TERM AT ADMISSION, ETHNICITY, AGE, AND COUNTY OF COMMITMENT.

THE PRISON COMPLEX INCLUDES THE TRENTON, RAHWAY, LEESBURG, MID-STATE, AND CLINTON MEN FACILITIES. THE ADULT DIAGNOSTIC AND TREATMENT CENTER AND CLINTON WOMEN, ALTHOUGH A PART OF THE PRISON COMPLEX ARE COMBINED WITH THE JUVENILE TRAINING SCHOOLS WITHIN THE "OTHER INSTITUTIONS" REPORT.

THE YOUTH CORRECTIONAL COMPLEX CONSISTS OF THE YOUTH RECEPTION AND CORRECTION CENTER - YARDVILLE, THE YOUTH CORRECTIONAL INSTITUTION - BORDENTOWN, AND THE YOUTH CORRECTIONAL INSTITUTION - ANNANDALE. THE JUVENILE TRAINING SCHOOLS INCLUDE THE JAMESBURG TRAINING SCHOOL FOR BOYS AND THE SKILLMAN TRAINING SCHOOL FOR BOYS AND GIRLS.

OFFENDERS REPORTED IN COUNTY FACILITIES (PRISON AND YOUTH COMPLEX) ARE TRANSFERS FROM STATE INSTITUTIONS WHO ARE SERVING THEIR FINAL 2 TO 3 MONTHS AT THE LOCAL LEVEL. THESE FIGURES DO NOT INCLUDE STATE SENTENCED OFFENDERS HOUSED IN THE COUNTY JAILS WHO ARE AWAITING ENTRANCE INTO THE DEPARTMENT OF CORRECTIONS RECEPTION UNITS.

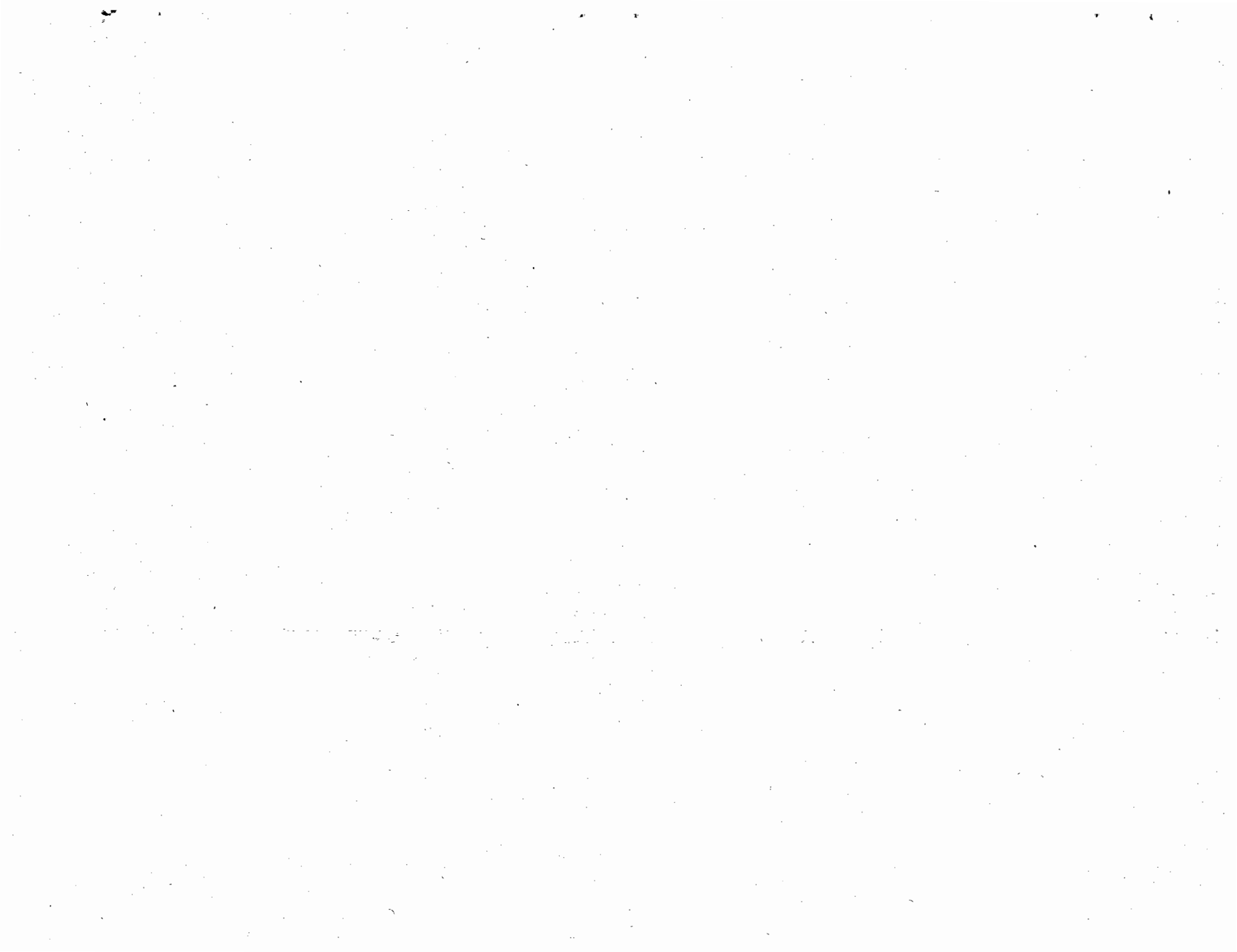
CURRENTLY THERE ARE APPROXIMATELY 1234 STATE SENTENCED OFFENDERS TEMPORARILY HOUSED IN COUNTY FACILITIES AWAITING TRANSFER INTO THE STATE PRISON SYSTEM. CHARACTERISTIC DATA ON THESE OFFENDERS IS NOT INCLUDED IN THIS REPORT. SIMILARLY, OFFENDERS HOUSED IN THE RECEPTION UNITS, HALFWAY HOUSES, AND RESIDENTIAL GROUP CENTERS ARE NOT REPORTED AS WELL.

HIGHLIGHTS

SEVENTY (70) PERCENT OR 3074 OUT OF 4418 OF ALL OFFENDERS IN THE PRISON COMPLEX WERE COMMITTED FOR CRIMES AGAINST PERSONS WHICH INCLUDE HOMICIDE, RAPE, ASSAULTS, ROBBERY, SODOMY, SEXUAL ABUSE AND OTHER PERSONS OFFENSES. SIXTY-THREE (63) PERCENT OR 5088 OUT OF 8082 OF ALL NEW JERSEY OFFENDERS WERE COMMITTED FOR CRIMES AGAINST PERSONS. THESE FIGURES DO NOT INCLUDE ADDITIONAL SENTENCES FOR CRIMES AGAINST PERSONS.

FORTY-EIGHT (48) PERCENT OR 3865 OUT OF 8082 OF ALL NEW JERSEY OFFENDERS WERE COMMITTED WITH A MAXIMUM STATUTORY SENTENCE OF 10 YEARS OR MORE. OF THESE 542 OFFENDERS OR 7% ARE SERVING LIFE SENTENCES.

SIXTY (60) PERCENT OF NEW JERSEY'S OFFENDERS POPULATION IS BLACK, WHILE 27% ARE WHITE AND 12% ARE HISPANIC.

SIXTY-FIVE (65) PERCENT OF ALL OFFENDERS IN THE NEW JERSEY DEPARTMENT OF CORRECTIONS ARE UNDER 29 YEARS OF AGE.

OF THE 21 NEW JERSEY COUNTIES, FIVE COUNTIES, ESSEX, PASSAIC, CAMDEN, MONMOUTH, AND UNION REPRESENT MORE THAN HALF (56%) OF THE TOTAL STATE CORRECTIONAL COMMITMENTS. ESSEX COUNTY IS THE HIGHEST CONTRIBUTOR WITH NINETEEN (19) PERCENT.

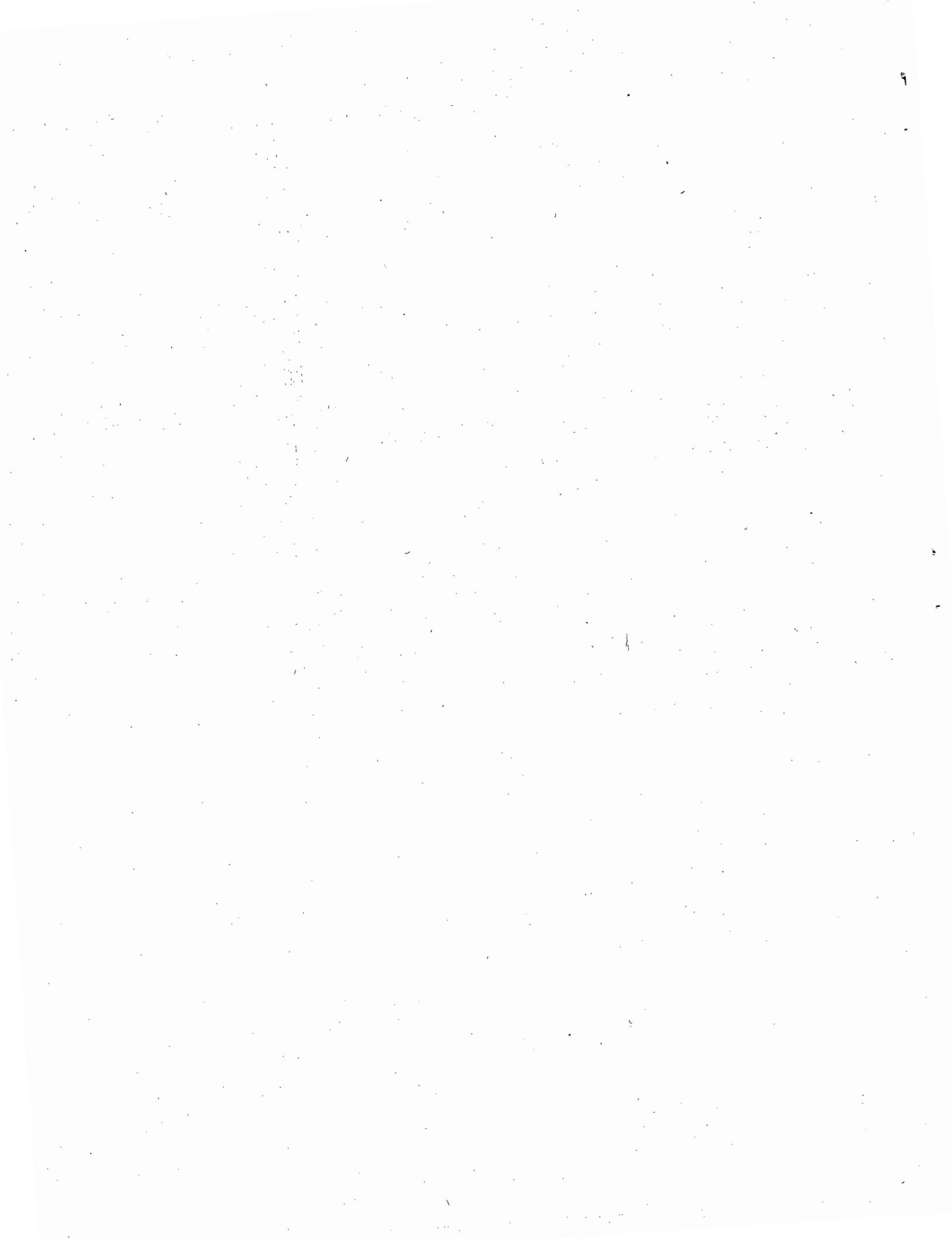

IN THESE TABULATIONS, THE BASE OFFENSE FOR AN OFFENDER IS THAT OFFENSE WHICH CARRIES THE LONGEST TERM AT THE TIME OF ADMISSION.

VIOLENT CRIMES INCLUDE MURDER AND NON NEGLIGENT MANSLAUGHTER; RAPE; ASSAULTS AND ATROCIOUS ASSAULTS; ROBBERY, AND SEXUAL OFFENSES, I.E. INCEST, CRANAL ABUSE, SODOMY, IMPAIRING THE MORALS OF A MINOR, AND ASSAULT WITH INTENT TO COMMIT CARNAL ABUSE.

OTHER PERSONS OFFENSES INCLUDE NEGLIGENT MANSLAUGHTER; INDECENT EXPOSURE; LEWDNESS; SEDUCTION; ATTEMPTED SEX OFFENSES, AND WEAPON OFFENSES.

PROPERTY OFFENSES INCLUDE BREAKING AND ENTERING; LARCENY; FORGERY; EMBEZZLEMENT; AUTO THEFT; AND RECEIVING OR POSSESSING STOLEN PROPERTY.

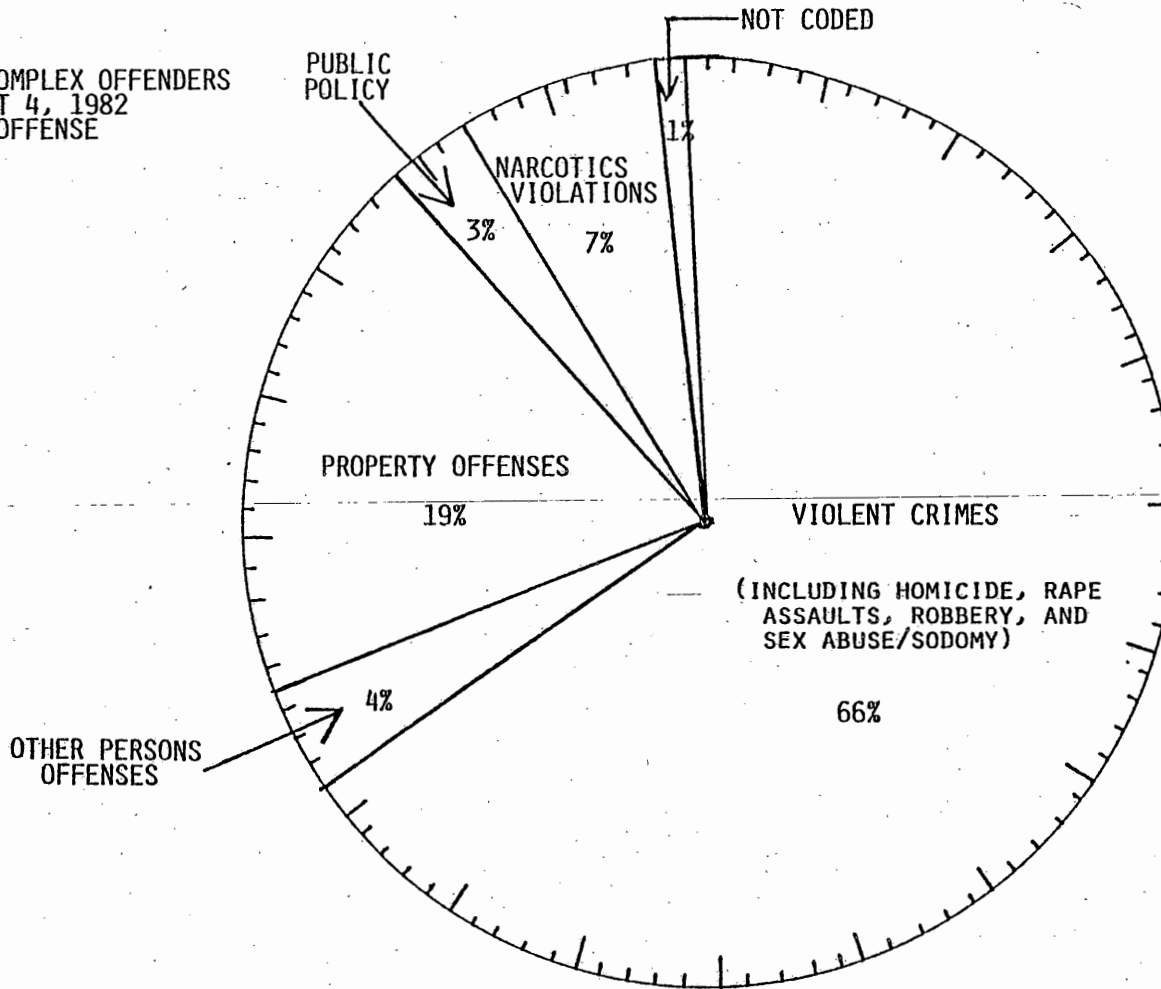
PUBLIC POLICY OFFENSES INCLUDE PROSTITUTION; GAMBLING; JUVENILE OR FAMILY RELATED OFFENSES; AND OTHER OFFENSES INCLUDING ARSON, CONSPIRACY, AND VANDALISM.

"NOT CODED" ARE RECORDS ON OFFENDERS IN THE CORRECTIONAL SYSTEM IN WHICH ADMISSION CHARACTERISTIC DATA HAS NOT BEEN ENTERED INTO THE COMPUTERIZED INFORMATION SYSTEM AS OF THE ABOVE DATE. ALSO NOTE THAT 408 PRISON AND YOUTH RECEPTION INMATES AND OFFENDERS RESIDENT IN REISIDENTIAL GROUP CENTERS AND COMMUNITY TREATMENT CENTERS ARE NOT INCLUDED IN THESE TABULATIONS.

 SKILLMAN - BOYS



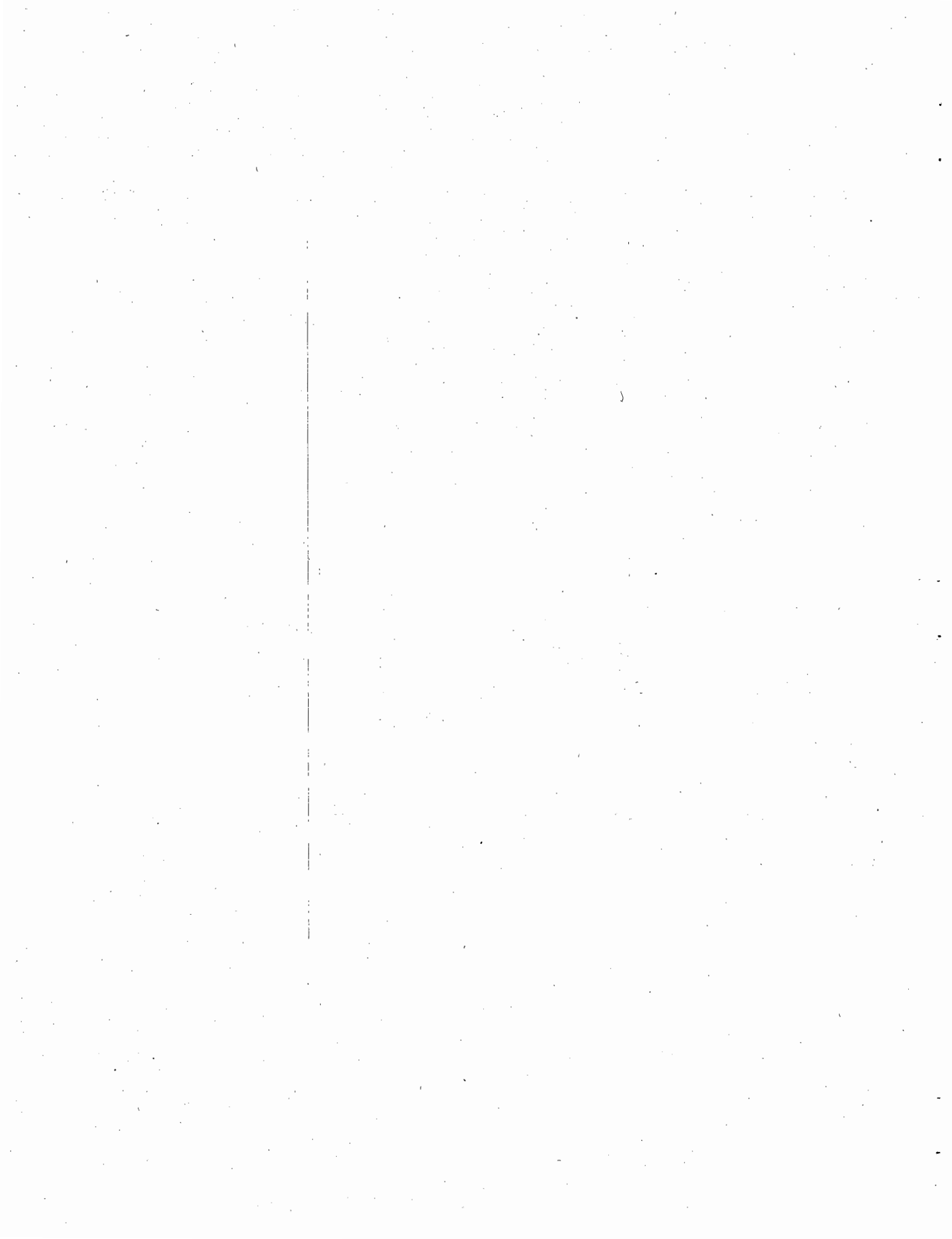

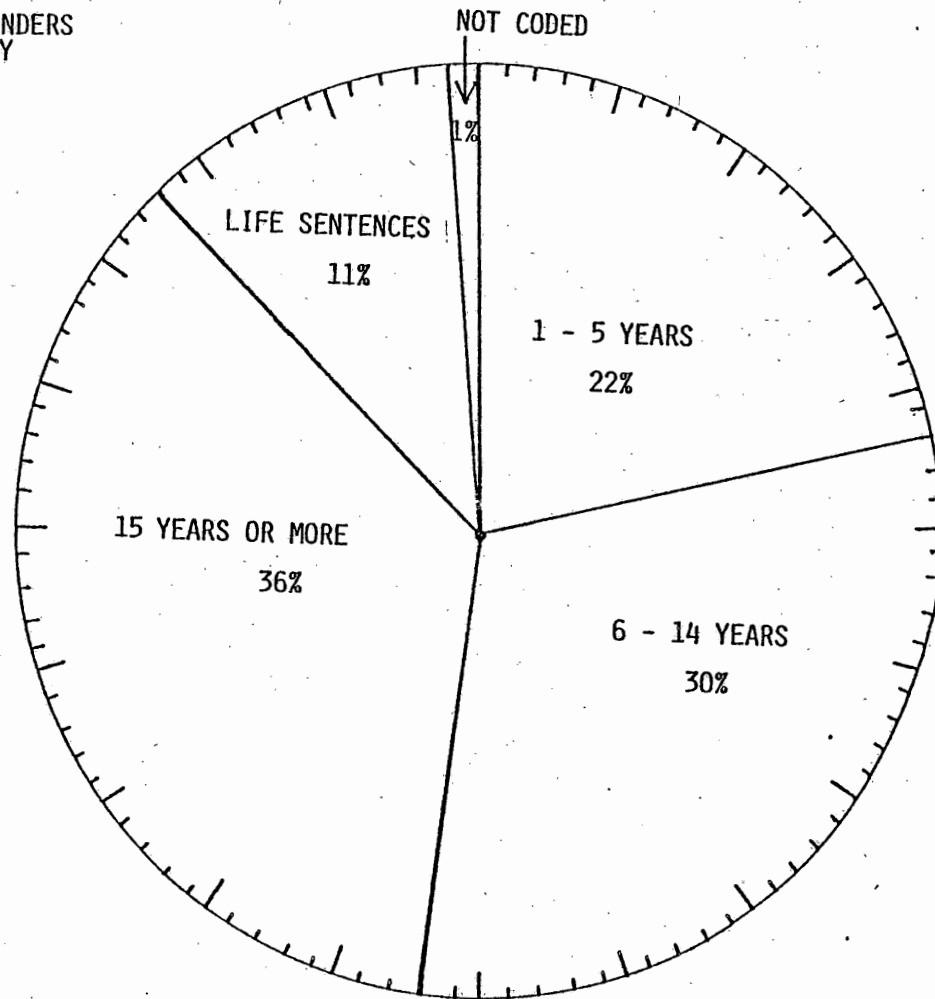

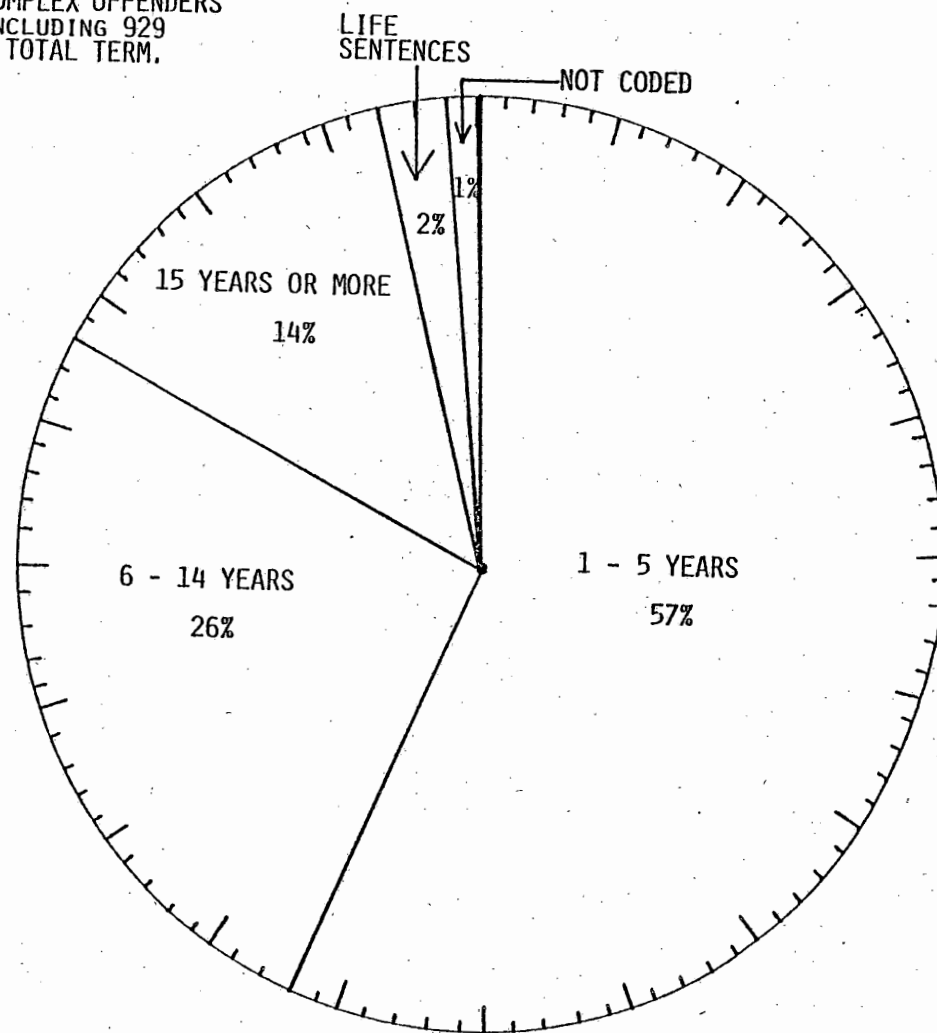

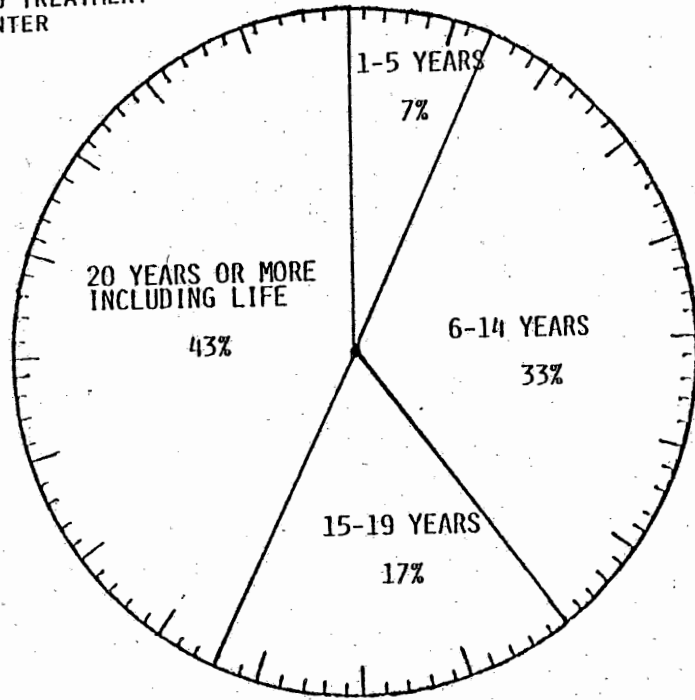

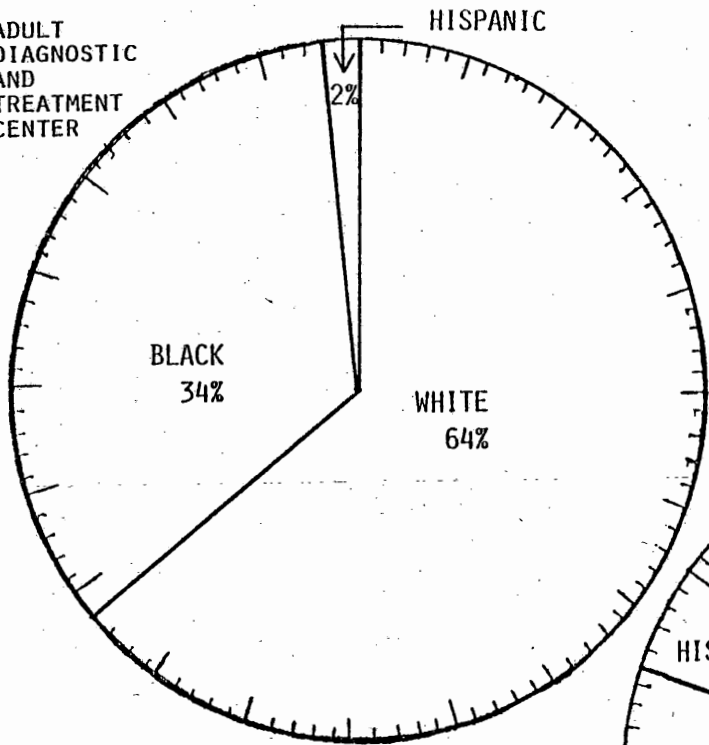

BY AGE GROUPS



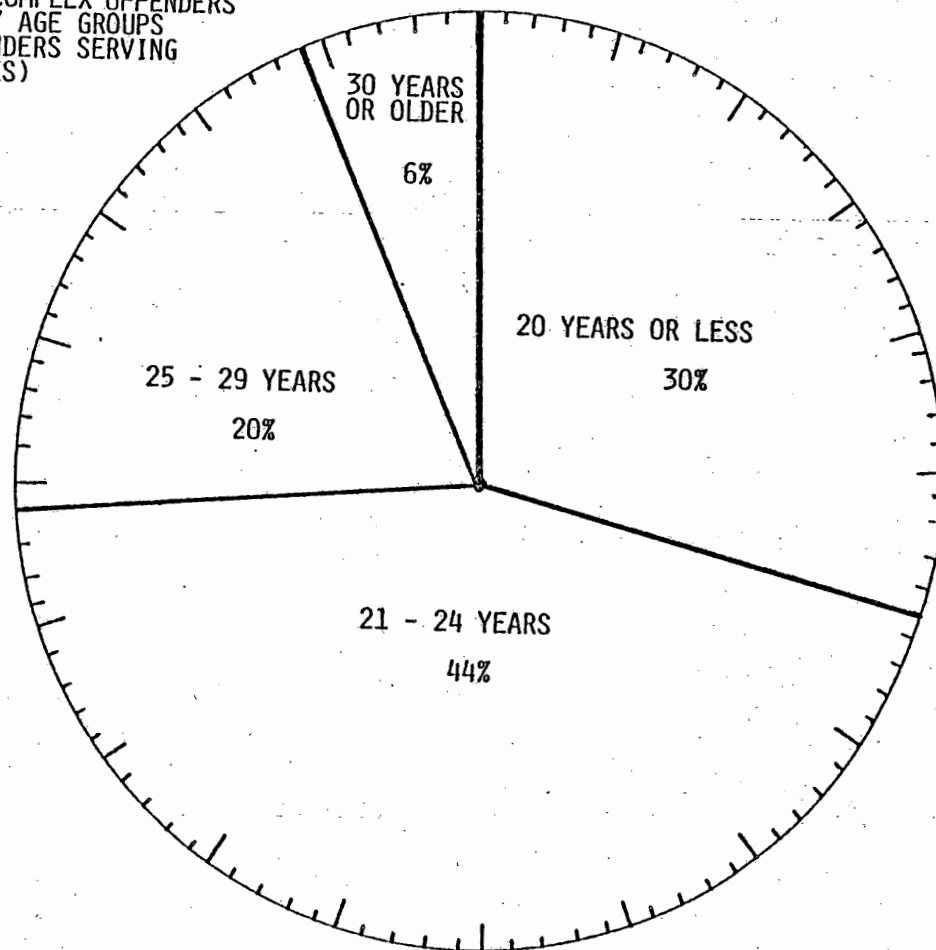

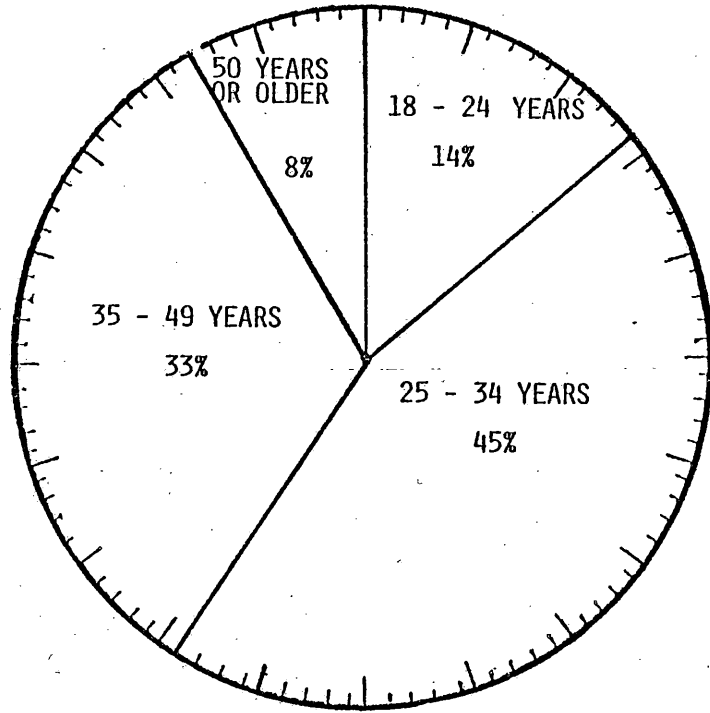

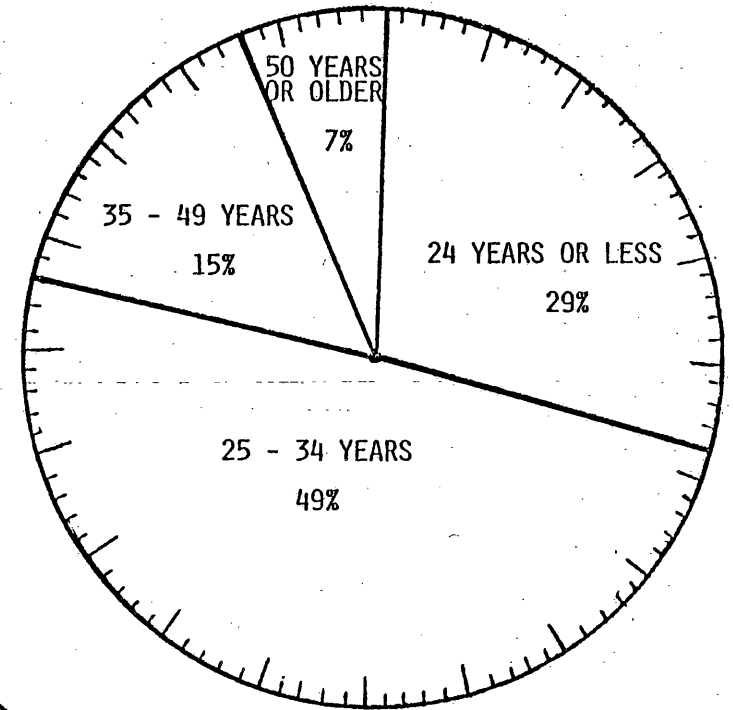

BY AGE

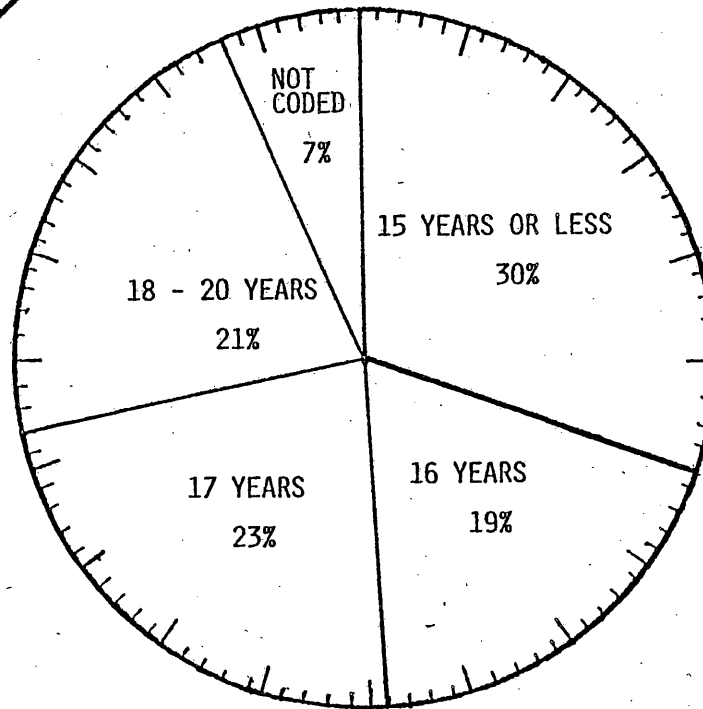

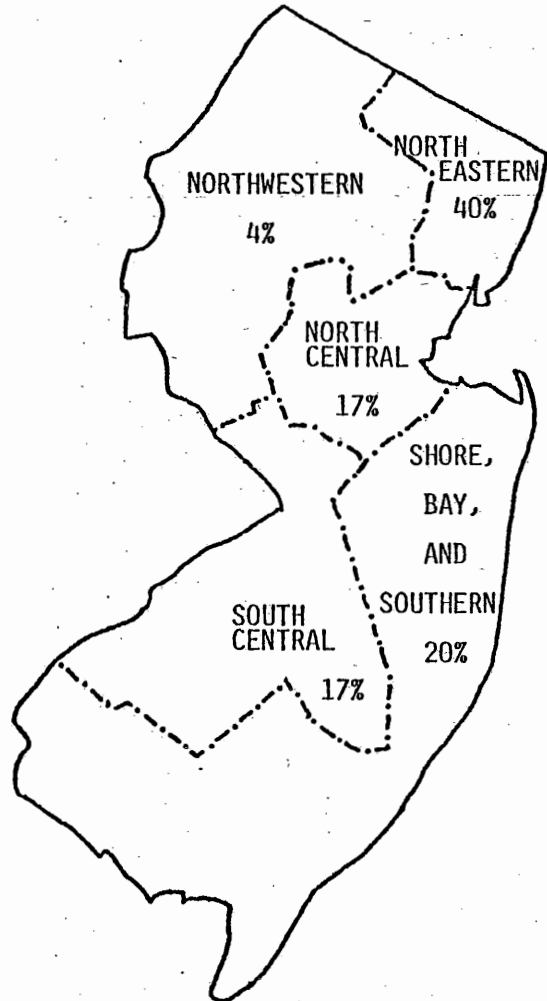

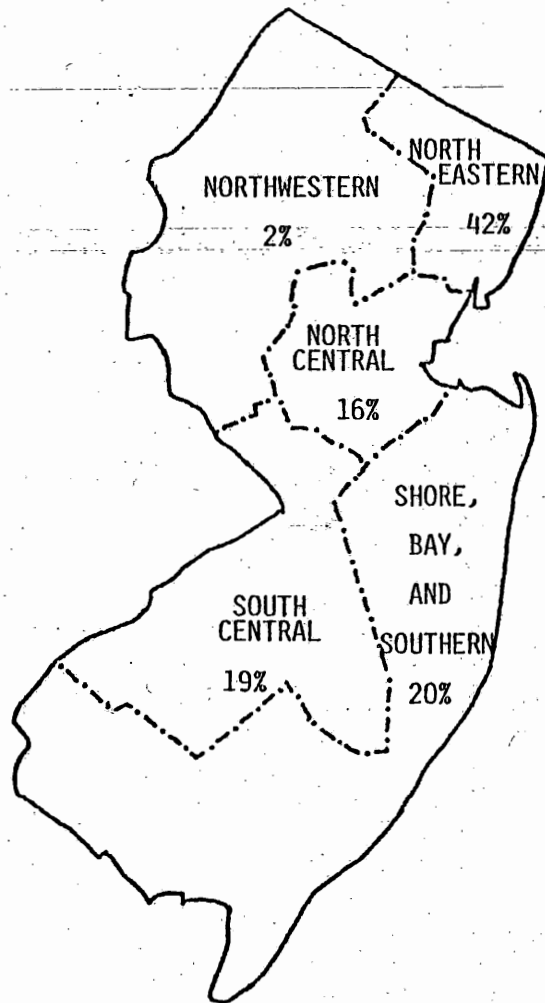

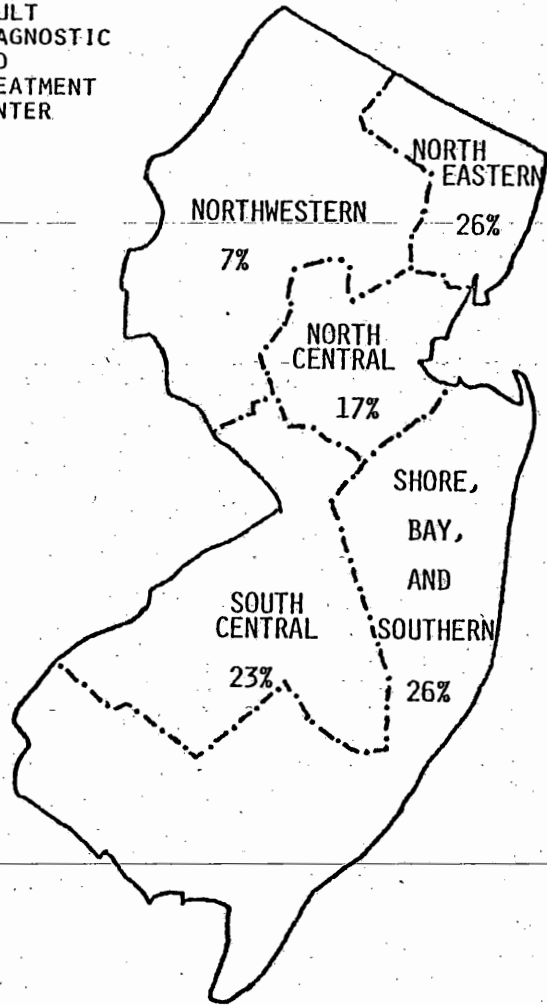

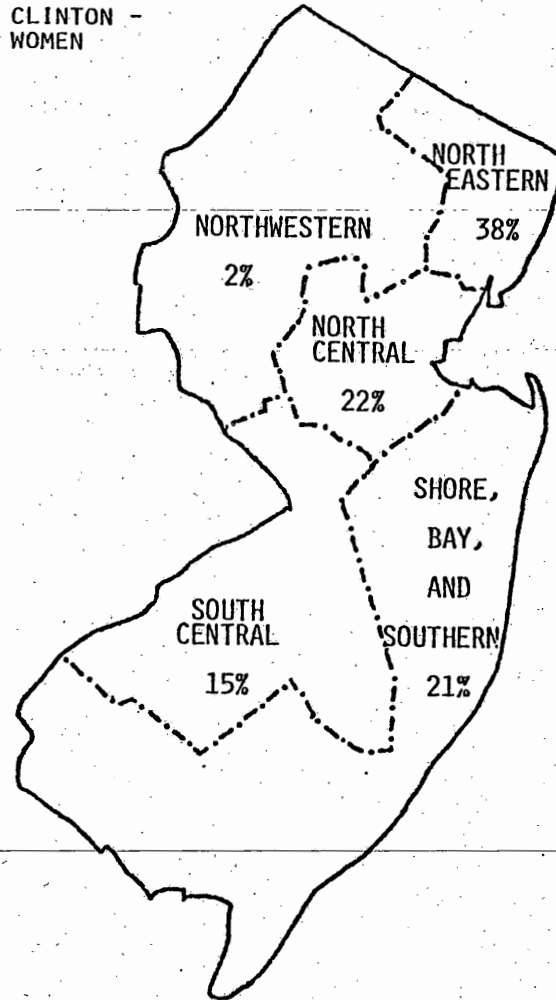

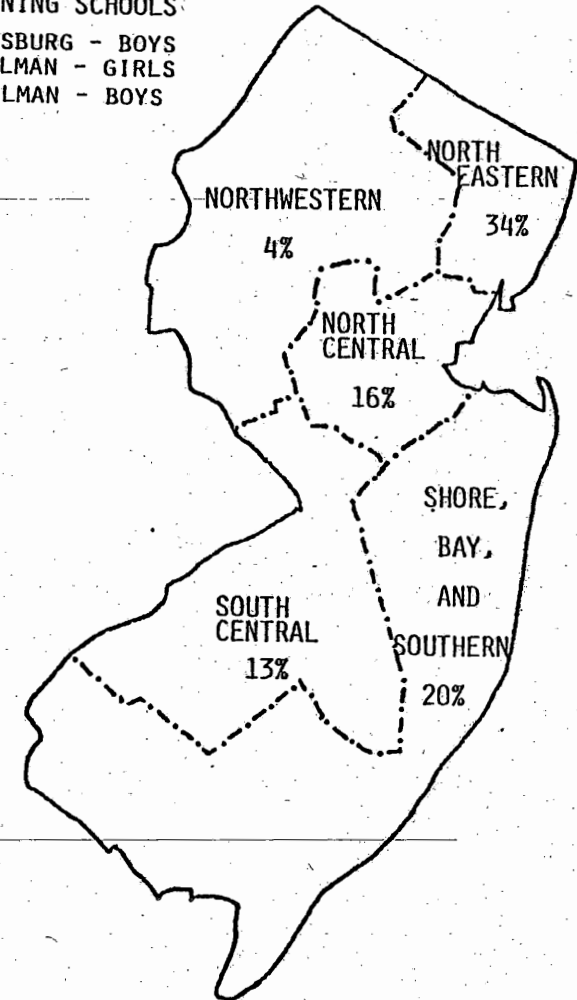
