After discussion, the Secretary was authorized to arrange for both the regular Institutes, and the Railroad Educational Train work, if possible.

Hotel for Annual Meeting was referred to the Secretary.

The matter of the importation of cattle from surrounding States was discussed and the need of a stricter law controlling this matter favored.

Various other matters connected with the needs and progress of the Board were discussed, then at 1:30 P.M. adjourned to meet at 2:00 P.M. January 30, 1911.

In reference to New Jersey making an exhibit at the American Land and Irrigation Exposition to be held at Madison Square Garden, Nov. 3-12, 1911, it was unanimously decided on motion of Mr. DeCamp, that the Executive Committee do not deem it advisable to ask the Legislature for an appropriation to make an exhibit at the said Exposition.

The Secretary presented the American Newspaper Annual and Directory to the attention of the Committee, suggesting that it


would be a good thing to have, if they would approve of it. On motion, the Secretary was authorized to purchase such book.

Dr.Smith being present by invitation of the Secretary, requested the appointment of a Committee of Appeal in Cases where orchards, nurseries or trees have been condemned by the State Entomologist and the parties feel aggrieved. The following were suggested for said Committee; Franklin Dye, Elias Black, Little Silver; Albert T.Repp, Glassboro. At this point President Frelinghuysen arrived and assumed the chair. Dr.Smith also requested the appointment of a temporary Inspector from March 1st to Sept.30th, at \$83.33 per month.His reason as stated being the invasion of the State by the Brown tailed and Gypsy moths, and the necessity for preventing their spread here and for foreign inspections. (See letter.) On motion of Mr.DeCamp the request was granted. The President then appointed the Secretary and Messrs. Black and Repp as the Committee of Appeal.

As to compensation to Mr.Sweeney, Dr.Lipman and Prof.Lewis for their Lectures at Annual Meeting, on motion of Mr.DeCamp, Mr.Lipman to receive \$15. and Mr.Lewis \$10. On motion of Mr.Lippincott, Mr.Sweeney to receive \$10. All adopted.

After discussion relating to the advancement of the work of the Board through the local organizations, the Committee adjourned at 6:30 to call of chair.

The Executive Committee convened at 2:30 P.M. in the office of the Secretary.

Present:- President, Jos. S. Frelinghuysen in the chair, Messrs. Cox, Rider, DeCamp, Lippincott, Brown and the Secretary -- all the members.

Minutes of meeting of April 11th were read and approved as read. The Secretary reported he had not purchased the American Newspaper Annual, as upon further examination it did not seem to be of as much value as represented.

By previous arrangement, there was a hearing on the question of selecting a Plant Pathologist for the State, at which Dr. John B. Smith, State Entomologist, and Mr. Alfred Gaskill, State Forester, were invited to be present and present their views.

Mr. Gaskill gave several reasons why the State should have a Plant Pathologist, -as the chestnut tree blight, the threatened disease of the white potato, and a disease of the white pine, now discovered in Morris County. As to a suitable person for the position, Mr. Gaskill and Dr. Smith have been in touch with the United States Department of Agriculture, seeking such a man and recommend Prof. Perley Spaulding, of said Department. The question of salary was discussed and it was thought \$1,800. per year should be the minimum. Thereupon Dr. Smith stated he had conferred with the Directors of the Experiment Station and the President of the College, and they are willing to provide a place for the Plant Pathologist and to cooperate with this Board in securing a capable man by giving him some teaching work at the College when not engaged in the duties of Plant Pathologist, thus supplementing the salary paid by the Board. Both gentlemen stated that men prepared for this work are

scarce. Dr. Smith presented also the question of the appointment of a deputy to assist in the work of Bee Inspection, as provided for in Chapter 60, Laws of 1911, requesting that when he is appointed he be an assistant to the State Entomologist in other work when not engaged in the Bee inspection duties.

The Executive Committee then discussed the powers given them in relation to the appointment of Plant Pathologist as provided for in Chapter 54, Laws of 1911, and the appointment of a deputy to the State Entomologist under Chapter 60, Laws of 1911, and requested the Secretary to ask the opinion of the Attorney-General as to whether either or both of these officials when appointed can legally take up any work connected with the State Agricultural College, as teacher or otherwise, providing they or either of them have time for such additional work and the college pays for same. It was also decided that the Secretary ask Chief Examiner Colby of the Civil Service Commission to announce an examination for Plant Pathologist, and for a deputy for State Entomologist under the Bee Inspection Law.

The request of Miss Gussie Johnson, Stenographer and Clerk of the Board, for an increase in her salary for the State Board of Agriculture work, from \$30. to \$45. per month, owing to the increased requirements of this Department, was on motion of Mr. DeCamp granted, to take effect May 1st, 1911.

The Secretary was instructed by a unanimous vote to ask the State House Commission in the name of the Executive Committee, for more and sufficient office room, for this Board.

Then at 4:00 P.M. adjourned to call of the President.

On invitation by the Secretary, Dr. Lipman was present and presented his suggestion that the Foreigners at Hammonton or Vineland be given a course of agricultural lectures in their own tongue. The matter was referred to the Institute Committee to arrange. Dr. Lipman also suggested that a number of the old bulletins of the Experiment Station be reprinted and revised up to date. He stated there were two or three very valuable ones which should be republished as there was constant demand for such information as they contained. That the Experiment Station have no funds now available for this work, and requested that if our Board could do so, it would be an advisable thing to issue another edition of these bulletins.

He said he would revise the same for this purpose. The Committee decided that if we had the funds, to publish the same as suggested, during this year, or the early part of the next fiscal year.

At 3:20 meeting adjourned to call of the chair.



Dr. Cook read a report of his attendance as delegate to the Chestnut Tree Blight Commission conference held at Harrisburg, Pa., which report was ordered to be made a part of the minutes.

Mr. Rider moved, Mr. Brown seconded that Mr. E. ^{L.}R. Dickerson be made assistant to the Plant Pathologist for two months during summer at a salary of \$100. per month, Mr. Dickerson to devote his entire energy to Plant Pathologist inspection work. Carried.

It was moved and seconded that Dr. Cook be allowed to expend \$500. for supplies, subject to approval of memorandum of such to be sent to Secretary State Board of Agriculture.

Mr. Rider moved, Mr. Cox seconded that \$100. be allowed from the funds of the State Board of Agriculture, to be spent for the purchase of lantern slides to illustrate lectures of the Plant Pathologist to be delivered at our Farmers' Institutes.

The Executive Committee met in the office of the Secretary May 10th. Present: President Frelinghuysen in the chair, Messrs. De Camp, Rider, Brown, Darnell, Cox and the Secretary. Dr Lipman and Dr. Davis from the Experiment Station were also present.

The reading of the minutes of May 2d was dispensed with until next regular meeting of the Committee .

The question was discussed as to whether the State Board of Agriculture could cooperate with the State Board of Education in having a Summer School of Agriculture for Teachers at the State Agricultural College at New Brunswick. Mr. Rider moved that \$2,500. be expended from the funds appropriated to the State Board of Agriculture for the purpose of establishing an educational system for the instruction of teachers, including lectures and other educational advantages at the

Agricultural Experiment Station at Rutgers under the direction of Dr. J. G. Lipman, subject to approval of the Executive Committee of the State Board of Agriculture. Seconded and carried. This motion was made with the proviso that the Attorney General give his opinion as to whether this sum may be used from our appropriation in this manner.

Moved and seconded that for this year at least, this education shall be given for Normal School graduates and teachers now teaching or under contract to teach in the agricultural sections of the State. Carried.

Moved and seconded that the enrollment for the course shall be first to teachers in the rural districts, then to Normal School graduates and to any other one that may apply, provided facilities can be provided for their instruction.

Moved by Mr. Rider, seconded by Mr. Brown that Dr. Lipman, Vice-President Cox and Secretary Dye interview Mr. Gaskill concerning the validity of this action. Carried.

It was also moved and seconded that Dr. Lipman, Mr. Rider, and Secretary Dye interview the Comptroller as to whether he will approve bills rendered in this transaction. Carried.

The Committee immediately waited on the Comptroller and after presenting the question he requested that the Executive Committee write him a letter stating our request and he would submit his reply in writing. The Committee reported the Comptroller's decision at once, whereupon Mr. Rider moved that the President of the State Board of Agriculture write the Comptroller in reference to the approving of funds used from the regular appropriation to provide a teachers' course at the Agricultural College. Seconded and Carried.

The following letter was dictated by President Frelinghuysen after which the Committee on motion adjourned to call of President. -

Dear Sir:-

At a recent meeting of the State Board of Education, Mr. Rice and Dr. Van Dyke introduced a resolution calling for an appropriation of \$2,500. from the funds of the Department of Instruction for the purpose of establishing a teachers' course in Agriculture at the Agricultural Experiment Station. It met with immediate approval not only of the Commissioner of Education, but also of all the members of the State Board of Education, inasmuch as it has been a universal demand all over the State for instruction in our public schools in agriculture. It was understood in the State Board of Education, however, that the appropriations to the Department of Instruction are made to definite purposes and that no appropriation was available. As President of the State Board of Agriculture I called the attention of the Board of Education to the fact that the State appropriated for expenditure by the Executive Committee of the State Board of Agriculture, a certain sum each year for lectures and general educational work in Agriculture, throughout the State, and I felt that the law contemplated the use of these funds for all agricultural instruction, and it was within our province to use this money not only for lectures to the farmers, but also in preparing the teachers of our Public Schools to teach agricultural subjects, under authority of the Act approved March 31st, 1890 on Page 9, Section 3 of the General Statutes of New Jersey, Volume I, which reads as follows:-

"That in order to collect and disseminate reliable and useful information, and to encourage a higher standard in the agriculture and horticulture of the State, the Executive Committee are hereby authorized to cause to be made experimental and practical tests of specific remedies or cures of diseases of domestic animals and poultry, and of plants, vegetables and fruits, and insects injurious thereto, and to employ suitable persons to lecture before the state board of agriculture at its annual or other meetings, and in the counties of the state as far as the sum herein appropriated will allow."

After conferring with the Attorney-General who informs us that we are within the limits of the law, we have passed a resolution approving the plan, and designate a certain sum of money to establish a series of summer lectures and demonstrations at the College Farm, and now ask for your approval and consent that the money may be expended from our appropriation for the purpose named.

It may be of interest to you to know that the State Board of Education has not hitherto asked for any appropriation of this kind, but will no doubt do so later on.

The Executive Committee of the State Board of Agriculture met at the State College Farm at 2 o'clock P.M. Present all the members, President Frelinghuysen in the chair.

Minutes of meetings of May 2d and 10th were approved without reading.

Acceding to the request of Prof. Mel. T. Cook, State Plant Pathologist, for an assistant in his work, the Committee appointed Mr. Carl A. Schwarz to the position at a salary of \$1,000. per year. The appointment being subject to a Civil Service examination to be held later.

Attention was called to the next meeting of the American Association of Farmers' Institute Workers and that New Jersey should send delegate representatives to it, whereupon motion was made and carried that three delegates be appointed to attend the Convention, place of meeting to be announced later. The President appointed the following: Secretary Franklin Dye, Vice-President Cox and Mr. W. H. Ingling. Later Mr. Theodore Brown was added to the delegates.

The Secretary requested a committee be appointed to select speakers and arrange topics for the next Annual Meeting and for the Farmers' Institutes. The Secretary, President and Treasurer were elected said Committee.

The Secretary reported his interview with Col. Reading relating to the use of the 2d Regiment Armory, Trenton, for the next Annual Meeting of the Board, and suggested that the President confer with the Governor in regard to the use of the Armory. The President agreed to do so, and requested that the Secretary write him a letter reminding him about it. A discussion as to what exhibits should be made at that time

with suggestions, was also made.

Concerning a resolution adopted at the last Annual Meeting favoring Parcels Post, copy of which was sent to our Senators and Congressmen, asking whether they will or will not favor such a measure, yes or no, a letter from Senator Briggs was read by the Secretary and a motion was made and carried that all replies from our Senators and Congressmen in regard to this matter be published in the papers. The Secretary reported that Congreeman Gardiner had not replied.

As to a Field Day in South Jersey a letter from Mr. Pincus regarding this was discussed by Dr. Lipman. Motion was made that a committee be appointed to arrange for such a meeting during the month of August, at a place agreed upon by the Committee, for the purpose of instructing the Italians and Jews in their own languages upon the subject of agriculture. Motion carried. The following Committee was appointed: Secretary Dye, Mr. Rider and Mr. Darnell with Dr. Lipman to act in advisory capacity. It was decided to have one meeting and three speakers, one to speak in English, one in Yiddish and one in Italian.

Motion was made and carried that Dr. M.T. Cook's request for a typewriter machine and desk be granted.

Motion was also made and carried to accept the lower of the two bids for supplies for Prof. Cook's use, one amounting to \$314.17 and one for \$295.00. Then at 3 P.M. upon motion the meeting adjourned.






Reorganization of the State Board was discussed and deferred, there being but one member of the Committee present - Mr. Walter S. Haines.


tion Commission to be held soon, and then to be considered at the next meeting of the Executive Committee.

Present: President Frelinghuysen in the chair, Messrs. Cox, Rider, Brown, Darnell, DeCamp and the Secretary. Dr. Mel.T.Cook, Prof. Alva Agee and Dr. J. G. Lipman were also present by invitation.

Minutes of meeting of April 2d were read and approved as read.

Minutes of Joint Meeting of the Executive Committees of the State Board of Agriculture, the State Horticultural Society and the State Grange were read and accepted.

Dr. Cook presented a request to have Mr. E.A. Dickerson as Assistant in work of the Plant Pathologist for the months of July and August, at a salary of \$100. per month. Mr. DeCamp moved that Mr. Dickerson be appointed as such Assistant for the months named. Seconded and carried.

Dr. Cook presented the question as to whether he had the authority under the law to destroy shipments or parts of shipments found to be diseased with crown gall. Dr. Cook made a brief statement concerning the amount of crown gall he had found of late, that he had destroyed a shipment of 2500 trees from Europe, 60 out of 300 in another shipment. The next lot destroyed the owner made a protest, which occasioned the question being brought up for action. Dr. Cook stated that there is evidence that this is an infectious disease. President Frelinghuysen suggested that Dr. Cook get all the facts concerning a case in Colorado which he cited, also their law, and all the facts in the case in which the protest was made here, and present same to our Attorney General for an opinion, as to whether he had the authority to destroy stock affected with Crown Gall. Until that time to go ahead as before.

Prof. Agee presented the question as to an adjustment of the methods as to the payment of his salary which is \$100. per month. After a discus-

sion of the subject it was moved and seconded that Prof. Agee should render a bill for his services as Institute Director and Lecturer and for arranging for Farmers' Institutes, not to exceed \$100. per month, for such services, each month.

Dr. Lipman presented the subject of Farmers' Week Program, and a committee comprising of the President, Secretary and Prof. Agee was appointed to arrange program for Farmers' Week.

Dr. Lipman brought up the matter as to the status of the men employed in Extension Work Department who are to be used as Institute Lecturers. After discussion it was decided that the State Experiment Station will furnish the State Board of Agriculture five men now in Extension Work to lecture free at Farmers' Institutes, which Prof. Agee may arrange for.

The Secretary reported that Dr. Mel. T. Cook would report on the subject of Crown Gall which was discussed at last meeting, at the next meeting of the Committee.

Col. Reading's letter concerning the rental of the Armory for meeting of State Board in December, was read and ordered to be placed on file.

A letter from Mrs. A.H.Reeve, President of the N.J.Congress of Mothers was read by the Secretary, in which request was made that an exhibition of the work done by the girls be made at the Annual Meeting, and asked information as to prizes, etc.

The President requested that the Vice President take the chair.

Mr. Frelinghuysen moved that the Secretary be instructed to write Mrs. Reeve asking her to outline a plan of exhibit, ascertain the cost and methods of receiving the exhibits, also an estimate of the entire expense of conducting and supervising said exhibit, whether she would be willing to superintend and limit the expense to the estimate she will make. The Secretary reported that he had received from the State Plant Pathologist and the State Entomologist an Inventory of the property of the State Board of Agriculture now in their use at the Experiment Station, New Brunswick, N.J. This record was ordered to be placed on file.

Meeting adjourned to call of the President.

The Executive Committee met in the office of the Secretary at 10 A.M. Present: Vice President Cox in the chair, Messrs. Rider, Brown, DeCamp and the Secretary. Dr. Mel. T. Cook was present by previous arrangement to make report on Crown Gall.

Minutes of meeting of June 11th were read and approved as read.

The Secretary reported that he had written Mrs. Reeve and Mr. Albertson as requested at last meeting, had received no reply as yet from Mrs. Reeve.

The Secretary gave a synopsis of the replies received from the officials of the different states, as to course pursued in compiling catalogue of farms for sale, etc., and placing of immigrants. The report was accepted and ordered filed for future consideration.

Dr. Mel. T. Cook reported that he had consulted with the Department at Washington and that the Government will furnish a man to take up the Chestnut Blight work in New Jersey, with the hope of remedying the ravages made on chestnut trees.

Dr. Cook also reported that he had secured the services of H.K. Lint of Kansas Agricultural College to take up the work of the potato blight in this state, as \$3000. had been donated to Rutgers College to investigate potato diseases in this state. Owing to the present disastrous conditions of the early potatoes, the Secretary requested Dr. Cook to make special investigations whenever this disease is found with reference to the use of Formaldehyde in the treatment of seed and of Sulphur, and the effect upon the potato crop, and the same where they were not treated, in order that the whole question may be presented and discussed at the Annual Meeting of the Board.

Dr. Cook made the following recommendation as to Crown Gall, which was approved and adopted:

"To the New Jersey State Board of Agriculture,

Trenton, N.J.

Gentlemen:-

The undersigned recommends that we continue our inspection of nursery stock for Crown Gall and Hairy Root and that all nursery stock coming into the state found to be affected with this disease be condemned, and either destroyed or returned to the consignor. Also that notices of this ruling be sent to every New Jersey nurserymen, and to nurserymen outside of the State who are known to send stock into the State.

MEL. T. COOK."

Dr. Cook made the following recommendation as to Peach Yellows which was approved and adopted:-

"Our studies during the past yet indicate that the peach stock put on the market by some nurseries is sometimes affected with the destructive diseases "Peach Yellows" and "Little Peach". This is due to the fact that many nurserymen fail to detect the disease in its early stages, and unknowingly select their bud wood from slightly diseased trees. Also to the fact that nurserymen are sometimes compelled to secure their stock of buds from orchards or nurseries outside their own districts, and have no way of knowing that these buds are healthy, or even true to name.

Inasmuch as the most careful inspection cannot detect any considerable number of nursery trees affected with these diseases, and inasmuch as the New Jersey Agricultural Experiment Station is conducting extensive experiments with peaches, including studies of numerous varieties, and that these trees are under the direct observation of the Experiment Station Horticulturist and Plant Pathologist, it is our opinion that the Agricultural Experiment Station may be of further service to the nurserymen and to the peach growing industry of the State by offering a limited number of buds of various varieties to the nurserymen of the State. This would give the nurserymen a start from trees of known varieties, and free so far as it is possible to determine, from either of the above diseases.

Therefore we recommend that arrangements be made whereby the nurserymen be supplied with a limited amount of bud wood from our Experiment Station peach orchards. The expense of cutting, packing and mailing their bud wood to be borne by the State Board of Agriculture or by the State Department of Plant Pathology.





New Brunswick, N.J. Dec. 8th 14.

The meeting was called to order with the following gentlemen present, President Jos. S. Frelinghuysen, Vice-President John T. Cox, Treasurer J.H.Darnell, Secretary Franklin Dye, Theodore Brown and A.J.Rider. Mr Frelinghuysen presiding.

The minutes of the meeting held October 6th were read and approved as read.

Dr.T.J.Headlee, State Entomologist, showed a number of Gypsy Moths captured in New Jersey, and discussed the need of additional funds to prevent their spread in this state, and the advisability of issuing a bulletin showing how the spread of the pest may be controlled, and a newspaper item regarding it, giving the matter wide publicity. This was discussed and unanimously agreed upon. Dr.Headlee requested that if the Gypsy Moth infection became more extensive, that the State Board ask for an additional appropriation of \$1,000 from the Legislature, to meet the situation. On motion Dr.Headlee's suggestion was seconded and unanimously adopted.

The attention of the State Entomologist was called to the fact that the Executive Committee would leave it to his good judgment as to when to issue public warning concerning this pest, in New Jersey, and if he felt that it was not confined to this one locality, he was urged by the Committee to issue a bulletin and insert precautions in the newspapers to protect the interests of the state.

Dr.Mel.T.Cook, Plant Pathologist, called attention to the fact that rumors had reached him that uninspected Maine table potatoes were being sold in New Jersey for seed purposes; also that it was absolutely impossible for his department to inspect said potatoes with his present appropriations. He recommended that as much publicity as possible be given to the dangers of using such potatoes. This recommendation was approved by the

Board.

Dr. Cook recommended also that Mr. Ralph B. Lott, Asst. Inspector, be continued until December 31, 1914.

Dr. Cook also requested the privilege of employing special clerical help during the rush seasons of the year, which are October, November, and December, March and April. He stated that in the past he had employed such assistance and had included the bills for same in his expense account. However, the moving of the office to the College Farm may make it necessary to increase this expense slightly and therefore, he thought best to call the attention of the Committee to this point. No one was recommended for the work and no salary stated. It was simply a case of employing help when rushed and paying for the same by the hour. This request was approved.

Dr. Cook spoke to the Board about the publication of a volume by Dr. Smith on "The Insects of New Jersey" explaining that it was equally desirable that a corresponding work be published on the Parasitic Fungi of New Jersey. Dr. Cook and Mr. Schwarze his Assistant, have worked for the last three years getting this work in shape, and now have considerable manuscript together. The best library for consultation and reference for such work being in New York City at Bronx Park, they would like to have permission to visit this Library for data in connection with this work. It was moved, seconded and carried that Dr. Cook's request be granted.

Dr. Cook advised the Board of having received a letter from the Secretary of the National Potato Growers' Association, saying that they thought it would be desirable for their Executive Committee to meet at Trenton at the same time the State Board of Agriculture met in January. It was moved and seconded and carried, that Dr. Cook advise the Secretary of the National Potato Growers' Association that this would be agreeable.

The Secretary read a letter from Prof. Ague asking if we could appropriate \$300. to cover part of the expenses for farmers week, the

Experiment Station to take care of the balance. Mr. Frelinghuysen approved of this. The motion was made, seconded and carried that \$300. be used out of the appropriation for such purpose.

Frelinghuysen, President, John T. Cox, Vice President, George E. DeCamp, A. J. Rider, Theodore Brown, J. Harvey Darnell, Treasurer, and Franklin Dye, Secretary. Minutes of meeting held Jan. 26 were read and approved as read.

Mr. Stevens, representing the Lehigh Valley Railroad Company, appeared before the committee and talked about the "Full Crew" law.

Remarks were made by several members, and President Frelinghuysen suggested that inasmuch as the Public Utility Commission was in charge of the railroads of the state, it should have the authority to take care of the "Full Crew" law.

Mr. Cox offered the following resolution:-

RESOLVED, That in the opinion of the Executive Committee of the State Board of Agriculture the service to be rendered by the railroads upon each of its trains should be carefully studied by the Public Utility Commission and to that Commission should be given full power to enact rules which will be binding upon the railroads operating in the state, but which should not be made effective until the railroads have had an opportunity of presenting their side of the case to the Public Utility Commission.

We believe that the public should be thoroughly safe-guarded and the Public Utility Commission should be instructed to have that object in view in the enactment of all rules to govern the requirements of the service. Without discussing the merits of the present law we applaud its motive of "safety first" for the traveling public, and there may be

instances where it works a hardship upon the railroads, and for that reason we favor the placing of the entire subject under the control of the Public Utility Commission: be it

FURTHER RESOLVED, that we recommend to the Legislature that it consider the advisability of committing this matter of a "full crew" to the Public Utility Commission with the proper power to regulate the same, as suggested above.

This was duly seconded and adopted.

Mr. Heydon, representing the N. J. Chamber of Commerce, appeared before the committee and spoke about the shortage of cars, and told how the trouble might be remedied.

Secretary Dye read the following preamble and resolution.-

WHEREAS, the agricultural interests of the state of New Jersey have often been hampered in harvest season by a shortage of cars to ship their products, and

WHEREAS the farmers have never co-ordinated their orders for cars early enough so that the railroads could devise some comprehensive plan to supply the demand, and

WHEREAS, preparation should now be made to prevent any shortage of cars to move the 1915 crops, therefore be it

RESOLVED, That the Executive Committee of the New Jersey State Board of Agriculture call upon the New Jersey Chamber of Commerce to take up this matter with them, with the State Grange, with the business interests of the state as represented by the local commercial organizations and with the several railroads in order that the trouble in the past in regard to the shortage of cars may be eliminated.

Mr. Rider offered a motion that this resolution be adopted and referred to Mr. E. R. Collins, Westfield, N. J. Transportation expert, for action. It was amended by empowering him to make any representations to the Chamber of Commerce that he might deem proper. The amendment was accepted, the motion was seconded in the amended form and adopted.

President Frelinghuysen informed the members that he had held a conference with Dr. Lipman, Mr. Minkler, and Mr. Gaskill relative to the bill for the reorganization of the State Board of Agriculture.

Meeting adjourned.

The Executive Committee met in the office of the Secretary March 9th, at 11:30 A.M.

Present: President Frelinghuysen in the chair, Messrs. Rider, De Camp, Brown, Cox, Darnell and the Secretary.

Minutes of meeting of Feb. 10, 1915, were read and approved as read.

The Secretary read letter from Dr. T. J. Headlee, State Entomologist, requesting permission to employ Temporary Nursery Inspector, beginning March 1st, at \$75. per month. Mr. G. L. Walters was temporarily employed until meeting of Committee, and this appointment was confirmed by unanimous consent. Dr. Headlee's request that he might have permission to appoint two additional inspectors during the season as the work might demand, was also granted, upon motion of Mr. Rider.

The Secretary read letter from Dr. M. T. Cook, requesting permission to employ as Temporary Inspector of nursery stock at a salary of \$75.

per month, Mr. Ralph B. Lott, service to begin March 15 and end May 1st.

Upon motion by Mr. Rider, this request was also granted by unanimous consent.

The Secretary read letter from Dr. Cook, enclosing copy of telegram from Washington, D.C. regarding Powdery Scab Disease of Potatoes, stating that the Department has discontinued its investigations of that disease. Communication received and ordered to be placed on file.

The Secretary read letter from Mr. A. L. Clark, asking permission to employ Mrs. Rose Morgan as Lecturer, for the Middlesex County Board of Agriculture meeting at the expense of the State Board. It was regularly moved and seconded that this matter be referred to the Extension Department at New Brunswick.

Vice President Cox assumed the chair and Mr. Frelinghuysen moved the following resolution be passed by the State Board of Agriculture:-

"That owing to the prevalence of the plague of Foot and Mouth Disease in the state of New Jersey at the present time, which is a menace to life and property, and is liable to destroy an industry amounting to \$19,000,000 and which will seriously affect the dairy business of the state, by reason of the fact that unless it is eradicated immediately by proper inspection, supervision, quarantine and slaughter, we may be confronted with the refusal of the authorities in New York state and Pennsylvania, to receive our product. That it is necessary that sufficient money be appropriated by the legislature to permit the tuberculosis Commission to enforce the law already passed, providing for the proper quarantining and slaughter and reimbursement of owners of cattle according to law. That we believe that the legislature should appropriate one hundred thousand dollars available for immediate use and to be placed in the hands of the Governor, one hundred thousand dollars additional, in place of emergency and future need, in order that this industry may be protected and the disease eradicated."

President Frelinghuysen read letter he sent to the Governor concerning Foot and Mouth Disease outbreak in this state, and it was suggested that this communication and statement by Mr. E. T. Gill (See copies attached) be given to the newspapers.

It was regularly moved and seconded that the Treasurer of this Board be authorized to receive and contributions for portrait to be made by Dr. E. B. Voorhees, and placed in the Agricultural College and send same to Dr. Demarest, Treasurer, New Brunswick, N. J.

The bill for reorganization of Board was discussed. Meeting adjourned at 1:30 P.M.

May 4, 1915.

The Executive Committee met in the office of the Secretary 10:30 AM. Present, Vice President Cox in the chair, Messrs. DeCamp, Rider, Brown, Darnell and the Secretary.

Minutes of meeting held March 9th were read and approved as read, there being no meeting held during the month of April.

The Secretary read letter from Dr. T. J. Headlee, State Entomologist, giving detailed information as to the result of the investigation and the stamping out of the Gipsy Moth found at Rutherford, N. J. Report was accepted and ordered placed on file.

The Secretary also read request from Dr. Headlee to employ for three months a Gipsy Moth Inspector to examine nurseries, salary \$75. per month, and expenses. Mr. Rider made the motion, same was duly seconded and carried.

The Secretary also read communication from Dr. Headlee stating that on May 6th there will be an important hearing before the Federal Horticultural Board at Washington, D. C., relative to Gipsy Moth, and he has been urged to have a representative of New Jersey present at this meeting, whereupon Mr. Rider moved that Mr. H. B. Weiss be appointed to make this trip, this was duly seconded and carried.

The Secretary read statement from Mr. E. R. Collins of the Railroad train work, same was accepted and ordered placed on file.

Letter from State Comptroller relative to the employment of persons in Institute work now in the service of the state, only to receive expenses when employed during time they are serving the state, was read. It was moved and seconded that the recommendations therein made be accepted and our future contracts for such lecturers made accordingly. Letter ordered filed for information to Institute Director.

Dr. Cook's request that Mr. Edgar L. Dickerson be employed as Special Assistant in the department of Plant Pathology for the months of July and August at a salary of \$100. per month was granted.

The Secretary read letter from Mr. E. G. Carr, Deputy Bee Inspector, relating to his attendance at meeting of Apiary Inspectors held at Amherst, Mass. in April, whereupon it was regularly moved and seconded that trip be approved and expenses paid out of Bee Inspection Appropriation.

The question as to permission to print a comprehensive bulletin on Poultry, possibly one on Market Gardening, and to reprint the Farm Lands of New Jersey in combination with the Handbook was raised. It was regularly moved and seconded that such printing might be done during this fiscal year.

The Committee appointed the President, Vice President and Senator Gaunt to act as a special Committee to prepare a statement in reply to the Governor's criticism in his Veto Measure on the Agricultural Bill. Said Committee to meet in New York, Monday, May 10th.

The Secretary stated that Mr. Collins had called his attention to the appointment of a representative of the Agricultural Interests to the meetings held each month to promote the cooperation and efficiency of the engineering work of the state (Chap. 190, Laws 1915), whereupon it was moved and seconded that the Secretary look into this matter and report at the next meeting as to whether any expense would devolve upon the Board by this appointment.

The question as to holding a Field Day Meeting at the President's home was considered, and through a telephone message with Mr. Frelinghuysen, the 19th day of June was set as the time for this meeting.

It was decided that the same number of Institutes be arranged for the coming fall and winter as last year.

It was regularly moved and seconded that the Executive Committee meet at Mr. Seabrook's Farm, Bridgeton, in connection with the N.J. State Horticultural Society, early in June, date to be fixed.*

Adjournment was made at 11:30 A.M.

REPORT OF CONFERENCE.

In a conference with Dr. Lipman and Prof. Alva Agee, May 5th, it was decided with approval of Executive Committee that the Summer meeting of the State Board of Agriculture and the farmers of the state in general should be held at College Farm, early in September, arrangements to be made and expenses met by College Farm, as last year.

Farmers' Week December 27th, 1915-January 1, 1916, to be arranged for and conducted by Prof. Alva Agee, as last year, expenses of program and speakers to be divided between Extension Department and State Board.

Dr. Lipman will assist in revising Farm Lands later, and opines we can combine with it the Handbook material, making one book. If more of Farm Lands are needed immediately, better issue a small edition of the present work now.

Prof. Mel. T. Cook's book on Plant Diseases of New Jersey is in preparation, will cost probably \$2,000. If this Board will assume $\frac{1}{2}$ of the expense of publication, then $\frac{1}{2}$ of the edition would be turned over to this Board for its use. Possibly the state would print it as they did Dr. Smith's Insects of New Jersey.

As to Institute Conductor and Institute matters in general, Prof. Agee suggests the advisability of employing a Conductor by the year, at a moderate salary, possibly Prof. Clark, and that in counties having a Demonstrator, meetings be held under auspices of this Board, both in summer as well as in winter, as occasion may seem to require, that the County Agent conduct if necessary, at least fully cooperate. This course would make the work continuous throughout the year. Give meetings for discussion and demonstration when and where most needed.

Raritan, N.J., June 19, 1915.

At the Field Meeting of the farmers of New Jersey held under the auspices of the State Board of Agriculture at the invitation and at the home of the President Hon. Jos. S. Frelinghuysen, as host, a meeting of the Executive Committee of the Board was held at 12 M, all the members being present. President Frelinghuysen presided. The following action was taken embodying a reply to Governor Fielder's published reasons for vetoing Senate Bill 289, reorganizing the State Board of Agriculture, which was passed by both Senate and Assembly at the 1915 session of the Legislature. (See clipping).

The resolutions were read by the President and after discussion, on motion of Mr. Rider, were adopted and ordered to be read before the assembled farmers at this meeting, which was done.

Answer to Fielder's Veto
 The statement was read by President Frelinghuysen, and follows:
 "The members of the executive committee of the State Board of Agriculture, disappointed at the veto of the agricultural bill, and having carefully considered the veto message of Governor Fielder, desire to express their views regarding same.
 "For several years past the State Board of Agriculture, representing the allied agricultural interests of the State, has felt that it was absolutely necessary that the various departments which have been created since the organization of the State Board in 1873, and were operating under separate management and control, should be consolidated in one department at

Dr. Headlee, State Entomologist, was present by request.


Dr. Headlee presented the matter concerning the Bee Inspector, who had been released by the State Board of Agriculture for the months of October, November and December, 1915, to do work for the U.S. Government in the South. His services with this Board were to have been resumed January 1, 1916, but owing to the fact that an error was made in appropriation bill taking effect Nov. 1, 1915, the money appropriated for Bee Inspection was not available until a new Act correcting this error was passed by the Legislature. The Bee Inspector was retained by the Government for the month of January, 1916, and started work for the state of New Jersey February 1st, working February and March without any reimbursement of salary. Accordingly, the Committee suggested that the Secretary and the State Entomologist interview the Comptroller as to whether the

Bee Inspector might be paid for his services for the two months above stated, out of the money set forth in the corrected bill passed by Legislature (Chap.20, Laws 1916). The Comptroller therefore ruled that Mr.Carr was entitled to the two months' salary and expenses and suggested that a requisition be made for same, immediately.

It was regularly moved and seconded that Mr.Carr's salary as Bee Inspector be increased from \$100. to \$125. per month, said increase to begin April 1, 1916. After securing President Frelinghuysen's approval it was carried.

Members who have suggested were requested to interview these men and request their presence at the next meeting of Commission.

Dr. Parry said "I think it doubtful and not advisable for the Chief Inspector to do his own testing. He must see that cattle are properly tested and released.

The Commission then proceeded to district the State as follows:-

Commission then took up the question advanced from the Comptroller's office as to the legality of the acts of the Commission prior to July 4th when the law went into effect to cover this objection and acting on the advice of the Assistant Attorney General, Mr. Gaskill. The Commission then passed the following resolution.

To Whom it May Concern:-

"Inasmuch as the Commission on Tuberculosis Among Cattle, appointed under Chapter 202, Laws 1911, was appointed, organized and entered on its duties prior to the date when said law becomes operative,

Therefore, it is hereby resolved that said Commission thus appointed being in session July 6th, does hereby ratify and endorse all business transacted, appointments made and salaries voted by the Commission under the law prior to July 4th, 1911."

To cover any possible question as to the legality of the appointment of the members by the President prior to July 4th, the President reappointed the present Commission; viz: Messrs. A. A. Cortelyou, William Richman, Dr. Wm. C. Parry, Hon. George M. La Monte and the Rev. Dr. John C. Sharp.

The Commission then took up the testimony in the VanderRoest case, and after a very careful consideration of the same rendered the following unanimous decision, which was approved by the President.

"In the case of Dr. H. VanderRoest and the charges against him made by the President and members of the New Jersey State Veterinary Medical Association which were presented to the Tuberculosis Commission at an

informal hearing given on June 13th, 1911, at the State House, after hearing informally all the charges presented and weighing carefully the evidence, The Commission unanimously conclude there is

1st: No evidence that Dr. VanderRoest is incompetent as a Veterinarian.

2d. That the charges of unreliable testing of two cows designated as the Montclair and the Kearney cows are not sustained by the evidence.

3d. That the evidence of the alleged detectives Herbert Lang and Wm. Martin seem to the Commission to be wholly untrustworthy.

4th. In the consideration of the conclusions above, the Commission revokes the suspension of Dr. VanderRoest imposed on him April 19, 1911.

The Commission then at 4 o'clock adjourned to meet on the 17th inst. to take part in the Civil Service Examinations of the applicants for Inspectors under the law.

The President reported that he had a call from Dr. Stearns (Baldwin?) who stated to him that he was receiving a great deal of opposition from an organization with which Dr. VanderRoest is connected--the Dairymen & Drovers' Protective Association of New Jersey, they were opposing the administering of the law. He told him to make a report of the incidents as they occurred. He thought that the ruling of the Commission in exonerating Dr. VanderRoest immediately put him in his former position, the President told him we reinstated Dr. VanderRoest, but did not employ him any further. The President thought Mr. McNabb should go to Newark and investigate the conditions there and report what he finds as to carrying out the law.

It was moved by Mr. Cortelyou and seconded by Mr. LaMonte that the Commission appoint Dr. Wm. H. Lowe as Inspector in the First District. Carried, the President not voting.

Moved by Mr. LaMonte and seconded by Mr. Cortelyou, that August 10 1911, be the date at which the Chief and District Inspectors commence their work. Carried.

Mr. Colby was called in to decide some questions, viz:

Of the three names submitted one must be chosen and given three months trial.

A new examination cannot be given, but the ones submitted must be given a probationary period of three months. Appointments could be postponed a week or so.

A requirement could be made in the appointment of the Inspectors that they give all of their time to the State work.

Mr.LaMonte moved that when these men are notified of their appointment that they be informed that under the Civil Service Commission Law and Rules, the appointment is probationary for three months.

It was decided that the District Inspectors should make a detailed report in writing to the Chief Inspector once a week, so that the Chief Inspector can make a detailed account to the Commission once a month.

-- Rules adopted referred to in above Minutes. --

For Home Herds.

1. Calves under six months old not to be tested unless for unusual conditions and by special arrangement.
2. When application is made to have one or more members of a herd tested, if tuberculosis is found in any animal, then the balance of the herd, if conditions warrant, is to be tested on arrangement with the owner.
3. In testing home herds, the usual two-pre-temperatures at two-hour intervals shall be taken, and ~~three~~ after-temperatures after the twelfth hour, at two-hour intervals, unless in the judgment of the Veterinarian a fourth or fifth after-temperature is important.
4. In selecting a Veterinarian to do testing of home herds, the Inspector shall select one from the list supplied him for his District by the Secretary and Chief Inspector.

(Adopted Sept. 28, 1911).

Mr. Gaskill said the Commission would have to call on the Sheriff of the County for assistance to the officer in executing the order.

The following resolution was passed:

That if the Sheriff of Essex County on request to assist any of the Inspectors of the Tuberculosis Commission in the execution of an order issued from the Commission for the slaughter of cattle reacting under the tuberculin test asks for indemnity against any risk which might be incurred by him in rendering such assistance, that the proper officers of the Commission are hereby authorized to enter into such indemnity agreement with the said Sheriff as one of the expenses incident to the enforcement of the Act under which this Commission is operated.

The President issued an order to the Chief Inspector authorizing the slaughter of condemned cows.

Then on motion, the Commission adjourned to call of President at 4 P.M.



"The sense of this Board is that the principle involved in the Weart bill is wrong, therefore the Commission cannot endorse it."
Seconded and carried.

The Secretary reported that he and the Chief Inspector had made report of the Tuberculosis Commission to the State Board of Agriculture for the year 1913. Report was accepted.

Senate bill 161 was discussed and the following motion made by Mr. LaMonte;

That we are still of the opinion that the office of the Commission on Tuberculosis in Animals is best safeguarded by the present Board, instead of being placed under the supervision of the State Board of Health. Carried.

It was regularly moved and seconded that when the bill for the month of February, amounting to \$1,298.22 is examined and approved by the proper officers, it be forwarded to the Comptroller's Department for payment.

He also stated that the Comptroller's Department were making an investigation along this line, and would report to the Commission later, when action upon this matter would be taken if necessary.

Vice-President Cox was authorized to sign bills for the month in the absence of the President. Said bill amounting to \$2010.07.

Minutes of last meeting held May 12th were read and approved as read.





The Commission on Tuberculosis in Animals met in the office of the Secretary at 2 P.M.

Present: Vice President Cortelyou in the chair, Drs. Sharpe and Buzby, Messrs. LaMonte, Richman and the Secretary,

Minutes of meetings held Jan. 13th and Mar. 9th were read and approved as read, there being no meetings held in the months of February and April.

The Secretary made inquiry as to whether the Report of the Commission should include that of Foot and Mouth Disease in the Report to the State Board of Agriculture, and be brought down to Jan. 29, 1915, or end with the fiscal year of the state, whereupon the following motion was made by Mr. LaMonte:- "That the Report of the Commission be made up to the end of the fiscal year." Carried.

Mr. McNabb gave a report of the Foot and Mouth Disease case discovered at Secaucus, Saturday, May 1st, where 13 cattle were slaughtered.

Discussion followed of admission of cattle from Pennsylvania, shipped Mr. Hansen, Pennington, without permit, and the following motion was made:- "Notify the shipper that cattle cannot be accepted or unloaded, as they have been shipped into this state in violation of the law, and are held sealed in the car for orders from the shipper, and must be promptly taken out of the state." Carried.

Inspector McNabb presented the request of Mr. Geo. Batten, who has 4 head of cattle with the Dairy Show held at Hawthorne, Ill., as to whether he can bring his cattle to Sussex County or not. After discussion the following motion was made: "That Mr. Batten should send this Commission a certificate of Health from both the Federal Government and State of Illinois, as to the health condition of the cattle, when such certificates are received, they will be acted upon by this commission."

Mr. McNabb reported the case of Mr. Flynn, who purchased 26 cattle from New York state, coming through at Port Jervis, N.J. had public sale and sold them without tuberculin test and in violation of quarantine restrictions. Four animals were slaughtered by this Commission and a fine of \$100. imposed.

The question of the admission of cattle from Canada was discussed, and the following resolution passed:-

"It is the sense of this Commission that we have no objection to the shipment of cattle from Canada providing they come in sealed cars with proper health certificates, until further action is taken. Tests must be made by Federal or regular authorized Veterinarians, in accordance with the Federal Government's permit for tuberculosis, foot and mouth disease, and other diseases." Carried.

In view of the fact of the increased work of the Commission the following resolution was passed:-

"Whereas the work of the employees of this Commission has been constantly increasing, requiring more time and greater skill, the judgment of this Commission is that the salaries should be increased as follows:- Said increase to begin May 1st, 1915.-"
