## College and Career Readiness

Additionally, this school is meeting $\mathbf{0 \%}$ of its performance targets in the area of College and Career Readiness.

College and Career Readiness measures the degree to which students are demonstrating behaviors that are indicative of future attendance and/or success in college and careers. ## Graduation and Post-Secondary
