Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, a U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwaters, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities which require a permit may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Stream Encroachment: Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed does not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed inside the back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

Bureau of Safe Drinking Water Revises Technical Manual

The Bureau of Safe Drinking Water (Bureau) has revised its Technical Manual for Public Water Works Facilities Approvals. The revisions reflect the changes in the Bureau's regulations for the construction of public community water systems (N.J.A.C. 7:10-11) which were adopted on November 18, 1996.

The technical manual has been prepared as guidance to water purveyors and consulting engineers who need to ascertain whether a permit application is necessary for the construction of water works facilities. More importantly, it serves to provide guidance to the consulting engineer as to what is required of an applicant for the permit application. It highlights areas of most frequent deficiencies, and it accentuates areas of critical concerns in each of the permit categories.

FACT SHEET

HARDSHIP GRANTS FOR RURAL COMMUNITIES

The New Jersey Department of Environmental Protection is soliciting interest from project sponsors that may qualify for a new grants program to provide wastewater services to rural communities that are not currently served either by a sewage collection or by a wastewater treatment system and are severely economically disadvantaged. New Jersey's allotment for this program is \$415,900. The new program, entitled "Hardship Grants Program for Rural Communities," was established by federal law and requires that eligible communities: (1) have a total population of 3,000 or less, (2) a per capita income of less than \$17,357 and (3) the local unemployment rate (on a municipality or county basis) exceeds the national average by one percent or more at the time of grant application. While the Department has targetted certain municipalities which may be eligible for these grants based on information from the State Data Center, other municipalities may also qualify provided an acceptable source of data is used to satisfy the population, income and unemployment criteria noted above. Project sponsors will be asked to confirm that they satisfy the eligibility requirements at the time of application.

Hardship grant funding will be available for projects starting with the FFY98/SFY99 funding cycle (i.e., November 1998 awards) and will be combined with low-interest loan funding from the Wastewater Treatment Financing Program to make the project more affordable. Grant assistance will be provided to an eligible project sponsor in an amount of \$100,000 (for no more than 85 percent of the allowable project cost) or 30 percent of the allowable project cost, whichever is greater. Sponsors of eligible projects should complete a Project Status/Cost Update Form to place the project on the Priority List and forward a commitment letter to submit planning and design documents by February 2, 1998. Please note that if all the available Hardship Grants funds are not awarded in the FFY98/SFY99 funding cycle, grants will also be made in the FFY99/SFY2000 funding cycle (i.e., November 1999 awards). Therefore, potential sponsors who are unable to satisfy the February 2, 1998 deadline for planning and design can submit a commitment letter for the FFY99/SFY2000 funding cycle. The FFY99/SFY2000 deadlines require the sponsor to send a commitment letter by February 2, 1998, submit planning by April 24, 1998 and design by November 2, 1998, for a grant/loan award in November 1999.

All persons, including permittees who believe that any condition of NJDEP's tentative decision to issue these permit actions is inappropriate must raise all reasonable issues of concern and submit all arguments and factual materials supporting their position during the public comment period. Any request for a public hearing shall state the nature of the proposed issues to be raised in the hearing. A public hearing will be conducted if NJDEP determines there is a significant degree of public interest. If a public hearing is held, the public comment period is automatically extended through the close of the hearing.

NJDEP will consider and respond to all significant and timely submitted comments. The permittee and each person who submitted written comments, will receive notice of NJDEP's final decision to issue, revoke or redraft the document.
