DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS DECEMBER 2020

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- At the end of December, the TANF caseload had decreased by 279 cases, from 10,957 in December 2019 to 10,678 in December 2020; a decrease of -2.5%.
- The counties with caseloads that increased the most since December 2019 were Hunterdon (24.2%), Hudson (20.6%), and Middlesex (14%).
- The counties with caseloads that decreased the most since December 2019 were Burlington (-20.1%), Morris (-19.2%), and Gloucester (-18%).
- Of the WFNJ/TANF cases, 3,410 or 31.9% were child-only in December 2020.
- The counties with the most child-only cases were Camden (551), Essex (425), and Hudson (411).
- Essex (4,564), Hudson (3,979), and Camden (3,490) counties had the greatest number of persons receiving TANF in December 2020.

NJ SNAP (Formerly FOOD STAMPS)

- In December 2020, there were 411,520 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 70,918 or 20.8%, since December 2019.
- There were 800,491 persons receiving NJ SNAP benefits as of December 2020; an increase of 129,220 or 19.3% since December 2019.
- The counties having the highest caseload increase since December 2019 were Hudson (38.4%), Warren (31.1%), and Essex (26.2%).

EMERGENCY ASSISTANCE

- There were 1,395 TANF families receiving Emergency Assistance (EA) in December 2020; a decrease of 237 or -14.5% since December 2019.
- In December 2020, EA payments were made for 676 SSI recipients.

**DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
DECEMBER 2020**

- There were 1,944 GA cases with Emergency Assistance payments in December 2020; a decrease of 95 or -4.7% since December 2019.
- The counties that showed the highest percent increase in Emergency Assistance payments were Monmouth (222.7%), Hudson (32.8%), and Mercer (19.1%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Salem (-100%), Cumberland (-55.6%), and Warren (-37.9%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 9,925 to 13,231 since December 2019; an increase of 33.3%.
- There were 8,540 Employable GA and 4,691 Unemployable GA cases in December 2020.
- The counties that showed a percent increase for GA cases were Salem (125%), Hudson (105.4%), and Camden (63.5%) since December 2019.
- The counties that showed the highest percent decrease for GA cases since December 2019 were Hunterdon (-18.3%) and Morris (-4.5%).
- In December 2020, GA cases showed a 1.4% increase since November 2020.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$295 million from October 2020 to December 2020 ; a decrease of -3.1% over the same period from FFY 2020.
- Total distributions decreased -0.2% from December 2019.

WORK FIRST NEW JERSEY (WFNJ)


- During the report month of December 2020, there were 247 families in which at least one member was employed and an additional 43 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (44), Mercer (30), and Hudson (27).
- There were 391 former TANF cases receiving post-TANF support in the form of child care assistance.

DECEMBER 2018 THROUGH DECEMBER 2020**









Ending with DECEMBER 2020













ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKIDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime
