DDHH Equipment Distribution Program Change

DDHH will no longer offer internet based caption phones, only the analog 840 CapTel. Consumers may get an internet based phone at no cost from the resources listed below.

To receive a free phone, you must provide a professional certification form from a qualified professional certifying your hearing loss and need for captioned telephone service. You must self-certify that you have a medically recognized hearing loss that necessitates use of captioned telephone service.

High-speed internet and a landline telephone are required to use the service. There is no charge for delivery, installation or ongoing customer support.

Grace's Law brochure Updated

The division has updated the Grace's Law brochure which can be found at the link below. This law, effective as of 2009 provides hearing aid benefits covered under health plans written in New Jersey for children under 16 years old. The original benefit was limited to \$1,000 for each ear. That limit was eliminated in 2014. However, co-pay, deductibles, and coinsurance are applicable. For more information, click [here](#).
