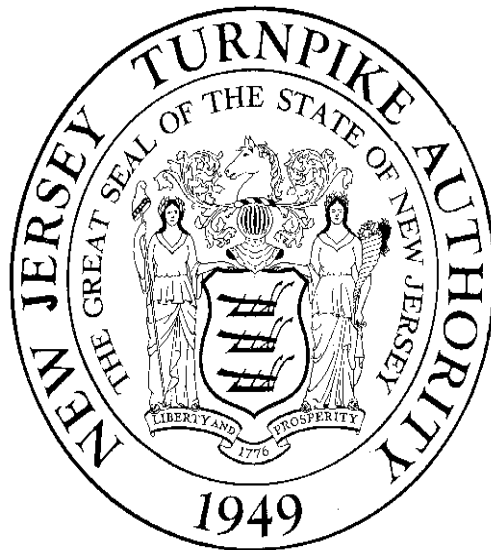

This agenda item seeks ratification of those actions taken under the delegated authority described above, as well as authorization for actions not yet taken relative to the above Program.

This project involves the reconstruction of New Jersey Turnpike Interchange 10, which will cause construction improvements to U.S. I-287 in the vicinity of Interchange 10. Construction management, supervision and inspection involving the NJDOT's highways that are part of this project are the sole responsibility of the Authority, but this agreement provides for inspection, monitoring and advice by the NJDOT, at the NJDOT's discretion. In addition, the determination of whether the Authority's contractor for the project is in compliance with the contract documents rests solely with the Authority's Construction Engineer.
