\*\*The amount of the relator's fee listed (\$4,439.57) in *Omnicare Inc. (Depakote)* represents 15% of the portion of the NJ State Share for the time of the covered conduct to which the relator's share applied (10 months out of a 96-month period).

\*\*\*Payments in *U.S. ex rel. Martin v. Para-Plus Translations, Inc.* are being made in installments, with a first payment of \$182,862.00 in December 2016 and quarterly payments of approximately \$6,656 for five years, which includes 3.5% interest per year.

\*\*\*\*Amounts recovered reflect cases paid in full plus the amounts of installment payments received on a prior year cases (i.e., *Maxim* and *Kesler v. Novartis (Bioscrip)*).
