SUBJECT: Reorganization of Medicaid District Offices (MDOs)

For many years, the Division of Medical Assistance and Health Services (DMAHS), the New Jersey Medicaid Agency, has administered a number of program activities from seventeen (17) Medicaid District Offices (MDOs) located throughout the State.

Over the past three and one-half years, staffing in our MDOs and Institutional Services Section (ISS) offices has declined from 497 to 315, a 37% reduction. This is primarily the result of layoffs, resignations and retirements, and a lengthy hiring freeze. The severe and imbalanced attrition-driven staff reductions have created staffing difficulties which have made it increasingly difficult to provide the desired level of services through the existing network of Medicaid District Offices.

In order to sustain the current array of MDO activities, it became imperative that existing resources be consolidated into a more manageable organization. On July 1, 1992, the two MDOs in Essex County were consolidated into the Newark MDO, and on July 20, 1992, the Paterson and Mercerville ISS offices were consolidated with Marlboro and Hammonton respectively. Additionally, the MDOs located in Cumberland, Gloucester, Union, Hunterdon and Mercer Counties will be closed, and Medicaid staff will be relocated to MDOs in nearby counties. Certain MDOs will continue to perform the full spectrum of MDO activities while other MDOs will perform either PreAdmission Screening assessments and other long-term care activities or adjudicate prior authorization requests. The target date for completing this consolidation plan is October 5, 1992.

The attached list identifies the counties served by each MDO in a regional concept as required by the Appropriations Act for Fiscal Year 1993 (S-1000, A-1500). The list also identifies the specialized services and activities to be performed by the remaining eleven MDOs. Each office will continue to handle Medicaid recipient problems, questions and eligibility issues, in addition to serving as a resource for the provider community.
