Message from the CEO

I am pleased to present my first biannual report as the Chief Executive Officer of the New Jersey Schools Development Authority (SDA). During my short tenure with the SDA, I have worked diligently with our state and industry partners to identify opportunities to enhance SDA operations and to more efficiently pursue our mission to improve the learning environments of our state's schoolchildren. My review of the SDA and its operations has already begun to produce tangible results.



First, in April 2010, Governor Christie announced his approval of the sale of \$500 million in bonds by the New Jersey Economic Development Authority (EDA) to support the work of the SDA. This infusion of much-needed capital to continue SDA operations signaled the new Administration's recognition of facilities needs statewide and demonstrated its commitment to providing safe and modernized schools for children throughout New Jersey. The dedication of these significant resources also carries with it an increased measure of accountability, which the public rightfully expects and deserves.

Next, in May 2010, the SDA and the Department of Education (DOE) announced the execution of grants statewide to support facilities work in the Regular Operating Districts (RODs). These state-funded grants provide approximately 40 percent of eligible costs for projects in RODs, addressing health and safety issues, student overcrowding and other critical needs. As of June 30, 2010, the SDA had 271 grants either fully executed or ready for release representing a \$90.4 million State investment towards \$202.9 million in total capital work. These grants not only provide direct assistance to districts to improve their schools but assist in the creation of jobs statewide in this time of economic crisis. One indisputable statewide need throughout the time period covered by this report and up through today has been job creation and sustenance. We are proud to have served and continue to serve as an economic stimulus vehicle while at the same time contributing to the improvement of our children's schools.

My review has also led to an overhaul in organizational structure that will increase fiscal accountability and improve the Authority's overall operations. I announced this comprehensive reorganization to SDA staff on June 29, 2010 and it became effective immediately. The new structure moves away from a departmental model for the delivery of school projects to a "team-based" approach involving appropriate staff, working as one unit, in all aspects and phases of every construction project. This structure will provide for greater continuity and better communication throughout the entire life cycle of a project, which will result in more cost-effective delivery of schools. In addition, the new structure will better position the SDA to be more responsive to ever changing times and environments.

These accomplishments represent only the beginning of the review of SDA operations. The results of this work will continue to inform our approach to carrying out our mission. One item that is presently under review is the 2008 Capital Plan and the method of project delivery. Be assured that the SDA will continue to report its progress to the Governor and the Legislature regarding ongoing reforms and additional recommendations for change as it continues the transformation into a model for school construction programs nationwide.

Introduction

Following is the Biannual Report of the New Jersey Schools Development Authority (SDA) for the period October 1, 2009 through March 31, 2010. This report is submitted under the provisions of P.L. 2007, c. 137 (“the August 2007 legislative amendments”), which modified the Educational Facilities Construction and Financing Act (EFCFA) (P.L. 2000, c. 72).

This report summarizes progress made by New Jersey’s school facilities construction program during the six-month reporting period and updates the status of projects in the SDA’s portfolio. It also presents a strategic plan for improvement, reflecting the results to date of an ongoing comprehensive review conducted by the SDA’s Chief Executive Officer. See [Appendix A](#) for details on the report’s statutory requirements.

About the SDA

The Authority fully funds and manages the new construction and modernization of school facilities projects in 31 school districts (“the SDA Districts”). Other SDA District projects for which the Authority is responsible are renovations and repairs deemed emergent by the Department of Education (DOE) due to health and safety reasons.

The SDA also makes grants available to the 574 Regular Operating Districts (RODs) throughout New Jersey for facilities projects approved by the DOE. These grants fund at least 40 percent of eligible project costs, with the remaining share coming from local communities, contingent on budget or voter approval.

Funding for the SDA

In total, the Legislature has authorized a total of \$12.5 billion in funding for the SDA (\$8.9 billion for SDA Districts, \$3.6 billion for RODs and vocational schools). Of the overall program total, the amount of debt financing issued to date is \$8.65 billion, having increased by \$500 million upon Governor Christie’s April 2010 approval of bonds by the EDA. A significant portion of the new \$500 million was issued in the form of Build America Bonds (BAB). BABs were established under the American Recovery and Reinvestment Act (ARRA) of 2009 and allow the state to receive a federal subsidy equal to 35 percent of interest payments. Status of the School Facilities Construction Program

Completed SDA-Managed Projects

The SDA completed seven schools during the reporting period, benefiting more than 4,700 students in districts across New Jersey. All but one of these schools are in SDA Districts. Five of the schools are newly constructed; the other two involve addition, renovation and rehabilitation work. All told, the schools represent a \$394 million state investment in providing the necessary classroom space, science labs, computers and other technology needed to support a 21st century education.

From its inception in 2001 through March 2010, the state's school construction program has completed 621 projects in SDA Districts: 54 new schools, 45 major extensive additions, renovations and rehabilitations, and more than 500 other projects.

Current Project Portfolio

School Facilities Projects/SDA-Managed

The SDA had 12 projects in construction at the end of the reporting period. These projects represent a state investment of \$511.6 million and will benefit nearly 9,300 students statewide. Nine of the active construction projects are in SDA Districts, while three are in RODs that receive 55 percent¹ or more of their budgets from State aid.

An additional 50 SDA District school facilities projects are in various stages of development. A review of this portion of the portfolio is now being conducted by the SDA and the DOE to ensure that current District needs are met and taxpayer dollars are effectively allocated. See [Appendix C](#) for the list of these school facilities projects.

¹ Before the August 2007 legislative amendments, the SDA was responsible for managing school facilities projects in RODs that were receiving 55 percent or more of their budgets through State aid. Following the amendments, the Authority no longer undertakes management of school facilities construction projects in these districts. The SDA continues to manage a limited number of ROD projects initiated prior to August 2007.

Emergent Projects/SDA Districts

The Authority continues to focus on the advancement of SDA District emergent projects – those deemed necessary by the DOE due to potential health and safety conditions. There were 129 emergent projects in the SDA portfolio as of March 31, 2010, reflecting an estimated \$80 million State investment. Emergent projects are SDA-funded and either managed by the SDA or delegated to the local school district. As of March 31, 2010, the status of the emergent-project program was as follows:

- SDA-managed:
 - Total projects: 45
 - Design phase: 42
 - Construction: 3
 - Estimated total cost: \$37.8 million

- Delegated:
 - Total projects: 84
 - Design phase: 51
 - Construction: 29
 - Completed: 4
 - Estimated total cost: \$42.8 million

Activity during the reporting period included the advancement of three (3) SDA-managed projects to construction and the delegation of six (6) projects to SDA Districts. Also, DOE approved 13 emergent projects to begin work.² See [Appendix D](#) for the list of DOE-approved projects.

Regular Operating District Grants

The SDA distributes grant funds for DOE-approved projects in Regular Operating Districts (RODs). ROD grants in the Authority’s portfolio fund at least 40 percent of eligible costs for projects, with the remaining share approved by local referenda or through individual school-district budgets. ROD grant projects are managed locally, with State funds disbursed by the SDA as project milestones are met. The DOE oversees applications from RODs for projects specifically addressing health and safety concerns as well as overcrowding, early childhood education and special education needs. During the reporting period, the SDA fully executed 241 ROD grants upon receipt and review of

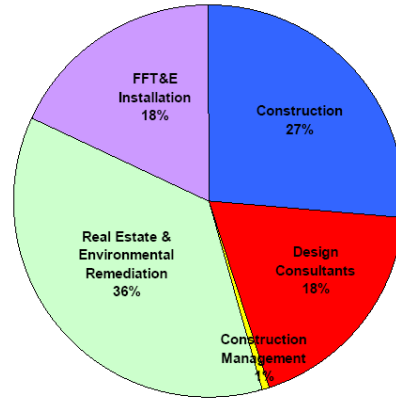
² Eight of these DOE-approved projects have progressed into the design phase and are reflected in the above statistical summary regarding the SDA’s 129 emergent projects. The remaining five projects are in preliminary scope review and are not part of the summary totals.

school district documentation. For a detailed listing of these executed grants, see [Appendix E](#). Following the Governor’s approval of \$500 million in bond sales, the ROD grant program resumed in May 2010 upon the joint SDA/DOE announcement that 142 grants were ready for release to school districts, with additional grants to follow.

Jobs Created/Sustained

The school construction program plays an important role for New Jersey’s labor force during these recessionary times by creating and sustaining jobs in the construction industry as well as for consultants in design and other fields. SDA-managed projects created 2,044 jobs overall during the reporting period, or a monthly average of 341 jobs. The program sustained an additional 1,848 jobs on an average monthly basis.³

Small Business Enterprise/Minority Initiatives

Each year, the SDA exceeds the statewide requirement of awarding at least 25 percent of all its contracts to Small Business Enterprises (SBEs). For the reporting period, the SDA surpassed the requirement by its widest margin ever as SBE participation reached 86 percent. In actual dollars, this percentage translated to \$45.5 million of the SDA’s \$52.8 million in contracts awarded. The chart below presents key facts on the SBE program, including statistics on contracts awarded to minority- and women-owned firms.

The SDA continues to pursue strategies to bolster SBE participation. On March 30, 2010, the SDA and Rutgers' New Jersey Small Business Development Centers announced a partnership to create the Contractor Business Development Program. This initiative is aimed at providing business management technical assistance that will enable more small, minority- and women-owned businesses to bid on state school facilities construction projects. This program combines informational seminars, instruction and one-on-one technical assistance to participating businesses. Businesses selected to participate in the program learn from experts in the areas of finance, estimating, bonding, project management, bidding and marketing.

The SDA is committed to ensuring diversity on its job sites throughout the state of New Jersey. To measure the level of diversity, the SDA tracks the number of minority and female work-hours on Authority-managed projects. During the reporting period, minorities performed 21 percent of all work-hours, while women performed 0.8 percent. - Note: This report is statutorily required to provide information on SDA projects exceeding the state's Facilities Efficiency Standards. No such projects were approved during the reporting period.

Recommendations for Change

The SDA has made progress in providing safe, efficient schools to improve the learning environments of New Jersey's schoolchildren. However, it has identified additional steps needing to be taken for the Authority to operate with the utmost efficiency and accountability. Below are recommendations for change that the SDA will undertake in its efforts to meet the standards that taxpayers expect and fully deserve.

2008 Capital Plan Review

A review of the Authority's 2008 Capital Plan will be conducted in collaboration with the DOE before the Authority resumes the advancement of SDA District school facilities projects into construction. The focus of the review will be to ensure that the most critical projects proceed statewide in a fiscally responsible way. The need for a review has been apparent as several SDA Districts have requested changes due to demographic shifts and other needs, seeking to swap certain Capital Plan projects for others not currently on the list. Also, policy decisions underpinning the Capital Plan must be revisited. The SDA will consider the findings and recommendations in the State Auditor's June 2010 report regarding the Capital Plan to ensure that the most critical projects move forward.

Internal Restructuring

Following a comprehensive review of the SDA's internal structure, policies and processes, the Authority's Chief Executive Officer determined that sweeping organizational changes were needed. On June 29, 2010, a comprehensive reorganization of the Authority was announced in order to streamline SDA processes, improve efficiency and provide fiscal accountability.

The new structure, described in greater detail in the "Message of the CEO" section of this report, is the first step toward reshaping the eight-year-old agency. The SDA will make adjustments to this new structure as necessary.

* * *

While the SDA believes its Capital Plan review and internal reorganization will result in significant improvement to the school facilities construction program, the Authority will continue to seek to identify additional areas in need of change and new direction to ensure the highest levels of fiscal accountability and efficiency. The SDA looks forward to updating the Governor and the Legislature on its progress in implementing these changes.

Appendix A: Requirements of the Biannual Report on the School Facilities Construction Program

Requirements of the Biannual Report

35. Section 24 of P.L.2000, c.72 (C.18A:7G-24) is amended to read as follows:

C.18A:7G-24 Biannual report on school facilities construction program.

24. The development authority, in consultation with the State Treasurer, the financing authority, and the commissioner, shall biannually submit to the Governor, the Joint Budget Oversight Committee, the President of the Senate and the Speaker of the General Assembly a report on the school facilities construction program established pursuant to the provisions of this act. The report shall be submitted no later than June 1 and December 1 of each year and shall include, but not be limited to, the following information for the prior six-month period: the number of school facilities projects approved by the commissioner pursuant to section 5 of P.L.2000, c.72 (C.18A:7G-5); the number of projects undertaken and funded by the development authority; the aggregate principal amount of bonds, notes or other obligations issued by the financing authority for the State share of construction and renovation of school facilities and whether there is a need to adjust the aggregate principal amount of bonds, notes or other obligations authorized for issuance pursuant to subsection a. of section 14 of P.L.2000, c.72 (C.18A:7G-14); the number of approved projects which exceeded the facilities efficiency standards, the components of those projects which exceeded the standards, and the amount of construction by individual districts and Statewide estimated to have exceeded the standards; and recommendations for changes in the school facilities construction program established pursuant to this act which have been formulated as a result of its experience with the program or through collaboration with program stakeholders.

In addition, the biannual report shall include a comparison of the costs of school facilities projects undertaken and funded by the development authority to similar school facilities projects constructed in the New York City Metropolitan Statistical Area and the Philadelphia Metropolitan Statistical Area as defined by the United States Department of Labor. The development authority shall include in the report an explanation of the methodology used in making the comparison.

Methodology to develop the comparison: To address the August 2007 statutory requirement that costs of school facilities projects undertaken and funded by the SDA be compared to similar school facilities projects constructed in the New York City and Philadelphia Metropolitan Statistical Areas (MSAs), the SDA subscribes to specific statistical data reports from McGraw-Hill Dodge Construction Reports.

The U.S. Office of Management and Budget (OMB) is responsible for developing the standards for defining MSAs and for applying these standards with Census data.

In addition to using the OMB's definitions of MSAs and to broaden comparisons of SDA projects with cost per square foot of other relevant projects, the SDA has supplemented its review with a recognized national-construction data source – the School Planning and Management 2009 Annual School Construction Report – as well as information from the School District of Philadelphia and the New York City Department of Education School Construction Authority. The use of multiple sources to monitor and analyze construction costs provides assurance that industry-wide pricing trends are addressed. The table above provides a comparison of cost per square foot for new school construction (public and private schools) within the Philadelphia and New York MSAs. The MSA comparative cost per square foot was measured by cost at time of bid.
