SUBJECT: Extension of JerseyCare Coverage to the Aged,
Blind and Disabled

The New Jersey State Assembly has passed a bill which extends JerseyCare coverage to aged, blind and disabled recipients. Governor Thomas H. Kean has announced his support for the bill and it is expected to become law. As a result, enactment of this coverage is anticipated to occur during calendar year 1988.

Therefore, the County Welfare Agencies are advised to take this proposed law into consideration when preparing their 1988 Budget Statement for the Medical Assistance Program (MAP) employee work unit. To assist in preparing your budget, attached is a schedule of the estimated JerseyCare population by county.
