Robert-Lettis Hooper, Esquire, produced a Certificate of his being duly elected a Member of Council, for the County of Hunterdon, which was read; and he thereupon took and subscribed the Oaths required by Law before the Honourable Elijah Clark, Esquire, one of the Members returned for this House, and took his Seat in Council.

Elijah Clark, Abraham Kitchel, John Peck, Ephraim Martin and Samuel Ogden, Esquires, severally produced Certificates of their being duly elected Members of this House, which were read; and they thereupon took and subscribed the Oaths required by Law, and took their Seats in Council.

Whitten Cripps, Esquire, produced a Certificate of his being duly elected a Member of Council, for the County of Salem, which was read; and he thereupon took and subscribed the Affirmations required by Law, being one of the People called Quakers, before the Honourable Robert-Lettis Hooper, Esquire, and took his Seat in Council.

“ GENTLEMEN,

“ **W**E, the Representatives of the State of New-Jersey in Council and Assembly met, although fully convinced of your Abilities and Zeal to promote the Interest of this State and of the Union, cannot refrain from communicating to you our Sentiments and Instructions upon certain Subjects of the first political Importance.

“ For the Sake of avoiding unnecessary Repetitions, we think it proper and sufficient in the first Place, to refer you to the Instructions given the former Representatives by the last Legislature, dated the first of March 1786, which one of you is officially possessed of, and the others may find recorded in the Minutes of the House of Assembly of the same Date.

“ The Disadvantages under which we then laboured, the Impositions that were at that Time practised upon us by the nearest States, and the Injustice that we conceived was done us by others still exist, and even operate with additional Force. These Instructions you will consider as the Rule and Direction of your Conduct while in Congress, and invariably adhere to them in every Matter to which they bear Relation.

“ As it may be necessary for you to be made acquainted with our Determination and Opinion upon the various Requisitions of Congress, we refer you for full Information on this Head to the Report of the Committee appointed for that Purpose, which has received the Approbation of that Branch of the Legislature from which they were appointed. We have directed that a Copy of this Report be enclosed to you, and you will regard it as expressive of our Wishes and Resolutions on this Subject. You will discover upon reading it, that it is expected you will spare no Exertions in endeavouring to paint, to that Honourable Body with whom you have a Seat, the Unhappiness of our Situation, in its most striking and truest Colours. While you assure them of our Inclination to satisfy their federal and just Demands, so long as that Justice which we have long and loudly called for is denied us, and those unfeeling Oppressions against which we have hitherto unavailingly complained and remonstrated, are continued and increased.

“ The Welfare of the Union is the first Object of our Wishes and nearest to our Hearts. It is your Duty to promote it in every Situation, and under every Circumstance. Should any Misfortune, which Heaven avert, hereafter happen to it, those States, and those alone, must be responsible, whose illiberal and selfish Policy will have occasioned it, and on them must fall the whole Weight of the Evils which cannot fail to accompany such an Event. Be it then your Care, while you are asserting the Rights of the State you represent, to guard with a watchful Eye the Interests of the Whole. Let your Conduct be such, as will furnish no Room for the Reproach that New-Jersey has been

among

among the laſt, or in the leaſt Degree remiſs in ſupporting the Confederation.

“ The Ceſſion for a Term of Years of the entire Navigation of the River Miſſiſſippi to the Spaniſh Court, has, we are informed, been propoſed and agitated in Congreſs. We cannot avoid expreſſing our Diſapprobation of the Meaſure; and it is our Wiſh that you ſhould give it your Oppoſition whenever it is again brought forward for Diſcuſſion or Deciſion. Were it evident, that the Execution of this Buſineſs would be attended with no ill Conſequences or Inconveniencies, yet, in our Opinion, the Conſideration offered for it is Nothing to this State, and little or trifling to the Union. But we view it in a far different Light. We believe that the Value of the weſtern Country, on the Sales of which we rely for the Diſcharge of our numerous Debts, is in ſome Degree dependant upon the free Navigation of this important River. The Ceſſion of a diſputed Right, when once made, is not eaſily reclaimed. And whether the Court of Madrid aſks or intends it for the Benefit of its own Subjects, or to barter with Britain, the Step will be equally imprudent, and the Inconvenience equally great.”

The Council having taken the foregoing Inſtructions into Conſideration,

Houston, William Paterfon and Abraham Clark, Esquires, to meet such Commissioners as have been appointed by the other States in the Union, for the Purposes mentioned in a Resolution of the Legislature of the 19th of May last ; and that the Treasurer be directed and authorized to pay the said Jonathan Dayton, Esquire, the same Pay as is allowed to the other Commissioners appointed on the Part of this State, upon producing his Accounts in the same Manner as is directed by a Resolution of the Legislature of the 24th November 1786.’

The Council having taken the two foregoing Resolutions into Consideration,
