### Report of State Librarian.

Hon. Walter E. Edge, Governor of New Jersey:

SIR:—The annual report of the operation of the New Jersey State Library for the fiscal year ending October 31, 1917, is herewith respectfully submitted.

The accessions in books and pamphlets for the year numbered 4,380, bringing the total number of books and pamphlets on file in the State Library up to 107,127. These books and pamphlets were acquired as follows:—

From the above table, it will be observed that an unusually large majority of books and pamphlets added to our shelves during the past year were obtained without a direct expenditure of money, at least so far as the State Library's appropriation is concerned. Books and pamphlets received from the United States Government are sent to us without charge, the New Jersey State Library being one of the United States Government depository libraries. Publications received from other States in exchange are almost entirely law books and other public documents issued by the several States that are sent to us in exchange for similar publications of our own State.

It is largely through the publications so received and other publications that come to us as gifts that the State Library is enabled, with its limited appropriation, to maintain its high standard as a repository of valuable, useful and up-to-date literature on the various subjects coming within the scope of the library's work.

#### APPROPRIATIONS AND EXPENDITURES.

The total amount of the appropriations available for the maintenance of the library during the last fiscal year was \$11,-100.00, and the expenditures aggregated practically an equivalent amount. The following table shows the appropriations and expenditures under the various headings indicated:—

The above item of \$3,000 for the purchase of books, periodicals, newspapers and other publications for both the Law Library and the General Library, as well as for binding, is \$500 less than the appropriation for 1915 and for several preceding years for the same purpose and made it impossible to secure during the past year, particularly for the General Library, many desirable publications. However, the appropriation for this purpose for the forthcoming year has been restored to the original figures of \$3,500 and this, it is felt, will make it possible for the library to obtain all really essential publications.

As stated in a former report, it is difficult to translate into words much of the detail of the operation of a library. However, there are some matters of moment during the past year to which brief allusion should be made.

The Legislative Reference Department continues to prove its usefulness and value to the members of the Legislature and to State officials and State departments and institutions as evidenced by the fact that its resources are being drawn upon to a greater extent with each advancing year. The usefulness of this department was pretty thoroughly discussed in our report of a year ago and need not now be reiterated.

Our Law Library is being kept up to its well recognized

high standard and, besides the usual purchase of text books, periodicals and other publications, there was added to our shelves a set of the Dominion Law Reports, which is a new, annotated series of reports comprising every case reported in the courts of every Province, and also all the cases decided in the Supreme Court of Canada, Exchequer Court and the Railway Commission, together with Canadian cases appealed to the Privy Council. Arrangements are also pending for adding to the facilities of the Law Library a set of the Lawyers Edition of United States Reports, which will give us three complete sets of reports of the decisions of the United States Supreme Court, namely, United States Reports, Supreme Court Reporter (National Reporter System), and the Lawyers Edition of United States Reports.

#### NEW JERSEY ARCHIVES.

One of the functions of the State Library for some years past has been to maintain a mailing list and send out as published copies of volumes of the New Jersey Archives. During the past year there were sent out Volume 28 of the First Series and Volume 5 of the Second Series. A new volume, Volume 29 of the First Series, has just come from the printer and this volume will be sent out within a brief time.

The New Jersey Archives are compiled under the direction of the New Jersey Historical Society and the expense of publication is borne by the State. One thousand copies of each volume are furnished to the State Library for distribution and these volumes, in the main, are sent to persons who are on a permanent mailing list which was made up at the time, some years ago, when these Archives were distributed by a number of State officials and departments. The older method of distribution resulted in a great deal of duplication and, finally, a determination was reached to consolidate these various mailing lists into a composite list to be maintained by the State Library.

The State Library is constantly in receipt of requests from persons not on the permanent mailing list for complete sets of these Archives, but these requests cannot be granted, for the reason that all the earlier volumes are now out of print so far as the State Library is concerned. The State Library does not now have on hand any spare volumes prior to Volume 24 of the First Series.

#### OUR NEWSPAPER FILES.

One of the most valuable and interesting sources of information in the State Library is our file of bound volumes of newspapers, including as it does a number of newspapers published during the early history of our State. These files are being constantly consulted and the fact that most of these volumes could not be replaced, gives them a value that can scarcely be measured in a monetary sense.

Space alone prevents the State Library from carrying on its shelves permanently a larger number of newspapers. This is particularly regrettable so far as New Jersey newspapers are concerned, because their contents contribute so much to the history of the State that might well be preserved in some convenient center for public reference.

As an appendix to this report, there is presented a list of the newspapers that are bound and kept permanently on file on our shelves and, in addition, it might be said that we also receive about twenty dailies and fifty weeklies which are not bound for permanent preservation but which are kept on our reading table for a length of time sufficient to meet reasonably recent reference demand. It might be added that practically all of these newspapers are furnished to the State Library gratis by their publishers. A list of these newspapers is conspicuously displayed in our newspaper department.
