Meeting Record

Roll call was taken. Chairman called for motion to approve the May minutes. Irwin Zonis made the motion to approve the May minutes as submitted. James Blando seconded the motion. The May minutes were approved by a unanimous vote. Dr. Bielory introduced Dr. John J. Petillo, President of UMDNJ, who welcomed the Council to the University.

Administrative Report

Presented by Samuel Wolfe, Assistant Commissioner, Environmental Regulation:

- Summarized the current version of the diesel legislation, which provides for retrofits
 of school buses, New Jersey Transit buses, commercial buses, garbage trucks, and
 publicly owned diesel vehicles and equipment.
- Discussed USEPA's April 5, 2005 guidance on implementing nonattainment New Source Review requirements for fine particulates. In the 13 counties that are nonattainment for PM2.5, USEPA guidance will have DEP apply nonattainment New Source Review to facilities with the potential to emit at least 100 tons of PM10 per year, when they are proposing an increase of more than 15 tons of PM10 emissions per year.
- The rule clarifying that CO2 is an air contaminant is expected to be adopted by midto late summer. A provision expressly stating that the actual or potential CO2 emissions of a facility or source will not be a basis for requiring information about CO2 emissions in a permit application, including CO2 emission limits in a permit, applying state of the art requirements, or charging emission fees.
- New Jersey is leading a group of states that have formally asked the USEPA to
 reconsider its mercury cap-and-trade rule, which offers virtually no reduction of
 mercury emissions over the next decade when 90% reductions are feasible. USDOE
 has licensed for commercial development its patented technology for injecting
 unburned coal from a power plant boiler into ductwork past the air preheater, which
 has shown great success in controlling mercury emissions at a substantially lower
 operating cost than activated carbon injection.

Hearing Report Review

- The recommendations will be divided into five domains.
- The members voted to include CAC generic support of legislation regarding smoking and diesels that would result in improved air quality.
- Members will receive final version June 14. Any additional comments due to Linda by June 21.
- Dr. Bielory suggested "Energy Conservation and Personal Choices" as a topic for the 2006 Hearing and encouraged other members to start thinking about suggestions.
