There are several issues DVRS has been looking at over a period of time. One of those is the distribution of the sheltered employment "slots". Actually we do not work directly with slots but this has been a convenient way of expressing level of service. actually been paying service days with each "slot" being equal to 220 days.

Originally when the method οf paying for extended employment was introduced established the levels of service based on what had transpired the previous year. There has been no major revision since then.

Now that we have a history, track record to go on, we will be making adjustments in the FY 1985 of service to reflect a better conformity to actual formance.

simple terms we will reducing the contracted level o f service for those facilities who are chronically under serving and increasing the contracted level for those who have historically overserved the extended population.

Grace Applegate Appointed to Human Resources Post

Commissioner Roger Bodman announced the appointment of Grace Applegate as the Labor Department's Assistant Commissioner for Resources.

Commissioner Bodman said Applegate's responsibilities will policy include developing programs and overseeing activities Division o f Vocational Rehabilitation, Division 0fDivision of and Disability Determinations.

addition, according to Commissioner, Ms. Applegate will continue to serve as a Assistant and Legislative Liaison with the Department of Labor.

Applegate was appointed by Commissioner Bodman as a Special Assistant and Legislative Liaison in June, 1982. Her duties in those posts include working with Governor's Office and the Legislation to further legislation that is of importance to the Labor Department.

Ms. Applegate, of Plainsboro, was advertising sales manager of the County News, a weekly newspaper in Dunellen for two years prior to joining the Department of Labor.

She previously served as a Legislative Aide to Senator Walter Foran, of Hunterdon County, as Minority Aide to the New Jersey State Senate.

As Middlesex County Republican State Committeewoman, Ms. Applegate served as co-chairperson of the Middlesex County Kean for Governor Committee in the Republican primary election. She was also a member of the inagural committee of Governor Thomas H. Kean.

DVRS Quarterly Statistics

This quarter we are a little short on raw material for this column. Usually the computer deluges us with data but not so this quarter.

It's in a good cause however. Our payment system is being revamped so that our bills can be paid faster and the new system provides a better accounting of how funds were spent. In the long run, it will benefit all of us. In the short run, it is a pain.

The data we do have available from various sources indicates there were no dramatic changes in utilization patterns during the first quarter of the fiscal year.

Referrals remained relatively unchanged, new starts (evaluation) were down slightly, WAT starts were up slightly and competitive placements were down slightly from their two year high achieved in the fourth quarter of the last year.

The sheltered employment program reported 42 competitive placements almost identical to the 43 in the first quarter of last year. Dropouts were up considerably rising from 87 to 133. This is

probably accounted for to some degree by the readjusting of population to reflect Division of Mental Retardation's interest in sponsoring some clients.

Average client hourly wage in Sheltered Employment was \$1.07.

Committed Level of Service

For the last couple of years we have lived with the originally assigned levels of service under the EE contracts. DVRS is presently studying the levels of these contracts against past performance with an eye to adjustments next year.

We strongly wish to make slots available to some of the smaller programs in order to make them more cost efficient.

Budget

The Commissioner of Labor, Roger Bodman and the Governor have both recommended a funding level of \$5,250,000 for the Extended Employment program in State Fiscal Year 1985.

The \$250,000 increase is tied to a 90 slot (19,800 service day) increase in level of service. This is not clear in the "Budget Book" because the 90 slot increase was not noted although it was used in making the computations as to average cost.

If you see figures that don't jibe, or if someone asks you, that's why. It should read: FY'84 2210 clients @ \$5,000,000 = \$2,262 per slot.
FY'85 2300 clients @ \$5,250,000 = \$2,283 per slot.

Community Service Programs In New Jersey

In New Jersey in 1983 alone there were 8,100 offenders performing community services by working without compensation, totaling more than 600,000 hours of community service in that year.

The Community Service program as a sentencing option has become a popular form of sanctioning offenders.

In January of 1982, a law went into effect mandating community service or jail for persons convicted for the second and subsequent offense of driving under the influence of alcohol or drugs.

The state legislature has appointed funds under the direction of county guidance departments, to municipal, county, state, federal and private not-for-profit agencies.

This program:

- * is cost effective
- * is a viable sentencing
 alternative to incarceration
 (referring to already overcrowded jails)
- * holds offenders accountable to community for their actions
- * offers needed services to a community, the public and private non-profit sector.
- * allows skills, talents, interests to be utilized in the performance of service.

The process involves 1) screening of an offender, 2) referral, and 3) an interview. All those accepted for placement are covered by accident/medical insurance through the Community Service Program.

A prospective employer is responsible for informing a client of company rules and regulations, and for describing the type of work to be done and designating a contact person for the client who would be available to the client for answering questions or for addressing problems to. A monthly report of work hours completed is to be sent to the Community Service Program,

individual reports are needed for each client.

State Grants Help Totally Unique Project Get Start

Cumberland Rehabilitation Center/ Easter Seal Society is to commended for their efforts and success with a contract thev recently developed in conjunction with Time Graphics, Inc. Mr. Paul Booker, director of the Cumberland Rehabilitation Center (CRC), Mr. Bill Scates, Project Coordinator, Ms. Cynthia Rauso, Coordinator of Training, and Mr. Dan Kelly. Director of Professional Services are especially to be recognized for their efforts.

CRC has contracted to manage the entire mailroom department of a private company, Time Graphics, Inc. The contract provides jobs and training for physically and/or mentally handicapped persons from the Cumberland County area. Two state grants, 1) New Jersey Division of Vocational Rehabilitation Services for \$16,500 and, 2) Human Services Advisory Council of Cumberland County for \$18,750

helped start this project in motion. The project gives client workers a realistic look at the working world.

Last report showed 15 client workers employed in the mailroom and plans are to bring in a continuous flow of new people. Workers are paid by Easter Seals, not Time Graphics, Inc.

After one month of operation, other New Jersey businesses are looking at this operation for possible implementation in their businesses.

Mr. John Ewing, Circulation Director for Time Graphics, Inc. is reported to expect mailroom operations to increase under Easter Seals. He is reported to have said the project is working out beautifully and CRC staff and workers should be commended.
