# Devereaux Appointed Director Veterans Programs

The New Jersey Department of Military and Veterans Affairs recently appointed William J. Devereaux to serve as the Director of Veterans Programs.

The highly decorated combat veteran of Vietnam and Camden County resident will be responsible for managing the 15 Veterans Services Offices located throughout the state.

"I'm extremely passionate about my responsibility to help every veteran in New Jersey receive every benefit, entitlement, and recognition which they have so justly earned by virtue of their patriotic service to both our state and country," stated Devereaux.

"By working closely with the commanders and representatives of the state's 36 plus chartered veterans organizations as well as the tens of thousands of individual veterans and family members not affiliated with any veterans group or organization, I hope to address the issues and concerns of a constituency that is both aging and changing."

Devereaux received his Bach-

elor of Science in Marketing from Tennessee Tech in 1967 and an Master of Business Administration from North Carolina State 1971. His military service from May of 1967 through May of 1970 included assignments in Artillery, Military Intelligence, and as a Paratrooper with the 82<sup>nd</sup> and 101<sup>st</sup> Airborne Divisions. Mr. Devereaux served a full tour of duty in Vietnam with the 101<sup>st</sup> Airborne Division and was attached to the 3<sup>rd</sup> Brigade of the 82<sup>nd</sup> Airborne Division during the Tet Offensive in 1968.

His military awards and decorations include the Purple Heart, Bronze Star, Presidential Unit Citations, Soldiers Medal, Vietnam Service Medal and the Vietnam Cross of Gallantry with palm.

He also is active in a number of veterans' organizations including the Disabled American Veterans, Veterans of Foreign Wars, Silver Rose Society, 82<sup>nd</sup> and 101<sup>st</sup> Airborne Associations, Vietnam Veterans of South Jersey; Purple Heart Association and the National Association of County Veterans Service Officers.

## Has Your Status Changed?

New Jersey recently extended eligibility for State Veterans' benefits to those who served in support of Operations Enduring Freedom and Iraqi Freedom. Assembly Bill 3564, which was approved on Dec. 16, 2003, provides veterans who served at least 14 days in country in support of either Operation,


My Administration is also working to enhance our military's presence in New Jersey. Through Executive Order, we have created the Governor's

# Old Glory Wing Opens At Menlo Park

On Apr. 5, the Old Glory Wing at the New Jersey Veterans Memorial Home at Menlo Park began accepting residents.

It began at 7 a.m. with the nursing staff receiving their first assignment of the unit.

An hour and a half later, the first resident arrived and was escorted into his clean, freshly decorated room.

"This is a great moment for our state's veterans and it's a step in the right direction towards better serving our state's 650,000 veterans," stated Joseph Brandspiegel, CEO of the Menlo Park Home. "This high quality care center is exactly what veterans have earned by virtue of their patriotic service. We are extremely proud and honored to provide these additional services to the veterans who so bravely served us."

This unit will take special need residents into consideration and

the unit will serve Alzheimer's and dementia related residents. Old Glory is a secure unit that provides a safe environment for residents who are at risk for wandering.

A new Menlo Park Veterans Home facility was completed several years ago to replace the previous, antiquated, 100 year-old "Old Soldier's Home". However, the "Old Glory" wing was not opened due primarily to a shortage of qualified nurses that created a situation in which the facility could not meet Department of Health mandated staff-resident ratios

The newly opened wing will provide 40 beds to veterans suffering from Alzheimer's.

Veterans must apply for admission on a 'first come' basis and will be placed on a waiting list when maximum capacity is reached.

On Apr. 30, Governor McGreevey officially dedicated the Old Glory Wing; several hundred guests were in attendance.

The "Grand Opening" Ceremony began at 11 a.m. in the Town Square area of the facility and was followed with an official ribbon cutting at the entrance of the unit. After the ceremony, guests had the opportunity to tour the unit in small groups led by the Veterans Home staff.

"We look forward to the Old Glory Grand Opening and providing the continued service to our country's Veterans," concluded Joseph Brandspiegel.

# First New Jersey Korean Service Medals Awarded

The first New Jersey Korean Service Medals were presented in a ceremony at the New Jersey Veterans Memorial Home at Menlo Park Apr. 30.

Brig. Gen. Glenn K. Rieth, The Adjutant General of New Jersey presented the medals to 15 residents of the veterans home.

The New Jersey Korean Service Medal was approved Feb. 3, 2003. In order to receive the medal, veterans must meet all of the following criteria:

Be a New Jersey resident who was on active duty in any branch of the armed forces of the United States in Korea, Japan, or the contiguous waters or airspace on or

after June 23, 1950 and on or before January 31, 1955

Been given an honorable discharge for their service and:

Was attached to or served for one or more days with an organization participating in or directly supporting military operations; or

Was attached to or served for one or more days aboard a United States Naval vessel directly supporting military operations; or

Participated as a crew member in one or more aerial flights into airspace above Korea or contiguous areas, except that this time limit may be waived for persons participating in actual combat operations; or

Posthumous - the surviving spouse or immediate family member of any resident of the State meeting the requirements for the medal who was killed while on active duty or who died after receiving an honorable discharge from the armed forces. Only one award of the medal and ribbon per eligible veteran.

# Stand Down 2004: A Hand Up To Homeless Veterans



On Sept. 24, beginning at 8:00 a.m., the New Jersey Department of Military and Veterans Affairs (DMAVA) and Stand Down of South Jersey, Inc., will be co-hosting Stand Down 2004 at the National Guard Armory at Cherry Hill.

DMAVA, along with many volunteers and civic organizations is holding the Stand Down to provide homeless veterans with access to healthcare, mental health screening, substance abuse counseling, social services availability, religious counseling, a hot meal, a haircut and winter clothing. Stand Down's ultimate goal is to show disenfranchised veterans that someone still cares and to assist him or her in bringing their homelessness to a close.

This is the fourth Stand Down to be held at the Cherry Hill Armory. Last year 137 homeless veterans and their families attended the Stand Down. In years past, Stand Downs have been held at Fort Dix and Naval Weapon Station Lakehurst.

On any given night there are

341,000 veterans estimated to be homeless, up from 274,000 in 1995. About one-third of the homeless in the United States have served in the Armed Forces and the number of homeless Vietnam veterans exceeds the number of service members killed during any

given conflict. There are currently 7,500 homeless veterans in New Jersey.

The Veterans Benefits Bureau is a six-person team responsible for reviewing applications for the following programs:

Determining veterans' status for preference and pension status, which includes veteran's preference for hiring in New Jersey Civil Service and Veterans status for pension purposes.

The N.J. Veterans and Spouses Catastrophic Entitlement Program.

Grants and Aids – POW/MIA/War Orphan/Veterans Tuition Credit Program, Post Traumatic Stress Disorder (PTSD), Transportation.

N.J. Property Tax Deduction/Exemption Program works hand-in-hand with tax assessors to determine eligibility for the property tax benefit.

New Jersey Medal Program: New Jersey Distinguished Service Medal, Meritorious Medal, Vietnam

Service Medal, Korean Service Medal and replacement of State Medals.

Operation Recognition Program (N.J. High School Diploma). Stand Down Operations.

# Military Retirees To See Pay Increase

On Feb. 2, an estimated 150,000 military retirees will see an increase in their pay. The National Defense Authorization Act, enacted in November 2003, significantly modified a long-standing law preventing retirees from receiving full-retired pay if they also received disability pay from the Department of Veterans Affairs.

The new law allows what has been dubbed "concurrent receipt" of military retired pay and VA disability pay for retirees with more than 20 years of service and a disability rating of 50 percent or greater. This restored pay will be phased in over a 10-year period that began Jan. 1, 2004.

Retirees are not required to take any action to receive the ad-

ditional pay. The Defense Finance and Accounting Service have already identified eligible retirees and have started making adjustments to their military retired pay.

The first payments are due the first business day of February for the law change that was effective Jan. 1. The additional funds will be paid Feb. 2 based on entitlement for Jan. 1-31, 2004. The restored pay is paid on the same schedule as current military retired pay. Recurring payments will be made on the first business day of each month based on entitlement for the prior month.

For the majority of military retirees, the additional money is taxable income and subject to federal tax withholding.

One category of military retirees that is eligible for additional funds will not be paid Feb. 2 - those who receive retired pay based on a disability percentage instead of years of service. Further guidance is needed from the Department of Defense to determine how the law will be applied in these cases. Once guidance is received, payments will be made retroactive to Jan. 1, 2004. An estimated 2,800 military retirees fall into this category.

# SAA News

Recent federal legislation has increased the GI Bill education rates for Chapter 35, Survivors and Dependents effective July 1, 2004. The rates increase as follows: \$788 per month, full time attendance; \$592,  $\frac{3}{4}$  time attendance; and, \$394,  $\frac{1}{2}$  time attendance at an approved college, university, or non-college degree school.

The State Approving Agency has recently completed approval of various on the job training programs at PSE&G Nuclear Power Plant in Salem County, N.J. The initial approval consists of four On-the-Job-Training (OJT) programs with an average length of 15 months of training. The SAA will be pursuing other jobs at the plant for approval in a continuing effort to expand apprenticeship and on the job training programs for New Jersey's veterans and other eligible persons.

In addition, the SAA has completed an apprenticeship training agreement with the New Jersey State Police. A two-year apprenticeship program was approved and retroactive payment of benefits for eligible persons are being processed. New Jersey state troopers can earn approximately \$11,000 in benefits in addition to salary while in the training program.

## ROK War Service Medal

The Republic of Korea (South Korea) is honoring Korean War veterans or the next of kin of eligible veterans, by issuing a Republic of Korea War Service Medal.

The United States Air Force has been designated the lead agency to receive and distribute the medals, which will be provided at no cost.

## VA Insurance Dividends

The 1.5 million veterans who are active policyholders of veterans' life insurance from policies served between 1917 and 1956 will receive more than \$517 million in dividends in 2004.

The payments will be sent on the anniversary date of the policy, with the specific dividend amount varying according to age, type of insurance and length of time the policy has been in force. Only those with policies that have been kept in force when premiums were required are eligible for the payout.

Payments are expected to reach \$416.8 million for the 1.2 million veterans of World War II with National Service Life Insurance ("V") policies. The 11,000 veterans with Government Life Insurance ("K") policies will be paid dividends totaling \$1.8 million.

Those nearly 200,000 Korean War Veterans who have maintained the Veterans Special Life Insurance ("RS" and "W") policies can expect to receive dividends \$83.9 million.

And for those veterans from World War II who have the Veterans Reopened Insurance ("J", "JR" and "JS") policies, who currently number approximately 53,000, they will share a \$14.7 million dividend.

Current active-duty service members and reservists are covered under the Service members' Group Life Insurance through a private carrier and no dividends are paid on this insurance. Nor are dividends paid on the VA term insurance that covers veterans who were discharged after 1956.

Veterans Haven is a transitional housing program for homeless veterans. Veterans may reside at Veterans Haven for up to two years. During that period, they receive employment assistance and life-skill training. During the past nine years, Veterans Haven has opened its doors to more than 500 veterans.

## Facts About VA Disability Compensation

Disability compensation for veterans is not subject to federal or state income tax. About 80 percent of veterans receive their VA benefits by direct deposit, which VA recommends for security reasons.

Veterans are rated at increments of 10 percent reflecting degree of disability. The largest category of veterans on the compensation scale is at 10 percent disability (\$106 per month), with 791,000 veterans at this rate at the end of fiscal year 2003 among the total 2.5 million veterans receiving disability compensation.

Disability criteria are available online at [http://www.access.gpo.gov/nara/cfr/waisidx\\_03/38cfr4\\_03.html](http://www.access.gpo.gov/nara/cfr/waisidx_03/38cfr4_03.html) As medical knowledge, laws and procedures change, VA regularly publishes proposed changes to these criteria in the "Federal Register" for public comment before a final regulation is adopted.

Where a veteran has more than one disability, the percentages are not added together to produce a new, overall rating. Instead, a formula described in federal regulations calculates the overall rating.

A veteran may be rated at zero percent, meaning there is evidence of the service-connected condition, but it does not impair the veteran. An example is a minor scar. This zero percent rating, though not compensable, is beneficial, since it raises the veteran's priority in other VA programs, and it may be reviewed for a higher rating if the condition worsens. A veteran may have a number of disabilities individually evaluated as 0 percent, which produce 10 percent combined disability and entitle the veteran to disability compensation. At the end of fiscal year 2003, there were 16,000 veterans in this category of "compensable zero" ratings.

In addition to the 2.5 million veterans on the compensation rolls, past studies have shown approximately 1.2 million veterans have overall ratings of 0 percent, but because they do not receive payments from VA, the exact number is not known.

The largest category of service-connected disabilities is musculoskeletal problems, accounting for 40 percent of all disabilities. This includes such problems as impairment of the knee and arthritis due to trauma. Data on the number and type of disabilities are published annually at <http://www.vba.va.gov/reports.htm>

Veterans who gained their automotive repair skills in the military are getting help from a leading automotive industry group to help them get the qualifications needed to find a job in the service technician career field. Automotive Retailing Today's program, Hire the Heroes, will give automotive dealers opportunity to network with military outplacement personnel and develop relationships to transition veterans into service technician careers. The website has a veterans section that includes general information and links to other websites.

Hepatitis C is the most common blood borne infection in the United States, affecting 2 percent of the population. VA cares for more hepatitis C patients than any other medical system, with more than 200,000 patients since 1996.

# Group Joins Forces In Veterans History Project

The Department of Veterans Affairs (VA) is joining forces with the National Foundation for Women Legislators (NFWL), the Disabled American Veterans (DAV) and the American Folklife Center at the Library of Congress to record interviews with veterans for presentation to the Library of Congress' Veterans History Project.

"I am proud VA is a part of this very important effort to preserve the legacy of America's veterans," said Principi. "This project will allow younger generations of Americans to learn about the sacrifices and patriotism of those who fought to guarantee their freedom."

"It is so important for all Americans to reach out to veterans and I know that our women legislators

are honored to be a part of this project and to have the opportunity to be working so closely with our nation's heroes," said Robin Read, president and CEO of NFWL.

Women elected officials from every state and U.S. territory have been selected to serve as veterans team leaders for NFWL's "Heart to Heart" program to record interviews with veterans for presentation to the Library of Congress' Veterans History Project. VA will assist NFWL in locating veterans to be interviewed and will provide nationwide public affairs support. DAV is encouraging its members to interview their fellow disabled veterans or to allow a volunteer to interview them.

Team leaders have been fo-

cusing on interviewing World War I and World War II veterans. During the next year, they will also interview veterans of Korea, Vietnam and Persian Gulf wars.

Congress created the Veterans History Project in 2000. The American Folklife Center at the Library of Congress is collecting audio and video recorded histories, along with documentary materials such as memoirs, letters, diaries, maps, photographs and home movies. The material will be available to veterans, their families, researchers, historians and future generations of Americans at the Library of Congress, with representative samples also online at the Veterans History Project web site at [www.loc.gov/vets](http://www.loc.gov/vets).

## Website To Help Military Retirees Apply For CRSC

The Department of the Army recently announced a new website designed to assist disabled military retirees in applying for Combat-Related Special Compensation.

The Army CRSC website, which went online the week of Jan 12, provides all the information that a disabled military retiree needs to know in order to apply for CRSC, said officials from the Human Resources Command. The site provides program guidelines used to determine eligibility for combat-related disability benefits and application procedures for the program.

"The site includes an application form, which can be downloaded, and it gives detailed instructions of the application process," said Brig. Gen. Gina S. Farrissee. "It also contains support-

ing documentation required to substantiate a claim and helpful tips on how to enable the timeliest application processing."

In addition the new website includes:

- \* Guidance on how and where to file an appeal for retirees who previously submitted applications that have been determined ineligible or have been declined.

- \* A detailed listing of specific information and documentation that is frequently overlooked by applicants in their initial applications, as well as procedural and timing considerations.

- \* Phone and e-mail points of contact in the event customers have difficulty navigating the site or need

specific information about the CRSC program.

As a provision of the 2003 National Defense Authorization Act, CRSC allows eligible disabled military retirees to collect payments for both their military service and their service-related disability.
