Explanatory Notes

Highlights of Current Program Statistics

AFDC (Tables 1 and 5, Graphs 1 and 4)

122,347 eligible families in New Jersey were receiving AFDC as of the end of November 1994.

About 110,200 were single head of household families (Regular AFDC, C segment).

Among two-parent families, Unemployed Parents (F Segment) accounted for 3800, and State AFDC (N Segment) for 3400. There were 5000 Medicaid Only families.

By County, the largest numbers were in Essex with about 30,800 families, Hudson with more than 19,400, and Camden County with 13,800. They accounted for more than 52 percent of all AFDC families.

The other counties ranged from 228 families in Hunterdon to 7,884 in Passaic County.

The number of eligible families in November 1994 has changed little since January 1993, but has declined each month since June 1994, for a drop totalling more than 2300 or almost two percent. There were peaks of 124,000 in May/June 1993 and 124,700 in May/June 1994.

Regular AFDC (C segment) peaked at nearly 111,800 in June 1994 then declined more than 1,600 through November to 110,181, below the January 1993 level of 110,215.

The number of F segment families peaked in both May 1993 and May 1994. It declined steadily from more than 4500 in May 1994 to about 3800 by November.

State AFDC (N segment) grew from less than 2600 families in January 1993 to nearly 3500 by May 1994 (almost 37 percent). It has since declined slightly each month until October, with virtually no change in November, at 3350.

The Medicaid Only group remained close to 5000 for the entire period.

FOOD STAMP PROGRAM (Tables 2 and 6, Graphs 2, 5, and 6)

At the end of November 1994, 221,800 households were participating in the Food Stamp Program.

About 114,300 were AFDC households and 107,600 were Other Low Income households.

About 48 percent of all Food Stamp Households are in Essex (55,028), Hudson (30,007) and Camden (22,006) Counties.

These households included more than 524,000 persons, 246,700 adults and 277,400 children.

In seven counties (Bergen, Hunterdon, Monmouth, Morris, Somerset, Sussex, and Warren) the number of adults exceeds the number of children in Food Stamp households.

Food Stamp households in New Jersey increased from less than 208,000 in January 1993 to about 222,000 in March through June of 1994, then dropped to about 220,000 by September, and again increased to almost 222,000 by November.

The numbers of AFDC(FS) households and Other Low Income households continue to converge. AFDC(FS) households increased by only 2700, from less than 112,000 in January 1993 to about 114,000 during September through November 1994 (with a peak of almost 116,000, March-June of 1994). Other Low Income households increased by more than 11,500 from 96,000 in January 1993 to almost 107,600 by November 1994.

The total number of recipients rose from 504,000 in January 1993 to a more than 530,000 in March through May 1994, then declined almost 9000 by September 1994, but increased by 2000 since then.

Recipient adults have increased much more than recipient children. Adults increased by about 14,000 from about 232,000 in January 1993 to about 247,000 in November 1994 (with a peak of over 248,000 in March through June 1994). Recipient children increased by only about 5000, from 272,500 in January 1993 to less than 277,500 in November (with a peak of almost 283,000 in March 1994).

EMERGENCY ASSISTANCE (Tables 3 and 7, Graphs 3 and 7)

At the end of November 1994 a total of 7013 eligible AFDC families were receiving Emergency Assistance (EA) in New Jersey.

3826 families were receiving Temporary Rental Assistance (TRA).

There were 695 motel placements and 434 emergency shelter placements.

All other AFDC-EA accounted for 2058 families, including either one-time benefits such as back rent, back utilities, security deposits, furnishings, and clothing and food allowance, or shared or transitional housing.

2649 families in Essex County received EA, including 2105 provided TRA. Mercer, Middlesex and Passaic each had more than 500 EA recipient families, and Bergen had 458. All other counties had between 19 and 370 with seven under 100.

After reaching almost 8500 in May 1993, total AFDC families receiving Emergency Assistance dropped below 7000 by December 1993, and ranged between 7000 and 7700 in 1994.

The number of Families receiving Temporary Rental Assistance has declined fairly steadily in the last two years. At almost 4900 in May 1993, it declined to less than 4000 in December 1993, remained between 4100 and 4300 through July 1994, and declined again in August through November to about 3800.

Motel placements declined from close to 800 in January 1993 to less than 600 a year later, then peaked at almost 750 in August 1994 and remained close to 700 during September through November.

Emergency shelter placements peaked at 573 in October 1993, and have fluctuated between 395 and 478 in 1994.

All other AFDC-EA fluctuated between 1800 and 2500 in 1993 and 1994.

JOBS/FDP PARTICIPATION RATES (Table 8, Graph 8)

Statewide participation in the JOBS/FDP Program has had three troughs, in August 1993 at 12.5 percent, December 1993/January 1994 at 16 percent, and again in August 1994 at 16.3 percent. It peaked in October 1993 at 17.8 percent, in May 1994 at 20.1 percent, and reached a new high in October 1994 at 21.8 percent, remaining unchanged in November. Thus a gradual upward shift can be seen in the overall pattern.

Most counties have shown a similar pattern, with a decline in June, July and August 1993, and a rebound through October 1993. Several experienced declines in the Winter months and then continued upward again beginning in March 1994. Most counties declined from May through August 1994, then turned upward in September 1994 and again in October. In November, twelve counties experienced a falling participation rate and nine increased, though several changed only a fraction of a percent.

Essex county's rate has consistently remained under 10 percent, as has Cape May except for three months. In most counties the rates were between 10 and 30 percent. Atlantic, Cumberland, Salem, Somerset, and Sussex generally exceeded 30 percent. Warren exceeded 60 percent from June 1994 through Otober 1994, the highest levels for all counties in the period.

GENERAL ASSISTANCE (Table 9, Graph 9)

For the period January 1993 through June 1994 (the latest available information), the number of GA recipients peaked at about 37,400 in March 1993 and again at 38,100 in March 1994. The number has since declined to 37,000 in June.

During the same period, the number of employable recipients fluctuated between 23,000 and 26,000. There were also peaks in March 1993 (25,900) and March 1994 (26,400). The June 1994 level of 24,800 was about 800 more than a year earlier.

The number of Unemployable GA recipients remained almost unchanged in the period, staying between 11,000 and 11,700. In May 1994, Unemployables grew by almost 600 to 12,200, the highest level in 1993-94, and stayed about the same in June.

CHILD SUPPORT AND PATERNITY (Table 10)

Total collections of the Child Support and Paternity Program grew from about \$438 million to more than \$510 million from FY1993 to FY1994, an increase of 16.6 percent. Total AFDC/Foster Care collections remained almost unchanged at around \$92 million. Non-AFDC collections grew from less than \$346 million to almost \$418 million, or 21 percent.

For the quarter ended September 1994 (1st quarter FY1995), AFDC/Foster Care Collections were down about 3 percent from a year earlier, led by declines in Unemployment Benefits collections and collections from other states. Non-AFDC collections, on the other hand, were up almost 24 percent, or about \$22 million more. Most of that increase was in Income Withholding and Other/Own Behalf. These patterns continued trends exhibited in FY1994 compared to a year earlier.



















AFDC Families Receiving Emergency Assistance January 1993 through November 1994







Explanatory Notes

The Department of Human Services Division of Family Development provides basic income and an opportunity to achieve self-sufficiency for individuals and families served by the Division's programs. The Division provides leadership, direction and supervision to those public agencies responsible for administering those programs and plans for and develops policies to promote self-sufficiency.

AID TO FAMILIES WITH DEPENDENT CHILDREN (AFDC) - Financial assistance for dependent children and their natural or adoptive parents, or certain other relatives recognized as taking the place of a parent.

Regular AFDC (C Segment) - assistance when only one parent is in the home due to death or absence, or both parents are in the home but at least one is incapacitated.

Unemployed Parents (F Segment) - assistance when both parents are in the home, neither is incapacitated and the primary wage earner meets the federally defined criteria for unemployment.

State AFDC (N Segment) - assistance when both parents are in the home, neither is incapacitated, and the primary wage earner does not meet the federal definition of unemployment.

Medicaid Only - families no longer receiving AFDC financial assistance but remaining eligible for Medicaid under applicable provisions which extend coverage beyond period of AFDC assistance.

FOOD STAMP PROGRAM (FS) - Authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refer certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for AFDC (also for General Assistance or Supplemental Security Income, not included here), authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if the eligible individual or family is in an imminent or actual state of homelessness.

JOBS/FDP

JOB OPPORTUNITY AND BASIC SKILLS PROGRAM (JOBS) - Federally mandated work/training program for recipients of AFDC established by the Family Support Act of 1988 under Part F of Title IV of the Social Security Act.

FAMILY DEVELOPMENT PROGRAM (FDP) - Reform legislation enacted by the State Legislature in January 1992 to: build, strengthen, and support the family unit; encourage family formation; reduce the long-term aspects of welfare dependency; look to the needs of the family unit as a whole; emphasize education and training for all family members; maximize use of educational, training and employment resources; and develop genuine private sector job opportunities.

County - Counties currently participating in the Family Development Program are indicated by an "*".
