In addition to the new Tower, Prudential will maintain 160,000 square feet of office space at Three Gateway Center in Newark. Over time, the taxpayers will see a net benefit of \$250 million to the state.

"Completion of the Prudential tower marks a significant milestone," said EDA Chief Executive Officer Melissa Orsen. "We look forward to seeing the impact of this project as new jobs are created and the neighborhood enjoys the ripple effect of being home to a bustling corporate facility."
