If there is an overall theme to the governor's plan, it's to refurbish the Jersey Shore as quickly as possible." - "Rebuilding grants of up to \$150,000 would go to qualified homeowners. ... Grants of that magnitude can be a godsend for homeowners financially struggling more than four months after superstorm Sandy. They also would help many owners elevate their properties to meet new flood standards. That's crucial, because homeowners who don't elevate may face insurance premiums of an estimated \$31,000 a year."
- "Another proposed program offers \$10,000 grants to homeowners who agree to stay in their homes. ... We agree that maintaining a community's 'fabric' is desirable."
- "The administration does propose about \$250 million to help rebuild and redevelop rental housing, with a majority of the money earmarked for low- and moderate-income people. More money may be needed in the future, but this is a reasonable start."

- “No matter how the administration's blueprint turns out, it's going to happen quickly. The goal is to begin implementing it on April 15. ...The thousands impacted by Sandy need assistance as fast as they can get it.”

*The Press of Atlantic City*: “[I]t was good news that Gov. Chris Christie's administration has moved quickly to file a plan for disbursing the first round of federal flood aid - \$1.8 billion in community block grants. In early February, states affected by Sandy were given 90 days to file action plans with the federal government. - “One positive aspect of the plan is that the money will be administered by the state, rather than going to county and municipal governments. With billions of dollars at stake, it is important that a central administration be accountable for how it is spent. (This is New Jersey, after all.)”
- “For those whose lives were turned upside down by Sandy, the fact that New Jersey has filed its plan is one more indication, at least, that help is on the way.”
