Abstract <p>This document provides a summary of work accomplished by the New Jersey Institute of Technology (NJIT) in support of the New Jersey Department of Transportation (NJDOT) efforts to meet the reporting requirements pertaining to the Federal Funding Accountability and Transparency Act (FFATA). This law, passed in 2006, and amended in 2008, requires any person or entity (prime awardee) receiving contract or grant funds directly from the federal government to report certain information regarding those funds through a centralized website, www.frs.gov. The Federal Funding Agreement with the State of New Jersey requires compliance with FFATA rules. The Agreement stipulates that Grantees must ensure that they have the necessary processes and systems in place to comply with the federal reporting requirements of FFATA. NJIT performed a number of activities to achieve a more streamlined and accurate reporting process that centered around rectifying the vendor file information, submitting the reports to the FFATA Subaward Reporting System (FSRS) website, correcting the information and errors in the NJDOT Vendor Files, and modifying the system programming. In performing these activities NJIT focused on determining the degree of compliance between what NJDOT was reporting and what the Federal Government requires, identifying the exact nature and causes of the discrepancies, and establishing corrective protocols to ensure improved compliance in future FFATA submissions.</p>

EXECUTIVE SUMMARY

This document summarizes the work accomplished by the New Jersey Institute of Technology (NJIT) in support of the New Jersey Department of Transportation (NJDOT) efforts to meet the reporting requirements pertaining to the Federal Funding Accountability and Transparency Act (FFATA). This law, passed in 2006, and amended in 2008, requires any person or entity (prime awardee) receiving contract or grant funds directly from the federal government to report certain information regarding those funds through a centralized Sub-award Reporting System (FSRS) website at www.fsrs.gov.

The Federal Funding Agreement with the State of New Jersey requires compliance with the Act's rules. The Agreement stipulates that Grantees must ensure that they have the necessary processes and systems in place to comply with the federal reporting requirements. All entities that receive at least \$25,000 in federal funding through this process are required to review and complete the necessary steps outlined in the agreement.

The purpose of this work was to identify deficiencies in the current system and develop solutions to enhance the effectiveness of NJDOT's reporting process. In order to comply with the Statute, the NJDOT had already put several practices in place, including establishing a FFATA committee, creating goals, defining the needs/requirements, developing the methods needed to address the data element requirements, building a web based application to process these requirements, and completing the initial cycle of reporting. During this process, NJDOT identified certain areas of insufficiencies that needed to be corrected to ensure that they are able to achieve their goals in reporting the federal expenses.

To address these deficiencies, NJIT reviewed the web-based application that is currently being used to report the federal dollars spent. Their review found that there were certain areas where the data needed to be verified and cleansed. During the needs assessment process, NJIT outlined the following main areas where improvement was needed:

- Automate the data gathering and verification process.
- Facilitate the maintenance of vendor files.
- Upload data into the FFATA website and maintain the reporting cycle on behalf of NJDOT.

Next, a number of activities were conducted to achieve a more streamlined and accurate reporting process that centered around cleaning up the vendor file information, submitting the reports to FSRS, correcting the information and errors in the Vendor Files, and modifying the programming in order to pull the required data from the correct data tables within NJDOT's data warehouse.

The achievements of this work focused on determining the degree of compliance between what information was being reported and what the Federal Government requires. As part of that process, NJIT worked on identifying the exact nature and causes of the discrepancies, and established corrective protocols to ensure improved compliance in future FFATA submissions.

BACKGROUND

This section of the report outlines the motivation for initiating a study on the reporting and data quality requirements mandated by the Federal Funding Accountability and Transparency Act (FFATA).

The impetus for the study was the need to provide support to the New Jersey Department of Transportation (NJDOT) in efforts to meet the reporting requirements pertaining to the FFATA legislation. This law, passed in 2006 and amended in 2008, requires any person or entity (prime awardee) receiving contract or grant funds directly from the federal government to report certain information regarding those funds through a centralized Sub-award Reporting System (FSRS) website at www.fsrs.gov.

The Federal Funding Agreement with the State of New Jersey requires compliance with the Act's rules. The Agreement stipulates that Grantees must ensure that they have the necessary processes and systems in place to comply with the federal reporting requirements. All entities that receive at least \$25,000 in federal funding through this process are required to review and complete the necessary steps outlined in the agreement.

Early in the process of adopting FFATA requirements, NJDOT began preparations to conduct periodic data uploads to the FSRS reporting site using established criteria that was captured and entered into an automated process. To advance towards achieving that goal, NJDOT had already conducted the first steps of the process.

During this system development stage, NJDOT identified certain areas where their reporting process was deficient and recognized that they needed help to address these deficiencies. Mainly, this pertained to data quality assurance, including completeness, consistency, and accuracy of data submitted to FSRS as part of the reporting process. It was identified at the time that it would be beneficial for NJDOT to conduct a study of the data available from the existing information management systems and their consistency with the FFATA reporting requirements, as well as to take required data quality assurance actions to ensure compliance with FFATA.

OBJECTIVES

This section defines the specific objectives of the research project.

Prior to the programmatic assistance provided by NJIT as part of this study, NJDOT completed the initial steps for ensuring compliance with the FFATA reporting requirements, including:

- Established a FFATA committee
- Established the goals
- Defined the needs/requirements
- Developed methods required to meet the data element requirements
- Built a web based application to process these requirements
- Completed initial cycle of reporting

As noted earlier, during this process NJDOT identified certain deficiencies in data elements that resulted in inability to submit complete records as required by FFATA. NJIT's role, and a broad objective of this study, was to provide assistance and support to NJDOT with addressing these deficiencies. More specifically, this entailed identifying and resolving the identified deficiencies in data element of the reporting process, so as to ensure timely and complete submission of required information through the Federal website.

While NJDOT's web based application was being used to report the federal dollars spent, the NJIT team found there were certain areas where the data needed to be validated and cleansed to comply (i.e. ensure consistency) with the FFATA reporting formats. To achieve this, the scope of the study was developed around the following objectives:

- Automate the data gathering and verification process.
- Facilitate the maintenance of vendor files.
- Upload data into the FFATA site and maintain the reporting cycle on behalf of NJDOT.

INTRODUCTION

This section of the report introduces the approach applied in this project to address previously defined project objectives.

In the early stage of the project the research team conducted a detailed review of FFATA reporting requirements, focusing on format and content of the data records included in the required data fields for online submission. This provided a basis for review of data that NJDOT was submitting through the FSRS, necessary data corrections, and refinement of the web-based software tool developed by NJDOT to facilitate online submission of data records to the FSRS website.

Submitted data was reviewed in several instances, before and after submission attempts. The research team looked for inaccuracies and inconsistencies in data records that could not be successfully submitted (uploaded) into the federal reporting system. Once these inconsistencies were identified, the data was scrubbed by correcting (or removing) corrupt or inaccurate information. The project team documented data cleansing actions, assisted NJDOT with refining the software code for the online data submission, and provided recommendations to ensure efficient submission of required data under the FFATA mandate.

SUMMARY OF THE LITERATURE REVIEW

Background of the FFATA Legislation

This section summarizes the review of the agency reporting requirements stemming from the FFATA legislation. The FFATA was enacted into law in 2006, and it requires information about Federal awards to be made available via a searchable website that is open for public access. By increasing transparency and improving access to Federal Government spending information, the guiding idea for the Act is that the public should be informed about the accountability of the Federal awards process. The Act states that “*Federal agencies must continue efforts to increase the availability of public information related to Federal spending and [must continue] to improve the data quality of information so reported*”.

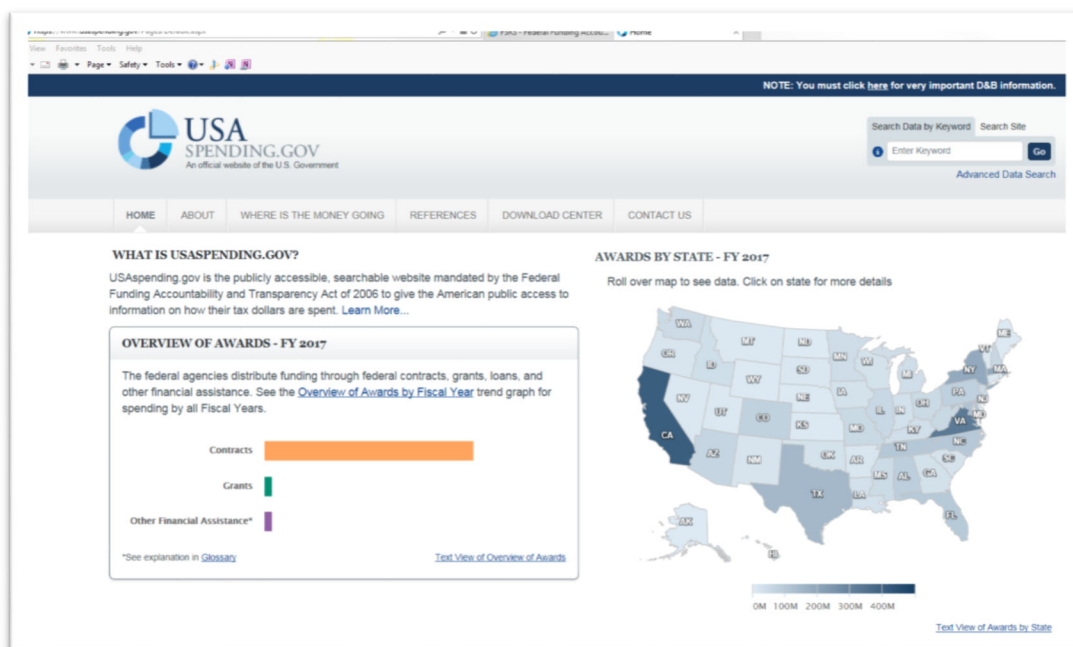


Figure 1. USASpending.gov Federal Awards site

The FFATA legislation requires that information on federal awards (federal financial assistance and expenditures) be made available to the public via a single, searchable website located at [http:// www.USASpending.gov](http://www.USASpending.gov). An example of the website log-in page is shown in Figure 1.

The objective of the FFATA legislation is to empower every American with the ability to hold the government accountable for each spending decision involving federal funding. The intended outcome of the law is to reduce wasteful spending in the government and to make the entirety of the funding process more transparent.

This website contains information on all Federal spending awards. The operation and support of the USASpending.gov site was originally overseen by the Office of Management and Budget (OMB) and the Department of Treasury. However, since February 2014, the Bureau of the Fiscal Service is administering this responsibility on behalf of the Treasury.

At the time, the impact of data collection requirements was limited to the collection and reporting of information about first tier sub-recipients under federal assistance awards and first-tier sub-recipients and vendors under federal contracts. Although the law is vague on the applicability of these stipulations to further tiers, the Office of Management and Budget (OMB) may require the reporting on second-tier awards in the future.

To achieve the goal of a responsive reporting process that is adaptable to future reporting changes and to ensure NJDOT's compliance with regulatory requirements, the NJIT project team was tasked with assisting in the evaluation and improvement of the reporting mechanisms used by the NJDOT. Beginning with an overview of the current reporting requirements, the team found that FFATA currently requires Departments and Agencies to provide:

- Information disclosure of entities receiving Federal funding through Federal awards such as Federal contracts and their sub-contracts and Federal grants and their sub-grants.
- Disclosure of executive compensation for certain entities.
- Establishment of a publicly available, searchable website that contains information about each Federal award.
- Agencies to comply with OMB guidance and instructions and assist OMB in implementation of website.

What constitutes a first-tier Sub-award?

A sub-award is an award presented to a sub-recipient by the prime recipient, or an award made by a recipient at one tier to a sub-recipient at the next lower tier, for the purpose of supporting the performance of any portion of the substantive project/program for which a grant was awarded.

The FFATA Reporting Requirements

Before beginning the registration process, the recipient must have a valid DUNS number and must be registered in the Central Contractor Registry (CCR) and must agree to renew their CCR registration annually. Award recipients can go to <http://www.ccr.gov>, as shown in Figure 2, to register their organization, renew their registration, or check on their registration status.

The rules governing the Transparency Act Reporting Requirements include the following guidance as it applies to the Awardee:

- Prime contract awardees of Federal contracts of \$25,000 or more must report associated contract first-tier sub-contracts of \$25,000 or more.

- Data collection will be phased with all required first-tier sub-contracts reporting by March 2011.
- Prime grant awardees of Federal grants of \$25,000 or more must report associated first-tier sub-grants of \$25,000 or more.
 - Applies to new Federal, non-Recovery Act funded grant awards and cooperative agreements with an award date on or after October 1, 2010, and resulting first-tier sub-awards.
 - The new reporting requirements do not apply to modifications to existing awards that were authorized prior to October 1, 2010.
 - Grants funded by the American Recovery and Reinvestment Act (ARRA) are not subject to these new reporting requirements.
- A sub-award generally means a monetary award made as a result of an award to a grant recipient or contractor to a sub-recipient or sub-contractor, respectively.
 - Sub-award Information Required for Reporting:
 - Name of entity receiving award
 - Amount of award (obligated amount)
 - Funding agency
 - NAICS code for contracts / CFDA program number for grants
 - Program source
 - Award title descriptive of the purpose of the funding action
 - Location of the entity (including congressional district)
 - Place of performance (including congressional district)
 - Unique identifier of the entity and its parent; and
 - Total compensation and names of top five executives (prime or sub awardee)
- Prime grant recipients must report the names and total compensation of the five most highly compensated officers associated with sub award recipient entities if all of the following hold true:
 - the entity in the preceding fiscal year received 80 percent or more of its annual gross revenues from Federal awards;
 - the entity received \$25 million or more in annual gross revenues from Federal awards; and,
 - the public does not have access to executive compensation data via periodic reports filed by the entity in compliance with SEC and IRS requirements.

To sum up, the prime grant award-recipient must report all relevant data associated with a Federal grant, including executive compensation data for the prime recipient or sub-awardees, or any other information that is connected with sub awards. The sub-awardee has a specific duty to give the prime grant awardee all necessary data for reporting. This includes the second tier awardee entity information, DUNS number, and any relevant executive compensation records (when applicable).

Please note that Sub-awardees are not required to report data directly to FFATA, and prime recipients are not permitted to delegate reporting duties to their sub-recipients. All prime awardees must upload the required sub-awardee information report *by the end of the next month immediately following the month* in which the sub-award or obligation was made.

SUMMARY OF WORK PERFORMED

Summary of Activities

All of the tasks described in the original scope of work were accomplished. The work plan for streamlining and improving the FFATA reporting process called for the research team to work with NJDOT IT personnel to update and verify vendor information data. The NJIT team worked closely with NJDOT staff on-site for a number of days each month and provided off-site assistance during the entire process of data collection, although this process was occasionally slowed due to personnel scheduling issues. NJIT also assisted NJDOT in verifying and processing the data in preparation for submitting the material to the FSRS reporting website.

Among the specific data fields reviewed in this work were the Vendors DUNS numbers, addresses, and other relevant details. A DUNS number (from Dun & Bradstreet) is a unique nine-digit identification number for each Vendor's physical location of their business. DUNS Numbers are required before a registered Vendor can bid on a government proposal.

During this process, NJIT continued striving to identify various ways to automate the data gathering and cleansing system. In the early stages of the work NJIT research team assisted with locating, modifying, and correcting missing vendor files data needed for the data verification process. These efforts led to a significant amount of previously missing data being discovered and added to update the database. Next, the team looked at the reasons why previous uploads of data to the FSRS website were rejected and found that formatting and content inconsistencies were interfering with the data upload process.

Problems Encountered

As an example of the various types of issues that were encountered, the NJIT and NJDOT teams discovered that between 2013 and 2014, some of the import requirements changed on the FFATA site. These changes were found to be significant because they subsequently contributed to NJDOT data upload failures.

For example, one such item of conflict was discovered to be the "legislative code" data entry item, which was absent in the 2013 requirements but is present in the 2014 requirements. Therefore, when the 2014 uploads were first attempted, they failed due to this mismatch.

The reason for the failure was because one specific item (the "legislative code" data entry item) was not being provided, so the 2014 version of the FFATA data collection system viewed that blank item as an incomplete entry. Another important area of discrepancy about the reporting requirements was uncovered when examining the information found in the NJDOT data warehouse.

In that case, the current NJDOT Financial Management Information System (FMIS) numbers had actually already met the FFATA requirements; however, the team discovered that the Federal Government needed to have the information broken down even further into categories of reported dollars per job by Construction, Consulting and In-House costs.

Another significant incongruity that was identified concerned compensation for vendors who hold over 80% of business income from Federal contracts. Although NJDOT already had a process in place to require the vendors to provide relevant information, a meeting with the NJDOT Assistant Commissioner (David Kuhn) led to a process improvement adjustment, where NJDOT added a FFATA Certification page to the current process to ensure vendor conformity and transparency.

CONCLUSIONS AND RECOMMENDATIONS

Conclusions

This report gives a comprehensive overview of how NJIT staff assisted NJDOT IT personnel with streamlining their current practices in meeting the FFATA reporting requirements, and also includes a discussion of the design, findings, and challenges of the web-based application that NJDOT is currently using for this purpose. Through a series of interactive data-sharing and on-site performance analysis reviews, the NJIT team assisted NJDOT staff with conducting a need-gap analysis of the existing FFATA reporting system to determine whether business requirements were being met.

Overall, several factors were made clear as a result of the extensive collaboration and investigation of the two teams' examination of the existing reporting process. As a result of the new information discovered by the team, the work accomplishments centered on upgrading the existing system currently being used for uploading data. The refinements to the existing data collection system began with a series of action steps that were conducted during this process, where the team performed the following improvements:

1. Cleaned up the vendor file information, which is expected to significantly improve the FFATA reporting counts to the government.
2. Performed a successful upload of the 2013 data.
3. Researched and updated the data for the year 2014. During this phase of the work, other causes for data rejection were investigated to ascertain the exact nature and causes of the discrepancies noted earlier in this summary.
4. Devised a strategy to compensate for data entry incompatibilities, such as the "legislative code" data point mentioned previously.
5. Developed a methodology for determining the degree of compliance between what NJDOT was reporting and what the Federal Government requires.
6. Achieved a better understanding of the causes of upload failures, which led to designing an improved reporting process.
7. Finally, the NJIT-assisted NJDOT teams in developing corrective protocols to ensure improved compliance in future FFATA submissions.

NJIT provided support for NJDOT's efforts to meet the reporting requirements pertaining to the Federal Funding Accountability and Transparency Act by helping staff focus on modifying and uploading all existing data. During meetings with NJDOT Information Technology Office and other relevant personnel, they also suggested and helped devise a method to automate the process for the uploading of vendor data.

Recommendations

To encourage operational efficiency and maintain on-going progress in the FFATA reporting process, the NJIT team recommends that NJDOT IT and other appropriate personnel consider the following recommended actions to ensure future compliance with Federal requirements:

- Continue conducting oversight of the FFATA reporting mechanisms and practices.
- Continue to monitor automated activities of the reporting systems.
- Continue to develop solutions to any future Federal reporting changes as they occur.
- Continue to maintain a regular schedule of accountability for uploading the backlogged vendor data, and
- Continue to apply standard QC methodology to ensure compliance.

This process may include adopting a process for assigning staff to track all activities and modifications made to the documentation and website, via either a log sheet or a built-in electronic feature in the database used for FFATA reporting, as illustrated in the example shown in Table 1.
