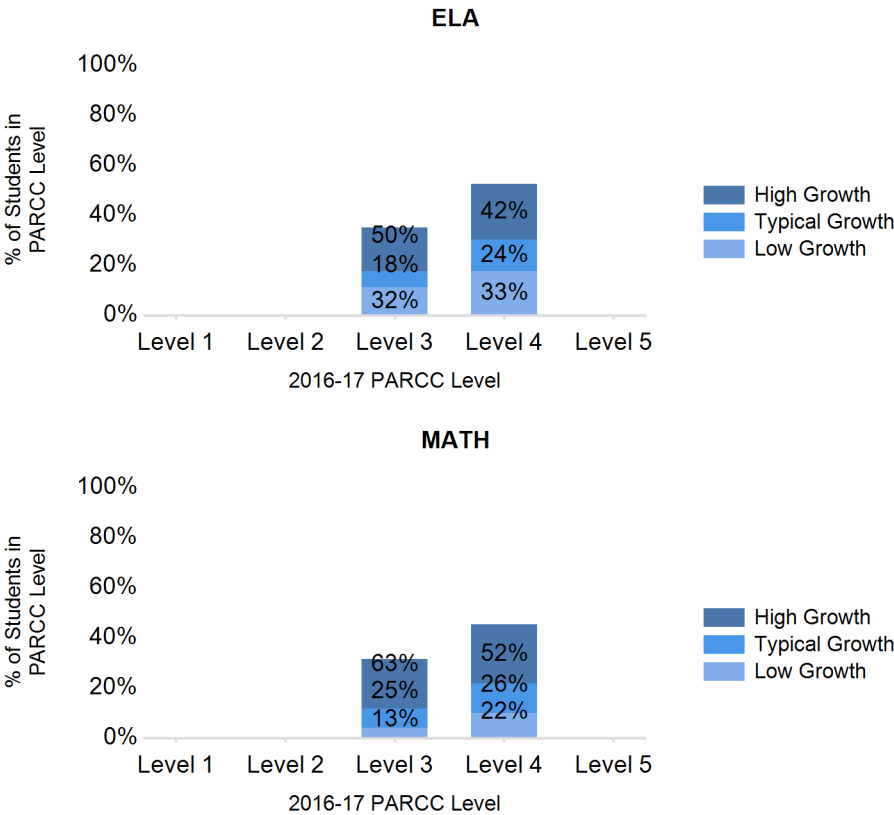

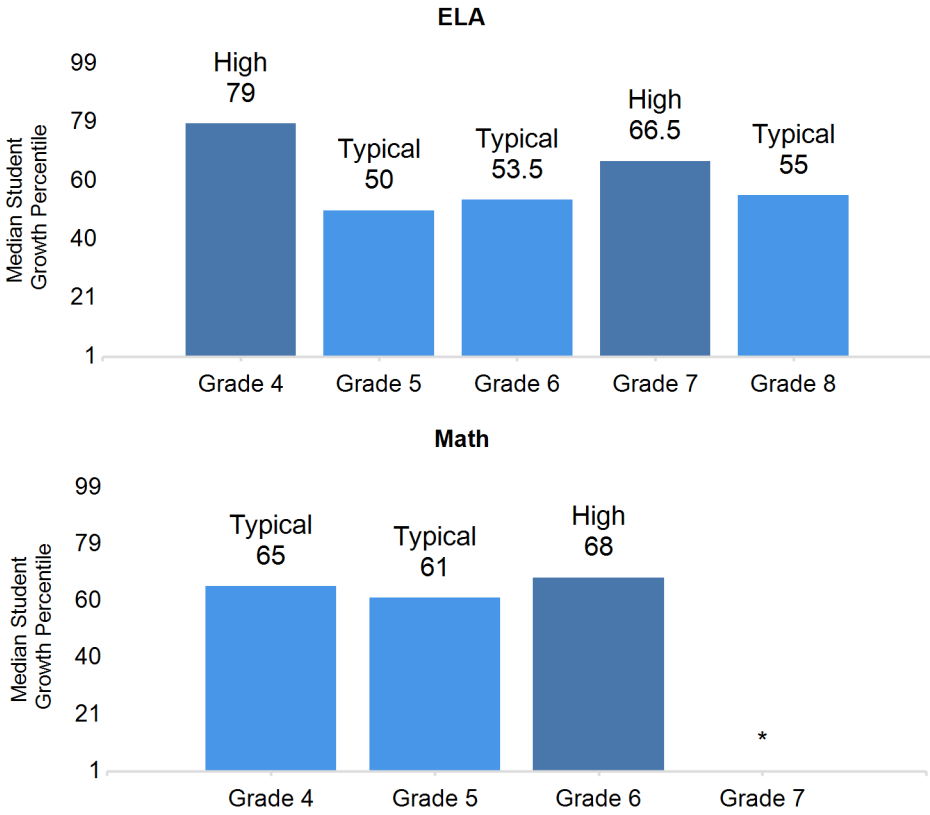
Student Growth by Performance Level

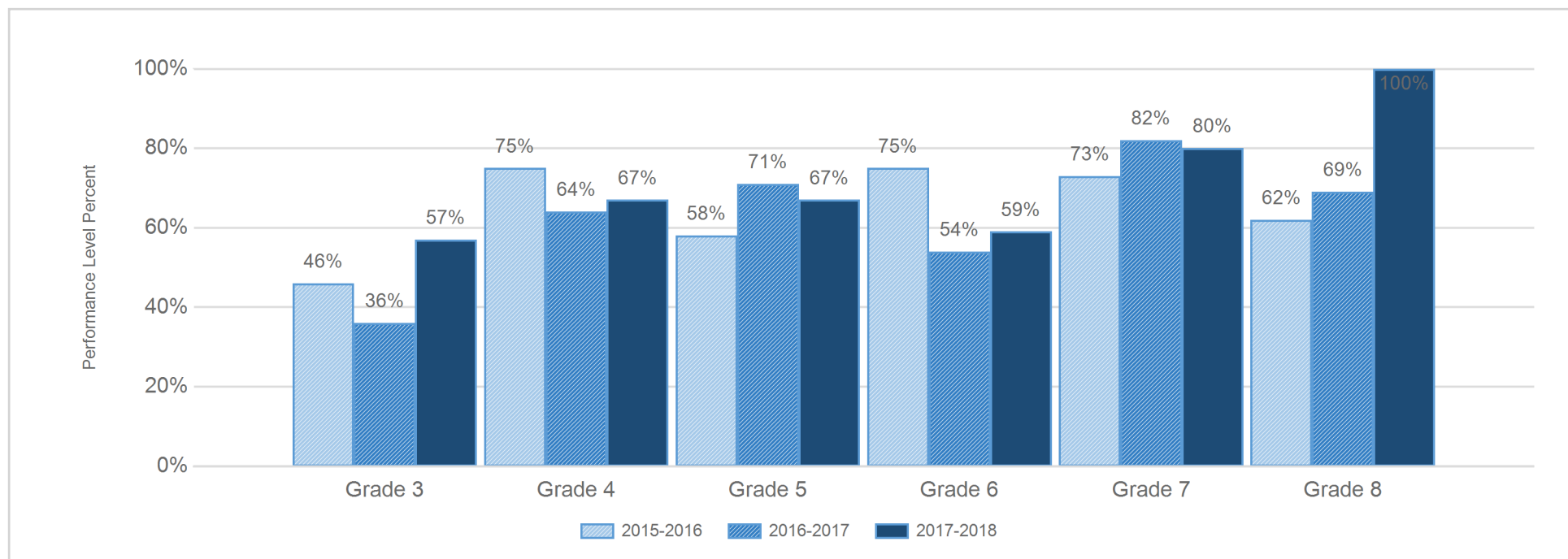

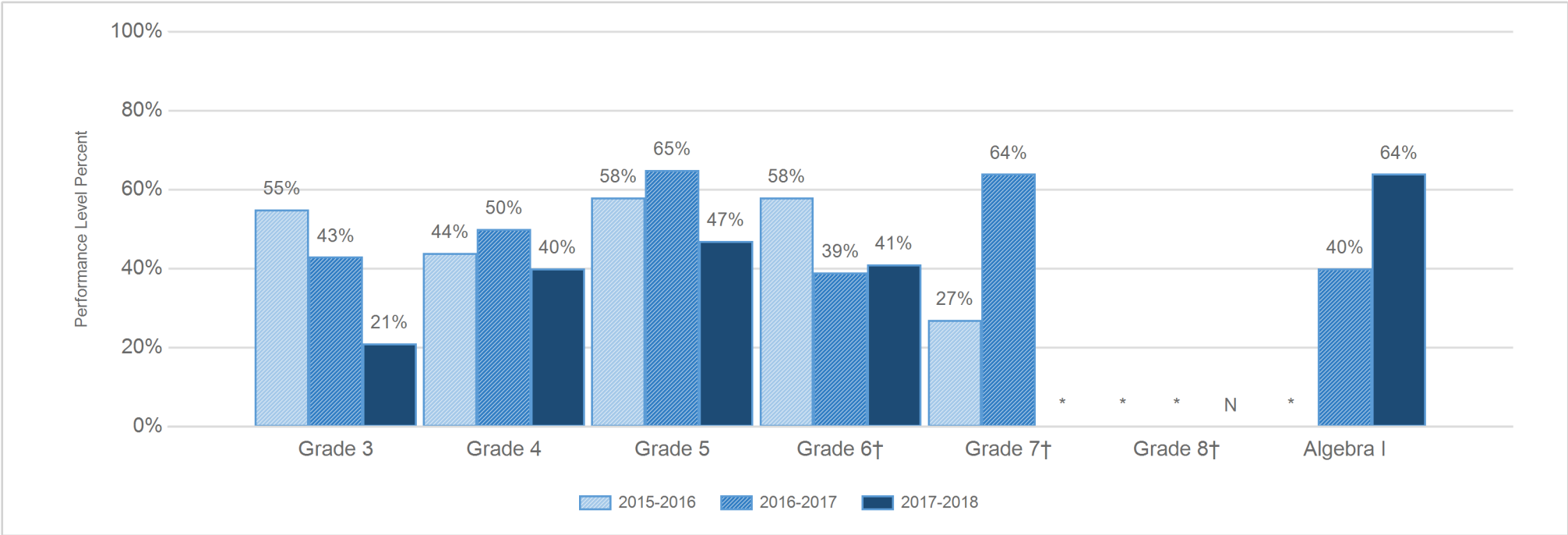

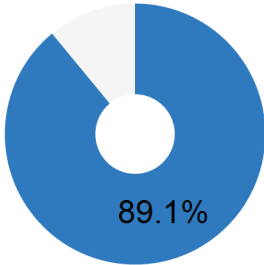

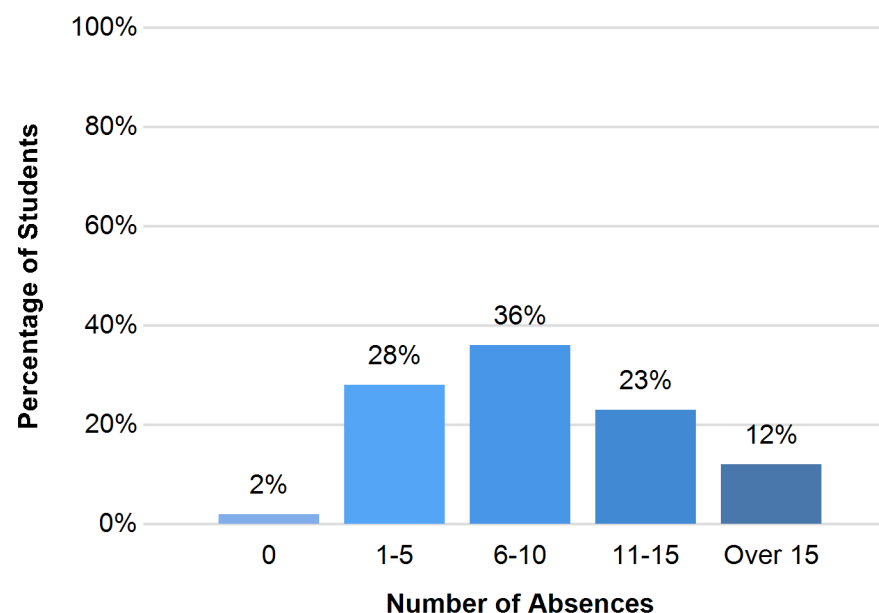

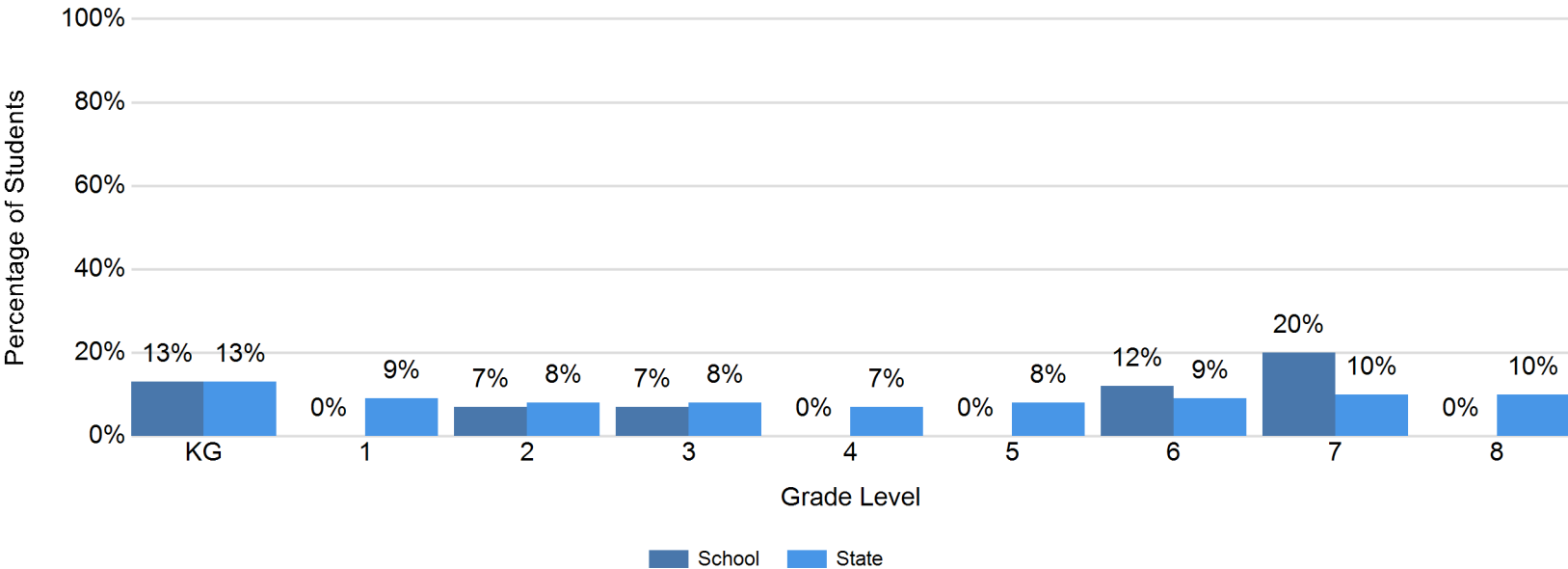

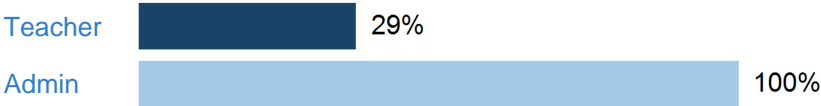

Facilities:

In support of its ecological mission, RVCS is located on 18 acres in Frelinghuysen Township. Repurposed modular classroom buildings are retrofitted with full spectrum daylight lighting, natural flooring, UV-filtered well water, and low VOC paint. A solar array installed in 2005 provides energy, while a rain garden and rain barrels manage storm water and irrigation needs for the organic garden and orchard. Multiple outdoor learning spaces offer students opportunity for experimentation and reflection.
